Chair Nakashima and Members of the Committee:

The Department of the Attorney General provides the following comments on this bill.

This bill amends chapter 91, Hawaii Revised Statutes (HRS), to create an expedited agency hearing process, which agencies may use in administrative proceedings that involve any criminal activity that threatens the public health and safety of the community or is drug-related.

This bill appears to create a separate type of hearing from what is already established in chapter 91 – the contested case hearing. The bill is unclear as to how the expedited agency hearing works within the established contested case framework. The bill appears to provide agencies with the ability to expedite matters that would typically proceed through a contested case hearing. If this is the intent, this bill should be amended to provide how and to what extent the existing statutes relating to contested case hearings apply (*see* sections 91-8.5 through 91-14, regarding ability to mediate; form and manner of notice and hearing; manner of service; presentation of evidence; and judicial review).

Aloha Chair Nakashima, Vice Chair Matayoshi, and members of the Committee:

The Department of Hawaiian Home Lands (DHHL) strongly supports this bill that provides for an expedited agency hearing for any criminal activity that threatens the health and safety of the community or any drug-related criminal activity. This bill was approved by the Hawaiian Homes Commission (HHC) and included in the Governor's administrative package by request of our department.

The Hawaiian Homes Commission has expressed concerns regarding ongoing criminal activity that is threatening the health and safety of the community and the slow pace of addressing these concerns through the existing process allowed for under Chapter 91. This bill was modeled after the Hawaii Public Housing Authority's Administrative Rules for Expedited Grievance Procedures or Federal Public Housing to allow for a prompt response through an expedited agency hearing.
