Chair Tarnas and Members of the Committee:

Good morning Chair Tarnas and members of the Committee. My name is Charlotte Carter-Yamauchi, and I am the Director of the Legislative Reference Bureau. Thank you for providing the opportunity to submit written **comments** on H.C.R. 102, Requesting the Legislative Reference Bureau, in Collaboration with the Department of Land and Natural Resources and University of Hawaii, to Develop a Plan to Establish a State Geological Survey in Hawaii.

The purpose of this measure is to request the Legislative Reference Bureau to develop a plan to establish a state geological survey in Hawaii. The plan is requested to include:

- (1) Proposed scopes of work for the state geologic survey, including proposed ways to consolidate existing functions into a state geological survey;
- (2) Proposed organizational structures of the state geological survey, including advantages and disadvantages of each proposed structure;

- (3) Proposed staff positions that would be needed for the state geological survey, including salary levels;
- (4) Proposed sources for funding or other necessary resources; and
- (5) Enabling legislation to create the state geological survey.

The measure further requests the Bureau to consult with the United States Geological Survey, state Office of Planning, and any other organization or person deemed appropriate. The Bureau is requested to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the convening of the Regular Session of 2022.

The Bureau takes no position on this measure but submits the following comments for your consideration.

With regard to the plan requested of the Bureau, we note that the Bureau has no specific expertise regarding geological surveying, hazard mitigation, or resource management.

The Bureau understands that the Office of Planning is intending to offer a friendly amendment to substitute the Office of Planning, rather than the Bureau, to conduct the planning activities requested by this resolution. Because the Office of Planning currently administers the Hawaii State Geographic Information Systems (GIS) Program and various land use planning activities, it already possesses the information, data, and expertise required to create the plan requested by this measure. Accordingly, the Bureau supports the adoption of the Office of Planning's proposed amendments.

If the proposed amendments from the Office of Planning are adopted and the Committee desires to keep the Bureau involved, the Bureau would respectfully request that the measure be further amended to have the Bureau assist with only the drafting of any proposed legislation that may be required to implement the Office of Planning's findings and recommendations. Further, we would ask that the Office of Planning submit to the Bureau by December 1, 2021, any draft documents for the proposed legislation to allow us adequate time to prepare bill drafts. The Bureau believes that such alternative assistance would be manageable, provided that the Bureau's interim workload is not adversely impacted by too many additional responsibilities, such as conducting studies, writing or finalizing other reports, drafting legislation, or any combination of these for the Legislature or for other state agencies, task forces, or working groups that may be requested or required under other legislative measures.

Aloha Chair Tarnas, Vice Chair Branco, and Members of the Committee on Water & Land:

The Office of Planning (OP) <u>supports</u> the intent and offers <u>proposed amendments</u> for HCR 102 / HR 85 and recognizes the importance of establishing a state geological survey in Hawai'i to unify the State's mapping capability, make Hawai'i eligible to compete for applicable federal funds, and provide a broader range of geological information for the public and state decision-makers to use in mitigation and management planning.

The Office of Planning has coordinated with the Legislative Reference Bureau, and offers the <u>friendly amendment</u> for the Office of Planning to conduct the study requested by this resolution instead of the Legislative Reference Bureau.

The Office of Planning recommends:

- 1. Replacing all references to the "Legislative Reference Bureau" with the "Office of Planning" (in the title of the resolution; page 3, lines 29-30, and 34-35; page 4, lines 14-15, 17, and 19-20); and on page 4, line 16, strikeout "state Office of Planning,"
- 2. Adding language to enable the coordination with the:
 - Hawai'i Emergency Management Agency,
 - Department of Transportation, and
 - County planning departments and emergency management agencies.
- **3.** Changing the due date of the report to "twenty days prior to the convening of the Regular Session of 2023" to allow for a thorough study and evaluation.

Chair Tarnas, Vice Chair Branco, and members of the Committee:

HCR 102/HR 85 requests that the Legislative Reference Bureau, in collaboration with the Department of Land and Natural Resources and the University of Hawai'i, develop a plan to establish a state geological survey in Hawai'i.

The School of Ocean and Earth Science and Technology, University of Hawai'i at Mānoa, enthusiastically supports the plan to establish a geological survey in the State of Hawai'i (the only State in the nation without one) and would be a willing partner in such a planning effort.

As noted in these resolutions, a sustainable future for the state will rely on mapping, and an accounting of the resources we have within our borders, including energy resources, water resources and our coastal resources.

Hawai'i will also face growing challenges related to climate change, including increased exposure to tropical cyclones, coastline erosion and landslides, flooding and drought, sea-level rise and heating of the air and ocean, and other impacts.

SOEST faculty, staff, and students are actively conducting federally-funded research into all of the aforementioned topics (as well as volcanic, earthquake, and tsunami hazards), and will be happy to provide advice and assistance that may be required.
