Dear Chairs Woodson and Tarnas, Vice Chairs Kapela and Branco, and committee members,

On behalf of Hawai'i Children's Action Network Speaks!, I am writing in SUPPORT of HCR 10 / HR 11. These resolutions urge the Board of Education and Department of Education to support and implement afterschool programs to combat COVID-19 learning loss.

With recent data showing Hawai'i's public school students suffering more learning loss during the pandemic than in previous school years,¹ it is crucial that our state do all it can to help our keiki catch up academically. One key way to do that is to make sure that afterschool programs are implemented and supported.

In fact, Hawai'i's students were the most prone to academic risks in the nation during the spring of 2020, according to an *Education Week* analysis,² with the largest disparity in weekly teacher interactions between more-educated and less-educated households. While the gap for the nation was about 8 percentage points, Hawai'i's gap was the largest in the nation, at nearly 54 percentage points.

Such wide gaps make afterschool programs even more important for our keiki. Experts project that it will take years for school systems to make up for pandemic learning loss. These resolutions would encourage important efforts to help our students catch up.

Dear Chairs Woodson and Tarnas, Vice Chairs Kapela and Branco, and Members of the Committee,

This testimony is submitted **in support for HCR10/HC11**, urging the BOE and DOE to support and implement afterschool programs to combat COVID-19 learning loss.

The data from the DOE Dashboard shows that learning loss among our students, particularly our high-needs students, is significant.¹ Students who are experiencing learning loss consist of students who are receiving a failing grade in English Language Arts (ELA) or math; students in elementary and middle school who are behind grade level; students in high school who are not on track to graduate; and students who are chronically absent. There are over 25,000 students who are receiving a failing grade in math and ELA, and over 20,000 and 19,000 elementary and middle school students, respectively, who are behind grade level in ELA and math. There are over 8,500 high school students who are not on track to graduate. There are over 27,000 of our high-needs students who are chronically absent.

Afterschool programs can help address students with learning loss but only if such programs are aligned and coordinated with a school's academic plan. We believe that a school should identify its students who are experiencing learning loss and design an afterschool program appropriate for them. There are many community organizations that provide afterschool services with whom the schools could partner. We recommend that the BOE and the DOE enrourage coordination and collaboration between the schools and community organizations so that resources can be utilized effectively.

Thank you for the opportunity to testify. Our support represents a 75% consensus or more of our voting membership.

Now is the time to invest in afterschool and summer learning programs as they will need additional staff and professional development, as well as more space and the ability to run full-day programming to most effectively support working parents and school districts' revised schedules. Decades of research show that afterschool programs inspire students to learn, help them do better in school, and prepare them for college and career

During these unparalleled times, OST programs have once again proven to be incredibly valuable to communities nationwide. We need to remember that learning does not just happen during school hours—afterschool programs can provide a safe space with added support and resources needed for all children to thrive in this new virtual learning world, as well as help parents return to work knowing that their children are being cared for.

Schools will directly benefit from the knowledge and experiences that afterschool and summer providers have gained while operating in the midst of the pandemic.

It's no secret that the COVID-19 pandemic is taking a disproportionate toll on the education of low-income students and people of color. Stories abound on the situation, especially when it comes to <u>remote instruction</u> and plans for <u>school re-opening</u>. But even after the school day ends, the disparities persist.

<u>New data</u> from advocates in the after-school sector are illustrating the impact COVID-19 is having beyond the schoolhouse doors: Low-income students are far less likely to have access to after-school programs in person, compared with children and youths from higher-income families.

This data comes as huge questions persist about the pandemic's impact on after-school programs nationwide, which collectively serve millions of children and youths every year. Many providers are worried whether they can stay afloat financially.

I support this bill's intent to provide opportunities for students that have experienced learning loss during the COVID-19 pandemic for all students with indications of struggling to maintain grade level learning.

I offer comments and considerations for afterschool programs.

Current after school programs, both Kamaaina Kids and the YMCA are unaffordable. These may not be the structure to use to bring our students back to grade level.

Again, there must be a clear purpose and design for afterschool programs designed to decrease learning loss.

Funding earmarked for "tutors" during the summer months, needs to be funneled into these after school programs. However, afterschool isn't the only time to recover learning. Intervention during school hours is also a strategy to help our students get back on track.

Unfortunately, by the time this bill is passed, there will be one month of school left. Afterschool programs will be of no benefit for one month. These types of interventions will be obsolete by the time they are available.

Opportunities for this type of intervention could be the use of summer learning time. Afterschool programs will create opportunities during those out-of-school hours for all kids. Many students have suffered from the isolation and trauma that the epidemic caused due to school closures. Afterschool programs can support any child that needs to re-develop social and emotional skills.

The Board of Education and Department of Education are urged to support and implement afterschool programs as a strategy to combat COVID-19 learning loss regardless of economic hardships. Many families have moms and dads who lost their jobs and are struggling with "just unemployment funds." They may not have been economically disadvantaged before the pandemic, but now they are.
