The Office of Planning (OP) supports HCR 126 / HR 103, which calls upon the Hawai'i Interagency Council for Transit-Oriented Development (TOD Council) to establish a State TOD Investments Task Force to determine priorities for funding and timing of needed TOD infrastructure investments for the three O'ahu State TOD priority areas, and to develop a financing plan, incorporating value capture and cost recovery mechanisms to help offset the cost of State investment in priority TOD infrastructure projects.

OP is one of the co-chairs of the TOD Council. We believe this measure complements the TOD Council's role as a forum for advising and supporting implementation of State TOD and securing the necessary resources for the development of TOD communities anchored by State and other public assets. As noted in the resolutions, the Task Force would identify the means to implement delivery of critical regional infrastructure preliminarily identified in the State TOD Planning and Implementation Study for O'ahu completed in 2020.

OP notes the Task Force's work will require the kind of resources being contemplated in other legislative proposals to ensure the availability of the technical expertise that will be needed to identify and craft an effective and collaborative implementation strategy for these infrastructure investments.

House Concurrent Resolution 126 and House Resolution 103 propose to request the Hawaii Interagency Council for Transit Oriented Development (TOD Council) to establish a State TOD investments task force to prioritize near term infrastructure projects for funding within priority TOD areas. The Department of Land and Natural Resources (Department) supports these resolutions.

The Department is a member of the TOD Council and has four parcels adjacent or in close proximity to the planned Keone'ae rail station in East Kapolei across from the University of Hawaii West Oahu (UHWO), and located in one of the priority areas in the TOD strategic plan. The Department's long-term objective is to lease the parcels for income generating purposes to support the Department's natural resource management and protection programs. The Department's planned uses for the parcels include transit oriented mixed uses such as commercial, retail, hotel, medical and 1,000 planned affordable rental housing units. Additionally, the Department intends to include light industrial uses for parcels located further away from the rail station.

In addition to generating income to support its programs, the Department believes that the proposed project will be a critical economic, employment and residential component of the East Kapolei community. The Board of Land and Natural Resources approved the draft strategic development plan that included those proposed uses at its meeting on October 23, 2020. The Department is currently in the process of procuring consultant services to develop an
