I have lived on the corner of E. Manoa and Oahu Ave. for the last 16 years. Over the course of these 16 years, the flooding in this intersection has become progressively worse. Though it had always been prone to flooding, when there is a heavy downpour, the entire intersection floods so badly that the water level is too high for pedestrians to cross the street or even walk on the grass in frot of my house. I have seen people remove their shoes and roll up their pants when absolutely necessary to cross...but I have also seen older citizens totally unable to cross in any direction. The water level can be so high that cars driving through the intersection have water that reaches up to the middle of their tires. As cars drive by my house, a wake pushes leaves and debris all the way up to my garage, leaving a mass of debris behind once the waters subside. Water often comes up off the street, covers the grass "sidewalk" and goes under the hedge and up to my garage wall on the Oahu Ave. side of the house. My neighbor's concrete wall has water marks that show just how high the water can get. For years, the neighborhood has tried to do what we can to help the problem, thinking that this will be taken care, improved in some way, but it stays the same. In time, I imagine things will only get worse and properties would risk flooding every time it rains hard...and mind you, in Manoa, this is a common occurance. It only takes a few minutes of downpour for the intersection to flood. Please do not think this is an exaggeration...ask anyone who lives in this intersection and they will tell you the same thing. Neighbors are buying inflatable devises to block the water from coming into their garages, carting their trash cans to higher ground to keep them from being knocked over, and all of us worry that some day our homes will be harmed by the increased flooding.

My name is Bruce Lum and I applaud Representative Dale Kobayashi for having the backs of the Manoa residents who have suffered and tolerated the very chronic flooding of the intersection of Oahu Ave. and Manoa Rd. for decades. This chronic problem has been further exacerbated since Manoa Valley has transitioned from a mixed-agresidential zoned community of the early 1950's to the dense residential-commercial community of today.

As a child, I used to walk across a wooden plank over the Manoa Stream at Kahaloa Drive when the original Manoa School site moved to the present day site. At that time, even during the heaviest rains, flooding at Kahaloa and the Manoa Stream was nothing as threatening as it is today. The small drainage channels surrounding the present Manoa School and Manoa District Park were well maintained and assisted greatly in the abatement of upper Manoa Valley flooding. Some of those drainage channels are filled in and some are over-grown. The elimination of those channels is part of the reason for the disrupted, deficient means to abate the flooding occurring today at the subject intersection of HCR 147.

When I was a child, my family moved into Manoa in 1961. I live in the original house in the back of Manoa Valley that I inherited from my parents.
