House Concurrent Resolution 186/House Resolution 155, urges state law enforcement entities, including the Department of the Attorney General, Sheriff Division of the Department of Public Safety, and the Harbors Division of the Department of Transportation to collaborate with the Division of Conservation and Resources Enforcement of the Department of Land and Natural Resources in this time of need. The Department of Land and Natural Resources (Department) offers comments on these measures.

The Department's Division of Conservation and Resources Enforcement (DOCARE) along with the other state law enforcement agencies (Sheriffs, AG Investigators, Harbor Police) already coordinate our activities, and when necessary, collaborate and work in a joint manner. There is an informal organization called the State Law Enforcement Coalition that meets regularly, and is the mechanism for which the State law enforcement agencies discuss issues, concerns, and plan operations.

The Department recognizes the many law enforcement related problems identified in the Resolutions, and the call for other agencies to assist DOCARE with these problems. Many of the problems described are longstanding, and have complications which make resolution difficult. While increased law enforcement assistance to DOCARE by other state law enforcement partners may temporarily resolve some of the problems, long term solutions will require more

than increased assistance. Long term solutions must include high levels of community understanding of rules, laws and regulations, as well as compliance.

We recognize the other state law enforcement partners, like DOCARE, have their own priorities and limitations on resources. For example, with the on-going COVID-19 pandemic, the Department of the Attorney General's enforcement of emergency rules and orders relating to quarantine and the State's safe travel program is essential to ensure public health and safety. Further, the security of COVID-19 vaccine Points of Distribution and of commercial ports continues to be a high priority for the State Sheriff Division and of the Department of Transportation's Harbor Police.

The Department will continue to address law enforcement problems and collaborate with our State law enforcement partners to the best of our ability, with the resources that are available.
