Aloha Chair Johanson, Vice Chair Kitagawa, and Members,

I write in strong support of HCR187/HR156 "Requesting the counties to develop an option to allow residents to remit motor vehicle registration taxes and fees on a pro-rated biannual basis."

There is something fundamentally grievous with the fact that people who are unable to pay for their car registration get hit with tickets as they drive to work. They need to go to work to be able to afford to pay for their car registration and feed their family. After they get a ticket, they now have to work harder to get their registration AND the ticket paid off. If they can't do that, they rack up tickets. The courts have mandatory penalties, increasing fines, and even throwing people into jail or volunteer work. But the volunteer work pay-off rate (hours worked toward paying off the fine) is way below minimum wage.

So these individuals now are pulled from their jobs, their families suffer with the loss of income, they have a criminal record, and still don't have enough to pay off their registration.

It's a sick cycle that's jamming up our court system, according to the State Judiciary.

Please, for the benefit of our local families, pass this resolution, which by all means should be a bill with force of law.
