Chair Hashem and Members of the Committee:

Good morning Chair Hashem and members of the Committee, my name is Charlotte Carter-Yamauchi, and I am the Director of the Legislative Reference Bureau. Thank you for providing the opportunity to submit written **comments** on H.C.R. 188, Requesting the Legislative Reference Bureau, in Consultation with the Department of Agriculture, Department of Taxation, and Hawaii Emergency Management Agency, to Conduct a Study to Recommend to the Legislature How to Support Greater Local Production of Food.

The purpose of this measure is to request the Legislative Reference Bureau to conduct a study to recommend to the Legislature how to support greater local production of food, in consultation with Department of Agriculture, Department of Taxation, and Hawaii Emergency Management Agency. The study is requested to include an examination of how:

- (1) General excise tax exemptions could support greater local production of food;
- (2) Greater local production of food could help diversify Hawaii's economy; and

 - (3) Greater local production of food could help ensure that Hawaii's population continues to have access to food if the State's harbors are ever rendered inaccessible due to a natural- or human-caused disaster.

The measure further requests the Bureau to submit a report of its findings and recommendations, including any proposed legislation, to the Legislature no later than twenty days prior to the Regular Session of 2022.

The Bureau takes no position on this measure but submits the following comments for your consideration.

With regard to the study requested of the Bureau, we note that the Bureau has no specific expertise regarding agriculture, food production, disaster resiliency and recovery, or the general excise tax. We further note that the measure requests the Bureau to consult with the Department of Agriculture, Department of Taxation, and Hawaii Emergency Management Agency in conducting the study. Because those agencies likely already possess the information, data, and expertise required to conduct the analysis and make the recommendations requested by this measure, it would seem more immediately beneficial to establish a task force of representatives from the aforementioned agencies to examine the issues requested by this measure and report back to the Legislature.

If the measure is amended in this manner and the Committee desires to keep the Bureau involved, we would respectfully request that the measure be further amended to have the Bureau assist with only the drafting of any proposed legislation that may be a product of the foregoing agencies' findings and recommendations. Further, we would ask that those agencies submit to the Bureau by December 1, 2021, any draft documents for the proposed legislation to allow us adequate time to prepare bill drafts. The Bureau believes that such alternative assistance would be manageable, provided that the Bureau's interim workload is not adversely impacted by too many other studies or additional responsibilities, such as conducting, writing, or finalizing other reports, drafting legislation, or both, for other state agencies, task forces, or working groups that may be requested or required under other legislative measures.

The Department of Taxation (Department) offers the following <u>comments</u> regarding H.C.R. 188 for your consideration.

H.C.R. 188 requests that the Legislative Reference Bureau (LRB), in consultation with the Department and other agencies, conduct a study and recommend to the Legislature how to support greater local production of food. The study requests specific focus on how general excise tax (GET) exemptions could support greater local production of food, as well as how greater local production of food could enhance economic diversification and disaster-relief efforts. The resolution requests that a report of findings and recommendations be submitted no later than twenty days prior to the Regular Session of 2022.

The Department defers to the Department of Agriculture (DOA) and the Hawaii Emergency Management Agency (HIEMA) on the substantive merits and issues surrounding local food production, as it does not possess sufficient subject-matter expertise to opine on this important issue. The Department notes, however, that there are already multiple GET exemptions and Hawaii income tax credits that relate to agriculture. Moreover, targeting tax benefits only to "local" producers may likely create an issue with the Commerce Clause of the U.S. Constitution.

Chairperson Hashem and Members of the Committee:

Thank you for the opportunity to testify on House Concurrent Resolution 188 and Resolution 157. These resolutions request the Legislative Reference Bureau, in consultation with the Department of Agriculture, Department of Taxation, and Hawaii Emergency Management Agency, to conduct a study to recommend to the Legislature how to support greater local production of food.

The Department offers comments and otherwise defers to the Legislative Reference Bureau, Department of Taxation, and Hawaii Emergency Management Agency.

More local production and local consumption of fresh foods and export of fresh and value-added foods will help to diversify the economy and provide some buffer in the availability of fresh foods in the event of a shutdown of the State's harbors due to natural or human causes. With the visitor industry showing signs of modest recovery,

this may help in the alacrity and magnitude of recovery by agricultural operations that have, to date, survived the effects of the shutdown of the visitor industry resulting from the public health response to the pandemic. We understand that agricultural producers lost about 40 to 60 percent of their sales since early in 2020. Exemptions to the General Excise Tax may help agricultural producers but wouldn't a farmer prefer to have increased production and product sales first and foremost? We believe it is supporting the most reasonably safe and expeditious return of visitors to Hawaii and the re-employment and return of economic security of Hawaii's residents that will help stabilize Hawaii's agricultural producers and lead to agriculture's increasing contribution to diversifying the State's economy and increasing food production to provide the buffer sought in these resolutions. Therefore, the Department respectfully requests that these resolutions be held in Committee.
