Aloha, Chair Lowen, Vice Chair Marten, and Members of the Committee on Energy & Environmental Protection:

The Environmental Caucus of the Democratic Party of Hawai'i and its Natural Resources Committee are in **strong support** of HR20/HCR27 as these Resolutions urge the Department of Health's Environmental Management Division to Ensure that destinations to which the State's recyclable waste is transported for out-of-state processing abide by the environmental standards as outlined in the Basel Convention.

The overarching objective of the Basel Convention is to protect human health and the environment against the adverse effects of hazardous wastes. Its scope of application covers a wide range of wastes defined as "hazardous wastes" based on their origin and/or composition and their characteristics, as well as two types of wastes defined as "other wastes" – household wase and incinerator ash.

The provisions of the Convention center around the following principal objectives;

- (1) The reduction of hazardous waste generation and the promotion of environmentally sound management of hazardous wastes, wherever the place of disposal;
- (2) The restriction of transboundary movement of hazardous wastes except where it is

perceived to be in accordance with the principles of environmentally sound management; and

(3) A regulatory system applying to cases where transboundary movements are permissible.

The regulatory system is the cornerstone of the Basel Convention. Based on the concept of prior informed consent, it requires that, before an export may take place, the authorities of the State of export, i.e., Hawaii, notify the authorities of the prospective States of import and transit, providing them with detailed information on the intended movement. The movement may only proceed it and when all States concerned have given their written consent (articles 6 and 7). In the event of a transboundary movement of hazardous wastes having been carried out illegally, i.e., in contravention of the provisions of articles 6 and 7, or cannot be completed as foreseen, the Convention attributes responsibility to one or more of the States involved, and imposes the duty to ensure safe disposal, either by re-import into the State of generation or otherwise (articles 8 and 9). The Democratic Party of Hawai'i (Party) has adopted at its 2018 State Convention, clear safeguards to promote and protect our clean and healthy environment. At page 17 of the Party Platform, it specifically provides, to wit:

ENVIRONMENT

The Democratic Party of Hawai'i believes that the preservation and restoration of our natural environment is essential. We support a sustainable society that utilizes the earth in such a way that future generations will benefit from the practices of our generation. We support the restoration, preservation, and protection of our native ecosystems on each island. We believe in integrated approaches, practices, and support public policies that create and maintain a sustainable way of life in Hawai'i.

We believe in supporting best management practices in sustaining our environment and in increased citizen involvement. We support programs that encourage sustainable clean, efficient, creative and environmentally friendly modes of transportation, recycling and waste reduction.

The conservation, preservation and restoration of Hawai'i's natural resources are connected to health and welfare of our people; therefore, we support the conservation and protection of our natural environment, which includes reducing our carbon footprint for the benefit of current and future generations.

We support the protection of our 'aina against destruction by corporate, government, or military usage and expect full restoration and reparation of environmental damage.

We believe in the vigorous enforcement of our environmental laws and increased public-private stewardships and citizen involvement in protecting our resources.

We know that climate change is a real threat to our islands and the world. We strongly urge our candidates and elected officials to take immediate action to mitigate and adapt to the consequences of climate change. This includes funding adaptation measures including coastal retreat, effective participation of indigenous peoples in climate change governance, and recognition that indigenous, local, and traditional ecological knowledge is key in climate change adaptation solutions.

We strongly urge you to pass HR20 / HCR27 as these Resolutions urge the Department of Health's Environmental Management Division to ensure that destinations to which the State's recyclable waste is transported for out-of-state processing abide by the environmental standards as outlined in the Basel Convention, all of which requirements are consistent with the Democratic Party Platform as they require the vigorous enforcement of our environmental laws to observe the fundamental principles of environmentally sound waste management in protecting our resources.

CONVENTION. - SUPPORT

On behalf of the American Chemistry Council (ACC), I am writing to express support for HR 20 and HCR 27, resolutions urging the United States to ratify the Basel Convention on the Control of Transboundary Movements of Hazardous Wastes and Their Disposal. ACC has long supported the U.S. ratification and implementation of the Basel Convention. ACC and its members support policies that aim to ensure that exported and imported end-of-life materials are recycled, recovered, or disposed of in an environmentally sound manner. The Basel Convention has an important role in ensuring these environmentally responsible global trade flows.

Basel Parties recently amended the Convention to control trade in most plastic waste as part of the larger global effort to address plastic waste. ACC and its member companies take seriously the need to address this global challenge. We recently announced goals that 100% of plastics packaging is reused, recycled or recovered by 2040. We also continue to be engaged in developing policies and programs aimed at increasing the recovery of plastic packaging and developing new domestic markets for recycled materials through both mechanical and innovative advanced recycling technologies that convert post-use plastics into a diverse range of raw materials, including feedstocks for new plastics and chemicals.

Last year, the <u>Global Plastics Alliance (GPA)</u> released its <u>5th Progress Report</u> announcing approximately 395 marine litter prevention projects have been planned, underway, or completed as of early 2020. The GPA, a collaboration among plastic industry associations around the world, noted the accounting of projects represents an increase of four times the amount since 2011 when the group was formed. The latest report reflects work undertaken by 80 plastics associations, including ACC, that have signed the Global Declaration in 43 countries. The six focus areas of the Global Declaration are education, research, public policy, sharing best practices, plastics recycling/recovery, and plastic pellet containment.

In just the past three years, <u>66 projects worth more than \$5.5 billion in modern recycling technologies</u>, have been announced in the U.S. alone; the vast majority of the investment dollars are being deployed to construct advanced recycling facilities.
