# In consideration of HOUSE CONCURRENT RESOLUTION NO. 44

Chair Taniguchi, Vice Chair Ihara, and members of the Committee on Labor, Culture and the Arts: the Hawai'i Tourism Authority (HTA) supports HCR 44, which urges United States President Joe Biden and the Asia-Pacific Economic Cooperation (APEC) to hold the 2023 APEC summit in Honolulu, Hawai'i.

This conference, which brings together the heads of state from 21 countries in the Asia-Pacific region thousands of foreign diplomats, and support staff and media members from around the world, would give Hawai'i's visitor industry a much-needed boost as our state recovers from the devastating economic impacts of COVID-19.
