## Comments:

My name is Kathleen Foote and I am a resident of Kapilina Beach Homes, a neighborhood adjacent to North Road in Ewa. I am also a member of the Ewa Neighborhood Board. I have been appalled by the conditions on North Road since moving here 3 years ago.

Many residents of Kapilina refuse to walk or ride bicycles along North Road, although it is the only road available in or out of Kapilina, because of the potentially dangerous conditions. There are no sidewalks, no lighting and the road is lined with trash, abandoned vehicles, and overgrown weeds.

There is no public transportation to Kapilina, so residents who work in Waikiki and get on the bus at the end of their work day during daylight end up having to walk along the road in complete darkness for more than 2 miles to get home.

Although James Campbell High School is directly down the road, it is rare to see students walking or riding bikes home from school - safety is a main concern.

Volunteers are the only line of defense for the trash, although the garbage begins to reappear within hours of their efforts.

Calling 311 to get the abandoned vehicles removed results in messages that the road does not belong to the city/county so the vehicles stay. Calls to the golf course go unanswered.

I support the efforts of Rep McDermott in beginning the process of clearing and cleaning this disrespectful eyesore.
