Case example: Denver Public Schools<sup>1</sup>

"The Denver Public Schools Restorative Justice Project was implemented to positively and effectively address the growing number of out-of-school suspensions in the district. In the 2004-2005 school year, this number approached 15,000 across the district, a number that has not been seen since."

The report from 2008-2009 (the fourth year of the program) show these results, comparing the first quarter and the last quarter of the 2008-2009 school year:

### Case Example: West Philadelphia High School<sup>2</sup>

"West Philadelphia High School, widely known as one of Philadelphia's mostdangerous and high-risk schools, on the state's 'Persistently Dangerous Schools' list for six years running, [saw] positive results with restorative practices less than one school year into implementation."

These statistics compare incidents in 2006-2007 to incidents 2007-2008 (the first year of implementation).

Assaults on teachers/admin decreased 76%.

Dangerous acts decreased 52% in the first year, with an additional 45%

decrease in the second year.

25% decrease in number of students suspended one time.

20% decrease in number of students suspended two times.

40% decrease in number of students suspended more than three times. Disorderly conduct decreased 72%.

Assaults on students decreased 60%.

"I think the turning moment—and I could see it in the students' faces—is when they realized they had a say... that they were going to be listened to, they would have input."

### Case Example: Palisades High School and Middle School, PA<sup>3</sup>

"Palisades High School was the first International Institute for Restorative Practices (IIRP) SaferSanerSchools pilot school . . . the principal [at the time] said that before the program was introduced . . . the level of caring and respect among many students had declined."

"Restorative practices was introduced at Palisades Middle School (PALMS) in Fall 2000. Previously the school climate was discourteous and disrespectful and altercations were common. PALMS principal Edward Baumgartner said 'We were suspending 200 students a year for everything from disrespect to not making up gym.'"

Palisades High School

Administrative detentions decreased 60% in the fourth year compared to the first year.

Number of **incidents decreased 40%** in the third year compared to the first year.

Number of out-of-schoolsuspensions decreased 38%

in the fourth year compared to the first year.

Number of referrals to the student office decreased

34% in the fourth year compared to the third year.

Palisades Middle School

Disciplinary referrals to the PALMS office decreased 43% in a year.

"I used to be one of these black and white, law and order guys. Kids had to be held accountable and the only way to do that was to kick them out of school—to show the other kids that you're the boss. That doesn't work. I didn't solve problems; I just postponed them until they got to high school. Restorative practices works. We now fix and solve problems."

Punishment and retributive justice simply are not as effective as a Restorative Justice approach. Sociological research supports the fact that punishment does not develop the kinds of motivations we want to see in healthy, productive members of society. Restorative Justice offers significant benefits:

#### Benefits to the community

Reduced recidivism. Restorative justice has a high rate of success in reducing repeat offenses. When communities reintegrate their citizens after harm has been repaired, the likelihood of recidivism is greatly reduced. People who have offended have the opportunity to make things right, learn from the process, and put the matter behind them, so they can more easily go on to lead a crime-free life.

Increased safety. With reduced recidivism comes a safer community. Restorative justice empowers individuals to make their neighborhoods and towns safer and more pleasant places to live.

Cost effectiveness. A restorative approach to crime saves the state money by preventing individuals from becoming part of the criminal justice system for offenses that can be resolved at the local level with community and victim participation.

A stronger community. In addition to enhancing the safety and well being of a town or region, community justice centers help to establish a more active citizenship. Volunteering has been shown to build stronger and more cohesive communities and increase the social networks within towns and neighborhoods.

#### Benefits to victims

Empowerment. When victims are offered the opportunity to have a safe and facilitated dialogue with the person who harmed them, they feel empowered and invested in the process. Victims' needs are acknowledged and considered, which gives them a voice in an often impersonal system.

Meaningful dialogue. Victims are given the opportunity to explain how they were harmed, get answers to their questions, and state what they need the offender to do to make amends.

Recovery and satisfaction. Restorative justice boasts a high rate of victim satisfaction. Many are able to recover what was taken from them, whether it be material possessions or their sense of security and peace of mind. They are more likely to be able to move on from the incident and get back to their daily lives.

#### Benefits to people who offend

An opportunity to make it right. People who offend have the opportunity to express remorse and apologize for their actions, benefiting themselves as well as their victims.

A way to put the incident behind them. People who offend have the opportunity to make significant and appropriate amends and then move on. They are able to return to their communities knowing that the matter is settled.

A timely resolution. The process of restorative justice is swift in comparison to the criminal justice system, so that offenders can more quickly make meaningful changes in their lives.

A high success rate. Restorative justice has a high rate of compliance or completion. Within a voluntary and non-coercive process, people who have offended tend to follow through on agreements that they have a part in creating.

#### Comments:

The Department of Education has antequated policies for dealing with problematic behavior. Restorative Justice (RJ) is a philosophy that enables communities to focus on building community as the principle means of reducing problem behaviors, and then to have practices to address behavior using a community approach. RJ cannot and should not be implemented without having the funding to address professional development and staffing needs, otherwise it runs the risk of becoming another trend that is bound to fail without proper support. I encourage the legislature to not only adopt this resolution but to also contemplate working with the communities currently using RJ in their schools, as well as those using similar philosophies grounded in Hawaiian culture, such as Foundations of Aloha, to identify what financial support would be needed to sustain programming at the school, complex, and department level, and to work to find funding to do so.
