Hawaii Youth Services Network, a statewide coalition of youth-serving organizations, supports HCR 162/HR 138 Requesting the Department of Health, Via the Behavioral Risk Factor Surveillance System, and the Department of Education, Via the Youth Risk Behavior Surveillance System, to Collect Information on the Sex, Sexual Orientation, and Gender Identity and Gender Expression of Respondents.

The Youth Risk Behavior Survey is a valuable data tool to track youth behavior that promotes good health and safety as well as risky behavior in which they may engage. It informs policies and programs for children and adolescents in areas such as tobacco, nutrition, sexual health, and substance use.

Dear Chair Yamane

The Trevor Project wishes to express its strong support of HR138, which would request the Department of Health, via the Behavioral Risk Factor Surveillance System and the Department of Education, via the Youth Risk Behavior Surveillance System to collect information on the sex, sexual orientation, gender identity, and gender expression of respondents.

The Trevor Project is the world's largest suicide prevention and crisis intervention organization for LGBTQ (Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning) young people. We work every day to save young lives by providing support through free and confidential suicide prevention through our 24/7 phone lifeline, chat, and text. We also run TrevorSpace, the world's largest safe space social networking site for LGBTQ youth, and operate innovative education, research, and advocacy programs.

Currently, there is only limited information about LGBTQI youth, particularly transgender, nonbinary, gender nonconforming, and/or intersex youth, because surveys that gather this data do not always ask these important demographic questions. Research has shown that transgender and gender nonconforming youth report higher rates of violence, substance use, suicide risk, and sexual risk behaviors. HR138 would help ensure that the Behavioral Risk Factor Surveillance System and the Youth Risk Behavior Survey are collecting this important demographic data to identify areas of issue, track trends, and ultimately help allocate appropriate resources.

The COVID-19 pandemic has exacerbated the need for mental health care and suicide prevention, especially as social isolation has increased due to physical distancing and other preventative measures. Recent polling by the Trevor Project also shows that 35% of LGBTQ youth report have felt more lonely during the COVID-19 pandemic compared to 22% of their cisgender/straight peers. A higher baseline of vulnerability means that when a stressor occurs, such as COVID-19, those people who are already at higher risk are more likely to find themselves in crisis. Therefore, it is more important than ever for collected data to be comprehensive in order to understand the full nature of youth behaviors as they relate to various

populations, and to ensure that especially vulnerable populations receive the resources and policy attention they need and deserve.

Please pass HCR162/HR138 to request that the Dept. of Health and Dept. of Education intentionally collect data around gender identity, gender expression, and sexual orientation and to expand to include intersex data. According to researchers Yost and Gilmore in 2011, the voices, stories, and issues of underrepresented populations, including LGBTQIA+ students are often not addressed- leading to feelings of isolation and loss of school connectedness. About 66 percent of LGBTQIA+ students face discrimination from their teachers and peers-leading to poor mental health outcomes such as depression and self-harm, mentioned by the Gay, Lesbian and Straight Education Network (GLSEN). Further explained by GLSEN, over 85 percent of LGBTQIA+ students reported being verbally harassed based on their sexual/gender orientation. As a result, 32 percent of LGBTQIA+ students report feeling unsafe, uncomfortable, and unmotivated to attend school, which leads to lower academic success (GLSEN, 2016). Positive representations of the LGBTQIA+ community provide a more accepting, safer environment for LGBTQIA+ students (Gowen and Winges-Yanez, 2014). Proper representation of LGBTQIA+ community can increase students' understanding of the risks associated with the LGBTQIA+ community, thus, allowing LGBTQIA+ students to feel more secured and less victimized.
