Honorable Representatives, I am writing in support of HR 50, Equity for Farmers and Ranchers. The 2017 National Ag Statistics Service Census of Agriculture data shows that in Hawai'i, Pacific Islanders, Native Hawaiians, Asians, and African Americans reported owning farms at much lower numbers than whites

(https://www.nass.usda.gov/Publications/AgCensus/2017/Full\_Report/Volume\_1,\_Chap ter\_1\_State\_Level/Hawaii/st15\_1\_0061\_0061.pdf). There are already many barriers to creating and maintainin successful agricultural and ranching operations, some of which are access to capitol, access to technical assistance, land access, and access to information and services. These barriers become greater when coupled with policies and programs that are not delivered in culturally appropriate ways or in languages that recipients are conversant in.
