Baldwin High School. I earned my undergraduate degrees from the University of Southern California and law degree from Southwestern Law School, both in Los Angeles. I practiced law in California before returning home to Maui in 2008 to clerk for the Honorable Joseph E. Cardoza. I am a former Deputy Corporation Counsel for the County of Maui, and since 2011 I have been a Deputy Prosecuting Attorney for the County of Maui.

Over the past ten years, I prosecuted many criminal cases where the defendant was represented by Chris. Through these cases together, I had the opportunity to observe qualities in Chris which I believe will make him an outstanding District Court Judge. I have witnessed Chris' lawyering skills hundreds of times during his tenure in Massachusetts. Whether he's arguing bail for a defendant or litigating a serious and complex criminal case, Chris passionately and effectively represents the interests of his clients, without regard to whether he is court appointed or privately retained. His respect for constitutional safeguards is clearly evident in his skilled advocacy and the dignity and respect he affords to his clients and their rights. He has a very good command of the relevant law, his memoranda are superbly written and thoroughly documented, and his meticulous preparation is patently obvious to anyone who has observed him in the courtroom.
