The Office of the Enterprise Technology Services (ETS) supports Senate Bill 1111, which establishes the Hawaii State Fusion Center as a program under the Office of Homeland Security and establishes the Hawaii State Fusion Center Director to manage the Center's day-to-day operations and be accountable to the Director of Homeland Security

The Hawaii State Fusion Center (HSFC) protects our communities and supports national security policy by facilitating the analysis, distribution, and sharing of criminal and terrorist activity intelligence and providing training and technology resources for local, state, and federal law enforcement, public safety, fire service, emergency response, public health, and public and private sector providers of critical services.

To carry out ETS' core mission to safeguard state government data and to protect the state government technology infrastructure, the ETS cyber security team works closely with the Hawaii State Fusion Center to exchange cyber threat and cyber incident information with federal, state, and local law enforcement and private sector homeland security partners. As a specific example, ETS and HSFC are partners with the Office of Elections to enhance physical and cyber security activities during the recent primary and general elections.

I am MG Kenneth S. Hara, Adjutant General, Director of Emergency Management and Homeland Security Advisor. Thank you for the opportunity to submit testimony in **SUPPORT** of SB 1111.

The proposal of SB 1111, with the additions to HRS Chapter 128A will solidify the Hawaii State Fusion Center. One of the major functions of the fusion center is to share information ensuring our partners are equipped with the necessary tools to keep Hawaii and the Nation safe, secure and resilient.

The Hawaii State Fusion Center serves as a focal point for the state for the receipt, analysis, gathering and sharing of threat-related information between the federal, state, local, and private sector partners. Fusion centers are situated in the state to empower front line law enforcement, public safety, fire, emergency responders, public health, critical infrastructure protection and private sector security personnel to understand the implications of intelligence for and to the State. The fusion center provides interdisciplinary expertise and situational awareness to inform decision-making at all levels of government. The Hawaii State Fusion Center conducts analysis and facilitates information sharing by assisting law enforcement and homeland security partners in preventing, protecting against and responding to crime, terrorism and all-hazard incidents.

The fusion center collaborates among all levels of government to receive, analyze, and disseminate threat related information in coordination with intelligence partners by coordinating with the 16 critical infrastructure sectors and lifelines, for example, electric, water, food, gas, utilities, communications, etc.

The collaboration includes the integration of cyber related threat information, cyber-crime prevention and analytic capabilities to assist in identifying cyber threats and indicators to individual networks and systems.

The intelligence analysts within the fusion center assist piecing together the disparate bits of information to form integrated views to produce actionable intelligence products on emerging cyber incidents, risk, threats, event, or trend.

The Hawaii State Fusion Center works closely with all educational levels and security personnel to track certain school incidents, such as stranger-danger or threats of targeted school violence. In addition, the Hawaii State Fusion Center works with members of the visitor industry and with retail establishments to help them track threats against visitors and businesses.

The Hawaii State Fusion Center is an important part of Hawaii's Homeland Security and the protection of our citizens and visitors.

**DEPARTMENT'S POSITION**: The Department of Human Services (DHS) supports this administration measure.

**PURPOSE**: The purpose of the bill establishes the Hawaii State Fusion Center (Center) as a program under the Office of Homeland Security as described in chapter 128A, Hawaii Revised Statutes. Also establishes the position of Hawaii State Fusion Center Director who shall be state-funded, permanently exempt from chapter 76, Hawaii Revised Statutes, responsible to the Director of Homeland Security, and accountable to manage the operations of the Center.

The Fusion Center and the Fusion Center Director are vital to the security, health, and well-being of Hawaii's residents and visitors. The Fusion Center provides access to cross-sector and cross-government communication.

DHS is a partner agency with the Fusion Center, and DHS staff actively participate in training and briefings that are easily accessible and available on a variety of issues. In the past year, DHS staff have attended training and discussions addressing cyber security, efforts of online law enforcement to identify sex trafficking, active shooter events, coronavirus procedures, and debriefs of significant events to inform planning. In January 2020, shortly after news of the coronavirus was emerging from China, DHS staff attended a presentation at the Fusion Center by the CDC Honolulu Region Division of Global Migration and Quarantine on CDC's procedures. Throughout the pandemic, the Fusion Center has continued to provide pandemic related resources and awareness, and other security information and advice leading up to the 2020 election and the violent January 6, 2021 insurrection at the U.S. Capitol.

The Board of Water Supply (BWS) strongly supports Senate Bill (SB) 1111. As a water utility serving almost one million residents and visitors, the BWS is designated as part of Hawaii's critical infrastructure by the Department Homeland Security. The BWS recognizes potential terrorist threats may significantly impact the health, safety and livelihood of every resident and visitor on the Island of Oahu.

Safeguarding our operation from these potential threats is the reason the BWS has become a partner of the Hawaii State Fusion Center (HSFC) under the direction of the Hawaii Department of Defense, through the signing of a Memorandum of Understanding (MOU) in June 2016. The MOU establishes efficient and timely sharing of information between two organizations to increase situational awareness of possible cyber-security issues and concerns.

With the current and actionable threat intelligence, coordinated and timely information dissemination, access to critical information sharing amongst Federal, State, County agencies and public-private entities is a critical component of our situational and operational programs for protecting against cyber and physical attacks. For many years, the Retail Merchant of Hawaii has been working in partnership with the Hawaii State Fusion Center. As property crimes continue to plague retailers, the Hawaii State Fusion Center has been instrumental in establishing the Hawaii Organized Retail Crime Alliance (HIORCA) website that is open only to law enforcement and retail investigators in an effort to share cross jurisdictional information to identify, disrupt, and apprehend Organized Retail Crime (ORC) crews. HIORCA operates like a business "crime watch" that allows law enforcement and retailers to communicate on a real time basis through alerts about criminal activity and incidents impacting their business or geographic area, as well as prevent other retail partners from being victimized.

The information that we receive from the Hawaii State Fusion Center is invaluable through their dissemination of information on leads, tips, trends, suspicious activities and more. It is only by continuing to work in partnership that we can maintain a Hawaii that is not only safe to visit but to live and work as well.
