

SB1384 HD1 RELATING TO EDUCATION Ke Kōmike Hale o ka 'Oihana 'Imi Kālā House Committee on Finance

The Office of Hawaiian Affairs (OHA) **STRONGLY SUPPORTS** SB1384 HD1, which would facilitate the state's kuleana to 'Ōlelo Hawai'i by allowing for consistent and continued representation for Hawaiian medium early learning providers on the state's Early Learning Board (ELB). The perpetuation of 'Ōlelo Hawai'i is critical to the evolving culture, health, and well-being of Native Hawaiians, and this measure may be crucial to ensuring the continued use and growth of 'Ōlelo Hawai'i in Hawai'i and beyond. Passage of this measure would help give 'Ōlelo Hawai'i a fighting change for re-normalization since its near extinction due largely to past prohibition in Hawai'i schools.

Although our state is constitutionally mandated "to promote the study of Hawaiian culture, history, and language[,]" and 'Ōlelo Hawai'i has been an official state language since 1978,¹ much remains to be done to ensure the re-normalization of the Hawaiian language in the Hawaiian Islands. Once spoken fluently throughout Hawai'i by Native Hawaiians and foreigners alike, 'Ōlelo Hawai'i was thought to be nearly extinct by the 1980s, when fewer than 50 fluent speakers under the age of 18 were left. A major reason for the near extinction of the Hawaiian language was an 1896 law that effectively banned 'Ōlelo Hawai'i from being taught and spoken in schools, forcing English-only instruction.² This 1896 law and its predecessors were in effect for roughly 90 years, until efforts by 'Aha Pūnana Leo and others in the mid 1980s were finally recognized and realized by the legislature to once again allow for 'Ōlelo Hawai'i medium instruction in our local schools.³ Ensuring that our early learning system and policies recognize the importance of 'Ōlelo Hawai'i immersion – which may also have significant developmental benefits – for Hawai'is infants, toddlers, and preschoolers is essential to remedy this past harm and near genocide of Hawaiian language and culture. Accordingly, it is critical to

have continuous and consistent representation of Hawaiian medium early learning providers on the ELB.

However, the ELB seat for a "representative of Hawaiian medium early learning providers," historically filled by the 'Aha Pūnana Leo, is currently limited only to two, two-year consecutive terms.⁴ Thus, the "Hawaiian medium early learning provider" representative may not serve more than a maximum of four consecutive years. This poses a significant challenge for a representative with the requisite experience and institutional knowledge to consistently fill this position, and has limited the ability of the 'APL representative from building the institutional knowledge and presence necessary to effectively advocate for the importance and value of a Hawaiian medium early education.

By exempting the Hawaiian-medium representative from the general two-term limit in HRS § 26-34(a), SB1384 HD1 will accordingly enable a representative of Hawaiian medium early education to maintain a consistent Hawaiian voice on the ELB, and thereby help to fulfill the greater mission to perpetuate and normalize the state's official language of 'Ōlelo Hawai'i.

The strength and endurance of 'Ōlelo Hawai'i is intrinsically connected to the health and wellbeing of the Native Hawaiian people, and it is part of what makes Hawai'i an authentic, unique, and beautiful place for all our local keiki to enjoy, learn, and ultimately thrive. **E ola mau ka 'Ōlelo Hawai'i**!

Accordingly, OHA urges the Committee to **PASS** SB1384 HD1. Mahalo nui for the opportunity to testify on this important issue.

Early Learning Board Position: Supports the Intent

Good afternoon Members of the Committee on Finance. I am Robert G. Peters, Chair of the Early Learning Board (ELB). Thank you for this opportunity to offer testimony in support of the intent of SB 1384, H.D.1 on behalf of the Early Learning Board.

Through Act 202, Session Laws of Hawaii 2017, ELB transitioned from an advisory to a governing board for the Executive Office on Early Learning (EOEL) and is charged with formulating statewide policy relating to early learning.

The ELB is composed of 17 representatives from across the early childhood field, in both the public and private sectors. One of those members is the representative of the Hawaiian medium early learning providers.

Hawaii has designated Hawaiian as one of its two official state languages. As such, and to insure the ELB reflects the diversity of the early learning community, the representative for Hawaiian medium early learning providers is a critical member and advocate for the important values of a Hawaiian medium early education. To date, the Hawaiian medium early learning provider seat has been filled by a representative of `Aha Punana Leo for both the Early Learning Board and its earlier iteration, the Early Learning Advisory Board.

The Hawaiian medium early learning provider seat is limited to two consecutive, two-year teams according to current statute. Thus, the representative cannot serve more than 4 years before terming out. The sense of the Board is that the term limit as provided is a barrier to continuity of experienced representation that the amended bill would address. The consistency of representation is the issue upon which a majority of Board members agree; at the same time, there are some on the ELB who would like to investigate the composition of the Board given current needs and the development of the Board.

The ELB appreciates the amended bill (H.D.1) that eliminates the language in the original that imposed a repeal date of June 30, 2025, which seemed counter to the intent of this measure.
