Honorable Chair, Vice-Chair and Committee Members:

Thank you for the opportunity to submit testimony in **Support** of **SB1421**.

Oceanit is a local diversified science and engineering company with capabilities/facilities in advanced technology, artificial intelligence, quantum, life sciences, information systems, aerospace, energy, oil and gas, and consulting engineering services.

Through various federal funding sources we have demonstrated the ability to develop "disruptive technologies" that are changing the way we live and work in the world. However, the ability to take disruptive technologies to the next level or to commercialize has been a challenge. Federal R&D funding is restricted to research and development activities, i.e., no marketing or commercialization activities allowed. And only a small percentage of tech businesses are venture-fundable. To diversify Hawaii's economy and the help Hawaii's economic recovery, the State needs to support Hawaii technology companies who are stuck in the "ditch" between research and product realization.

Previous support of Hawaii's Dual Use technologies, has created several new high tech startups in Hawaii, as well as product development efforts which have brought funding and people to Hawaii. This bill will create a task force to explore potential dual use technology research and development efforts to create high income jobs opportunities for Hawaii's residents and graduates of Hawaii's educational institutions. In return, the State will benefit from tax revenues, job creation and economic growth.

The Hawaii Technology Development Corporation (HTDC) **supports** the intent of SB1421, SD2 that creates a task force within the department of business, economic development, and tourism consisting of representatives from the university of Hawaii, Hawaii technology development corporation, and the State's technological and business community that explores how dual use technology can be used to promote economic recovery and diversify the State's economy; requires the task force to submit reports to the legislature in 2023 and 2025; and provides that the task force shall be dissolved on an unspecified date.

HTDC supports efforts to diversify Hawaii's economy through innovation. HTDC administers the Hawai'i Small Business Innovation Research (HSBIR) program serving many businesses from the dual-use community. We are working very closely with the University of Hawaii on pilot initiatives aimed at getting University technology to market and increasing the pipeline of new small businesses securing federal SBIR funds. We are also partnered with the University of Hawaii and the Naval Information Warfare Center (NIWC formerly known as SPAWAR) Pacific on the Hawai'i Tech Bridge Program to facilitate new opportunities for local technology companies to provide solutions for the Navy. Exploring new project opportunities for dual-use technology is well aligned with HTDC's current priorities. HTDC prefers the original draft of the bill which included an appropriation.

HTDC looks forward to working with all stakeholders in moving dual-use technology forward. HTDC supports this bill provided it does not supplant the priorities in the Administration's budget. Thank you for the opportunity to offer these comments.

I am Larry Veray, Chairman for the Pearl City Neighborhood Board No.21 and I am submitting this testimony as an individual but I want you to know that hope our State can recover from the COVID 19 pandemic, loss of jobs and economic growth as soon as possible. To tackle these issues, it truly requires strong leadership, innovative ideas, creative solutions and bringing in valued resources. This Task Force should be comprised of real creative thinkers and problem solvers who have been exposed to the latest technology, computer software and visualization and analysis tools developed by the military that could be transitioned for civilian employment.
