Allowing minors to consent for HIV testing and treatment will reduce risks of HIV transmission and increase likelihood that minors will receive testing and treatment.

We are not sure that this bill is necessary, however, as minors ages 14 and older already have the right to consent to primary and preventive medical care when parental/guardian consent cannot reasonably be obtained (Citation from the capitol.hawaii.gov website below).

Chair Rhoads, Vice Chair Keohokalole, and committee members, thank you for this opportunity to provide testimony on SB 25 SD1, which permits minors to consent to medical care related to the diagnosis or treatment of HIV or the prevention of HIV and authorizes physician assistants, in addition to physicians and advanced practice registered nurses, to render such treatment to minors.

Kaiser Permanente Hawai'i SUPPORTS SB 25 SD1.

Kaiser Permanente Hawai'i is Hawai'i's largest integrated health system that provides care and coverage for approximately 260,000 members. Each day, more than 4,400 dedicated employees and more than 600 Hawai'i Permanente Medical Group physicians and providers come to work at Kaiser Permanente Hawai'i to care for our members at our 20 medical facilities, including Moanalua Medical Center, providing high-quality care for our members and delivering on our commitment to improve the health of the 1.4 million people living in the communities we serve.

Kaiser Permanente Hawai'i supports SB 25 SD1 because it would ensure and promote access to care for this significantly vulnerable population of our state. Adolescents and young adults (aged 13-29) accounted for 41% of new HIV diagnoses in 2017.¹ Those aged 13 to 24 accounted for 21%; roughly one in every five new diagnoses.² Of these, 44% were unaware of their status. This age group is the least likely to test for HIV, receive HIV treatment or be virally suppressed, or be offered HIV prevention treatment. Data from 2012 to 2016 shows HIV diagnoses have either stabilized or fallen among the majority of adult population groups, however they increased by 6% among those aged 13 to 29.³

The Trevor Project writes to support SB25-SD1, which permits minors to consent to medical care related to the diagnosis, treatment, or prevention of the human immunodeficiency virus (HIV).

The Trevor Project is the world's largest suicide prevention and crisis intervention organization for LGBTQ (Lesbian, Gay, Bisexual, Transgender, Queer, and Questioning) young people. We work to save young lives by providing support through free and confidential suicide prevention and crisis intervention programs available by our 24/7 phone lifeline, chat, and text services; TrevorSpace, the world's largest safe space social networking site for LGBTQ youth; and through our innovative education, research, and advocacy programs.

From our 2019 National Survey on LGBTQ Youth Mental Health we know that only 68% of LGBTQ young people disclose their sexual orientation to their parents and only 51% of trangender or nonbinary youth share their gender identity. Accessing life-saving HIV prevention services should not be reliant upon sharing one's sexual orientation or gender identity, including with parents and/guardians. This bill is not intended to disrupt meaningful and supportive parental and family relationships, but it gives youth the opportunity to seek care without fear of stigma or other barriers to care.

HIV and AIDS continues to be very serious viruses and its holders, adult and youth alike, still carry stigma around the world, their safety always at the threshold. Very similarly we are now seeing on a grander scale COVID-19, creating the same challenges. We need to get ahead of it.

Many adolescents are unwilling to receive sensitive healthcare services if they need to involve their parent or guardian. This is very similar to young women getting access to birth control, pregnancy tests and abortion/planned parenthood services. We should empower them to take responsibility for their health care.

A minor's ability to consent to getting tested for HIV or accept a prescription for a medication such as PrEP, can ultimately be the end of the spreading of the virus. PrEP (pre-exposure prophylaxis) is medicine people at risk for HIV take to prevent getting HIV from sex or injection drug use. When taken as prescribed, PrEP is highly effective for preventing HIV.
