Department Testimony: Thank you for the opportunity to testify in STRONG SUPPORT of
S.B. 25 which would permit minors, as currently defined in §577A-1, HRS, "from the age of
fourteen to seventeen inclusive," to consent to medical care related to the diagnosis, treatment, or
prevention of HIV. Parents or legal guardians would not be able to abrogate consent. The minor
would not be liable for payment. This measure would also update archaic terminology in §577A,
HRS, by replacing "venereal disease" with "sexually transmitted infection."

8 The department strongly supports S.B. 25 as it can help prevent HIV acquisition in 9 minors and supports critical treatment of minors diagnosed with HIV. Safe, highly effective 10 medications for the treatment and prevention of HIV need to be accessible for all individuals 11 diagnosed with HIV or at high risk of acquiring HIV. Medications taken by an HIV-uninfected 12 individual to prevent acquisition of HIV are highly effective and were approved for use in 13 minors in 2018.

Current statutes do not appear to permit a minor to consent to medical care related to the prevention of HIV. This is a critical gap in access to medical care. This measure would resolve this gap. Permitting minors who cannot or will not seek the consent of their parents or guardians to consent to HIV medical care is essential to the health of the minor and a valuable step in ending the HIV epidemic in Hawaii.

#### Re: SB 25, Relating to the Medical Care for Minors

Chair Keohokalole, Vice Chair Baker, and committee members, thank you for this opportunity to provide testimony on SB 25, which permits minors to consent to medical care related to the diagnosis or treatment of HIV or the prevention of HIV.

#### Kaiser Permanente Hawai'i SUPPORTS SB 25 and requests an AMENDMENT.

Kaiser Permanente Hawai'i is Hawai'i's largest integrated health system that provides care and coverage for approximately 260,000 members. Each day, more than 4,400 dedicated employees and more than 600 Hawai'i Permanente Medical Group physicians and providers come to work at Kaiser Permanente Hawai'i to care for our members at our 20 medical facilities, including Moanalua Medical Center, providing high-quality care for our members and delivering on our commitment to improve the health of the 1.4 million people living in the communities we serve.

Kaiser Permanente Hawai'i supports SB 25 because it would ensure and promote access to care for this significantly vulnerable population of our state. Adolescents and young adults (aged 13-29) accounted for 41% of new HIV diagnoses in 2017.<sup>1</sup> Those aged 13 to 24 accounted for 21%; roughly one in every five new diagnoses.<sup>2</sup> Of these, 44% were unaware of their status. This age group is the least likely to test for HIV, receive HIV treatment or be virally suppressed, or be offered HIV prevention treatment. Data from 2012 to 2016 shows HIV diagnoses have either stabilized or fallen among the majority of adult population groups, however they increased by 6% among those aged 13 to 29.<sup>3</sup>

We support SB 25 because it would further enable and encourage minors age fourteen to seventeen to obtain such services without involvement of a parent or guardian.

We note that it appears the intent of SB25 is to clarify a "health care provider" as "an individual licensed, certified, or otherwise authorized or permitted by law to provide health care in the ordinary course of the individual's business or profession." This includes, physicians, osteopathic physicians, physician assistants (PAs), and advanced practice register nurses (APRNs). Hawai'i has already seen the benefit of allowing qualified licensed providers perform a wide range of health care services, with both APRNs' and PAs' roles expanding dramatically in Hawai'i. Similarly, in 2019, the legislature recognized that PAs can safely and effectively perform their extensive duties with reduced supervision. PAs perform physical examinations, diagnose, and treat illnesses, order and interpret lab tests, perform medical procedures, assist in surgery, and enhance health care coordination. In Hawai'i, PAs practice in primary care and in every medical and surgical subspecialty. Both APRNs and PAs may function as Primary Care Providers (PCP), managing chronic conditions like hypertension and diabetes and providing gynecologic care and family planning services.

However, other parts of Section 577A limit the ability to treat these minors to a "physician licensed to practice medicine, or advanced practice registered nurse". Therefore, we request the committee consider the following amendments to include PAs where physicians and APRNs are already included:

SECTION 3. Section 577A-2, Hawaii Revised Statutes, is amended to read as follows:

"§577A-2 Consent valid. The consent to the provision of medical care and services by public and private hospitals or public and private clinics, or the performance of medical care and services by a physician or physician assistant licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, when executed by a female minor who is or professes to be prequant, or by a minor who is or professes to be [afflicted with a venereal disease,] infected with, or to have been exposed to, a sexually transmitted infection, or a minor seeking family planning services shall be valid and binding as if the minor had achieved his or her majority as the case may be; that is, a female minor who is, or professes to be pregnant, or a minor who is, or professes to be [afflicted with a venereal disease,] infected with, or to have been exposed to, a sexually transmitted infection, or a minor seeking family planning services shall be deemed to have, and shall have the same legal capacity to act, and the same legal obligations with regard to the giving of such consent to such hospitals and such clinics or medical care and services to be

provided by a physician <u>or physician assistant</u> licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, as a person of full legal age and capacity, the infancy of the minor and any contrary provisions of law notwithstanding, and such consent shall not be subject to later disaffirmance by reason of such minority; and the consent of no other person or persons (including, but not limited to a spouse, parent, custodian, or guardian) shall be necessary in order to authorize such hospitals or such clinics or medical care and services provided by a physician <u>or physician assistant</u> licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, to such a minor."

SECTION 4. Section 577A-3, Hawaii Revised Statutes, is amended to read as follows:

"§577A-3 Providing information. Public and private hospitals, or public and private clinics or physicians or physician assistants licensed to practice medicine, or advanced practice registered nurses as defined in section 457-2.7 may, at the discretion of the treating physician, physician assistant, or advanced practice registered nurse, inform the spouse, parent, custodian, or guardian of any minor patient of the provision of medical care and services to the minor or disclose any information pertaining to such care and services after consulting with the minor patient to whom such medical care and services have been provided under this chapter.

If the minor patient is not diagnosed as being pregnant or [afflicted with [a] venereal disease,] having a sexually transmitted infection, such information as well as the application for diagnosis may be disclosed, at the discretion of the treating physician, physician assistant, or advanced practice registered nurse after consulting with the minor patient."

SECTION 5. Section 577A-4, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows:

"(a) If a minor consents to receive medical care and services, the spouse, parent, custodian, or guardian of the minor patient shall not be liable for the legal obligations resulting from the furnishing of medical care and services provided by the public and private hospital, public and private clinic or physician or physician assistant licensed to practice

medicine, or advanced practice registered nurse as defined in section 457-2.7. A minor who consents to the provision of medical care and services under this section shall assume financial responsibility for the costs of such medical care and services[-]; provided that a minor who consents to receive medical care and services related to the treatment or prevention of HIV pursuant to this section, shall not be liable for payment. Any other law to the contrary notwithstanding, no spouse, parent, custodian, or guardian whose consent has not been obtained or who has no prior knowledge that the minor has consented to the provision of such medical care and services shall be liable for the costs incurred by virtue of the minor's consent."

We ask the committee to adopt these amendments. Mahalo for the opportunity to testify on this important measure.

Hawai'i Health & Harm Reduction Center (HHHRC) <u>strongly supports</u> SB 25, which will increase access to HIV medical care for minors. HIV prevention and care have transformed over the past decade and it is essential that young people also have access to these emerging medical interventions so that they can either prevent acquiring HIV or if they are living with it, get the care they need to live well and not transmit the virus to others.

HHHRC's mission is to reduce harm, promote health, create wellness and fight stigma in Hawai'i and the Pacific. We focus our efforts on those disproportionately affected by social determinants of health, including but not limited to: people living with and/or affected by HIV, hepatitis, substance use, and the transgender, LGBQ and the Native Hawaiian communities. We foster health, wellness, and systemic change in Hawai'i and the Pacific through care services, advocacy, training, prevention, education, and capacity building.

HHHRC's roots are working with people living with and at-risk for HIV and has been at the forefront of "Hawai'i to Zero." <u>Hawai'i to Zero</u> is a coalition of members who are committed to getting to zero new HIV infections, zero HIV-related deaths, and zero stigma. SB 25 addresses all three components.

Specifically, HHHRC launched Hawai'i's first PrEP program which provides HIV antiviral to HIV negative people to prevent infection. HHHRC has had to turn away several young people who did not have parental consent for this important drug. This legislation is needed to help younger persons access this medication that can, with safer sex practices, prevent the transmission of HIV from their partners.

I write in **STRONG SUPPORT of** SB25, to ensure the ability of minors to consent and therefore have access to medical care for the treatment and prevention of HIV.

Ability to access such care is a crucial piece of HIV prevention. In my practice, I have seen many young adults with new HIV diagnoses that were entirely preventable from both better education and biomedical interventions such as PrEP (pre-exposure prophylaxis). In 2018, youth aged 13-24 years accounted for nearly one-quarter (21%) of new HIV diagnoses in the United States. Youth with HIV are the least likely of any age group to be retained in care and have a suppressed HIV viral load. The ability of youth to be able to consent for their own access to care around HIV prevention would be a key in preventing new HIV diagnoses. Confidentiality issues, including concerns that parents might find out, pose significant barriers and stigma among minors regarding STD (sexually transmitted disease) treatment and prevention (including HIV). Leichliter et al (2017) found that 22.6% of youth aged 15-17 reported that they would not seek STD services, because of confidentiality concerns.

In 2018, the FDA approved the use of a fixed dose combination tablet of tenofovir disoproxil fumarate (TDF)/emtricitabine (FTC) in adolescents to prevent HIV. In 2019, it expanded this approval to include tenofovir alafenamide (TAF)/emtricitabine (FTC) in adolescents meeting certain medical criteria and assessments. In brief, these medications have been approved with an efficacy of nearly 99% of preventing HIV transmission through sex and would be a powerful tool in preventing new HIV infections in our youth.

SB25 would address the current gap in the existing statute that does not permit a minor to consent to the potentially life-saving biomedical intervention of PrEP, and so I would strongly and humbly urge that you please **PASS SB25.**

Senate Committee on Health Friday, Feb. 12, 2021, 1:00 p.m. Via Videoconference SB25, Relating to the Medical Care for Minors



Dear Chair Keohokalole, Vice Chair Baker and Members of the Committee,

Thank you for this opportunity to provide testimony on SB 25, which permits minors to consent to medical care related to the diagnosis or treatment of HIV or the prevention of HIV.

#### Hawai'i Academy of Physician Assistants SUPPORTS SB 25 and requests an AMENDMENT.

The Hawai`i Academy of Physician Assistants supports SB 25 because it would ensure and promote access to care for this significantly vulnerable population of our state. Adolescents and young adults (aged 13-29) accounted for 41% of new HIV diagnoses in 2017.1 Those aged 13 to 24 accounted for 21%; roughly one in every five new diagnoses.2 Of these, 44% were unaware of their status. This age group is the least likely to test for HIV, receive HIV treatment or be virally suppressed, or be offered HIV prevention treatment. Data from 2012 to 2016 shows HIV diagnoses have either stabilized or fallen among the majority of adult population groups, however they increased by 6% among those aged 13 to 29.3

We support SB 25 because it would further enable and encourage minors age fourteen to seventeen to obtain such services without involvement of a parent or guardian.

We note that it appears the intent of SB25 is to clarify a "health care provider" as "an individual licensed, certified, or otherwise authorized or permitted by law to provide health care in the ordinary course of the individual's business or profession." This includes, physicians, osteopathic physicians, physician assistants (PAs), and advanced practice register nurses (APRNs). Hawai'i has already seen the benefit of allowing qualified licensed providers to perform a wide range of health care services, with both APRNs' and PAs' roles expanding dramatically in Hawai'i. Similarly, in 2019, the legislature recognized that PAs can safely and effectively perform their extensive duties with reduced supervision. PAs perform physical examinations, diagnose, and treat illnesses, order and interpret lab tests, perform medical procedures, assist in surgery, and enhance health care coordination. In Hawai'i, PAs practice in primary care and in every medical and surgical subspecialty. Both APRNs and PAs may function as Primary Care Providers (PCP), managing chronic conditions like hypertension and diabetes and provide gynecologic care and family planning services.

However, other parts of Section 577A limit the ability to treat these minors to a "physician licensed to practice medicine, or advanced practice registered nurse". Therefore, we request the committee consider the following amendments to include PAs where physicians and APRNs are already included:

SECTION 3. Section 577A-2, Hawaii Revised Statutes, is amended to read as follows:

"§577A-2 Consent valid. The consent to the provision of medical care and services by public and private hospitals or public and private clinics, or the performance of medical care and services by a physician or physician assistant licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, when executed by a female minor who is or professes to be pregnant, or by a minor who is or professes to be [afflicted with a venereal disease,] infected with, or to have been exposed to, a sexually transmitted infection, or a minor seeking family planning services shall be valid and binding as if the minor had achieved his or her majority as the case may be; that is, a female minor who is, or professes to be pregnant, or a minor who is, or professes to be [afflicted with a venereal disease,] infected with, or to have been exposed to, a sexually transmitted infection, or a minor seeking family planning services shall be deemed to have, and shall have the same legal capacity to act, and the same legal obligations with regard to the giving of such consent to such hospitals and such clinics or medical care and services to be provided by a physician or physician assistant licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, as a person of full legal age and capacity, the infancy of the minor and any contrary provisions of law notwithstanding, and such consent shall not be subject to later disaffirmance by reason of such minority; and the consent of no other person or persons (including, but not limited to a spouse, parent, custodian, or quardian) shall be necessary in order to authorize such hospitals or such clinics or medical care and services provided by a physician or physician assistant licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7, to such a minor."

SECTION 4. Section 577A-3, Hawaii Revised Statutes, is amended to read as follows:

"§577A-3 Providing information. Public and private hospitals, or public and private clinics or physicians or physician assistants licensed to practice medicine, or advanced practice registered nurses as defined in section 457-2.7 may, at the discretion of the treating physician, physician assistant, or advanced practice registered nurse, inform the spouse, parent, custodian, or guardian of any minor patient of the provision of medical care and services to the minor or disclose any information pertaining to such care and services after consulting with the minor patient to whom such medical care and services have been provided under this chapter.

If the minor patient is not diagnosed as being pregnant or [afflicted with [a] venereal disease,] having a sexually transmitted infection, such information as well as the application for diagnosis may be disclosed, at the discretion of the treating physician, physician assistant, or advanced practice registered nurse after consulting with the minor patient."

SECTION 5. Section 577A-4, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows:

"(a) If a minor consents to receive medical care and services, the spouse, parent, custodian, or guardian of the minor patient shall not be liable for the legal obligations resulting from the furnishing of medical care and services provided by the public and private hospital, public and private clinic or physician or physician assistant licensed to practice medicine, or advanced practice registered nurse as defined in section 457-2.7. A minor who consents to the provision of medical care and services under this section shall assume financial responsibility for the costs of such medical care and services[.]; provided that a minor who consents to receive medical care and services related to the treatment or prevention of HIV pursuant to this section, shall not be liable for payment. Any other law to the contrary notwithstanding, no spouse, parent, custodian, or guardian whose consent has not been obtained or who has no prior knowledge that the minor has consented to the provision of such medical care and services shall be liable for the costs incurred by virtue of the minor's consent."

We ask the committee to adopt these amendments. Thank you for the opportunity to testify on this important measure.
