#### TESTIMONY OF JAMES J. NAKATANI EXECUTIVE DIRECTOR AGRIBUSINESS DEVELOPMENT CORPORATION

> SENATE BILL NO. 335 RELATING TO AGRICULTURE

Chairperson Hashem and Members of the Committee:

The Agribusiness Development Corporation (ADC) appreciates the intent of Senate Bill No. 335, which requires the Department of Agriculture and ADC to annually lease at least fifty percent of land leased or up for lease renewal to operations whose primary business is local food production beginning January 1, 2022 and requires the Department of Agriculture and the ADC to submit reports to the legislature on leasing activities.

We share the Legislature's goal and objectives to increase local food production for our State. The ADC has made food production its highest priority when issuing land licenses to agricultural operators. Over a thousand acres of the Galbraith Agricultural Land and surrounding area on Oahu are licensed to small and medium farms growing food for the local consumer market.

Markets and demand tend to shift over time, and we need the ability to respond and adapt to these shifts. Emerging crops such as hemp, which has a wide range of uses, has significant potential due to its high-yielding, high agronomics, and environmental attributes. Other agricultural operations such as nurseries, flower and ornamental, and medicinal crops has potential to become major Hawaii exporters. We have concerns that this measure limits ourselves by regulating the size and type of crops that can be grown on State lands, which may have inadvertent effects to the agriculture industry down the road.

Farming, big or small, is like any other business and the bottom line is it needs to be economically feasible for the farmer to prosper and make a living for themselves and their family. Rather than regulating the landowner and imposing limits, perhaps a better way to encourage farmers to grow more food for local consumption is to find ways to incentivize growing food crops. We should also support the family owned and operated farms who are currently growing food for Hawaii's local consumers and exporting premium Hawaii grown products around the world. These multigenerational farms have made substantial investments to comply with all county, state, and federal laws and regulations and have the expertise and capability to achieve the economies of scale. In addition to the crops they grow and jobs they create, they also bring in and generate taxable revenue to our State.

Chairperson Hashem and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 335, SD2. This bill requires the Department of Agriculture ("Department") and Agribusiness Development Corporation ("ADC") to annually lease at least fifty per cent of land leased or up for lease renewal to operations whose primary business is local food production beginning 1/1/2022. It also requires the Department of Agriculture and Agribusiness Development Corporation to submit reports to the legislature on leasing activities, and requires ADC to implement the recommendations in State Auditor's Report No. 21-01. The Department respectfully opposes this bill.

Local farming is a difficult business due to the State's remote location leading to high input costs. The Department has consistently championed the growth of diversified agriculture by providing opportunities for affordable, long term leases and irrigation water. We recognize that in order for farmers to have the best chance of financial success, they must be able to rapidly pivot to the market. We also recognize that it is desirous to produce food to be consumed locally to the greatest extent possible. This measure, while encouraging food production, would severely limit the income of some

farms and hurt other diversified agricultural sectors such as nurseries, crops for export, agroforestry, and energy crop production. Additionally, this bill will negate the lease conversion provision which was widely supported by the agricultural industry in recognition of the broad benefits which allows a successful diversified agricultural operation to renew an existing lease with approval of the Board of Agriculture. This action allows successful entities to complete succession planning and reinvest capital into their operation.

We respectfully caution that not all of the department's lands are suitable for food production due to soil quality and slope of the land. For example, our Keahole Ag Park is a very successful ag park; however, due to challenging soil conditions such as lava tubes, has a high production of potted plants above ground. For its prime agricultural lands like Kunia Agricultural Park, the Department is strongly considering terms to prioritize food production.

Local produce prices, excluding specialty crops, are greatly influenced by imported crops. Often, in order for them to be competitive, the farmer will have to sell their crop for less, or at times generate no profit making the business a higher risk and unattractive. These restrictions would also affect the State and program's revenue as lease rent with such restrictions would be appraised lower than an unrestricted, diversified agricultural market value. The Department's land program's special funds run very close to break even on any given year. The reduction in revenue would need to be made up with general fund supplement.

Lastly, the Department currently maintains the authority to establish other terms and conditions it deems necessary on leases and ask that this flexibility be retained to fully utilized its agricultural lands.

The County of Hawai'i supports SB 335, SD 2, with comments. SB 335, SD 2 requires the Hawai'i Department of Agriculture and the Agribusiness Development Corporation to annually lease at least 50% of land leased or up for lease renewal to operations whose primary business is, or supports, local food production beginning 1/1/2022.

Aloha Chair Hashem, Vice Chair Perruso and Members of the Committee,

Hawai'i Alliance for Progressive Action (HAPA) supports SB 335 SD2, which requires the Hawai'i Department of Agriculture (DOA) and the Agribusiness Development Corporation (ADC) to annually lease at least 50% of land leased or up for lease renewal to operations whose primary business is local food production.

Requiring at least 50% local food production on Hawaii's agricultural (ADC) lands and annual reporting on ADC leases is an important and vital first step, which HAPA strongly supports.

# However, we believe that the Legislature should also put great consideration into deciding on if dissolving the agency altogether is a better option.

HAPA is a Hawaii-wide organization, but grows out of the movement on Kaua'i to advocate for fair and sustainable food systems. Starting around the beginning of 2013 a groundswell of community engagement arose when local residents became concerned about their exposure to pesticide drift from agrochemical tenants on both ADC lands and privately owned lands on Kaua'i's west side. A multi-year advocacy effort to provide basic public health protections from pesticide drift ensued. While the state auditor has highlighted many failings of the ADC<sup>[1,2,3]</sup>, our testimony is largely informed by concerns arising from the ADC's mismanagement of its vast west side Kaua'i landholdings.

#### Public Lands Should Serve the Public Good

Considering that ADC lands represent the largest swath of public (crown) agricultural land on Kaua'i, lawmakers should consider the highest and best use of those lands, for the public good.

As a "public-private corporation", in the name of bypassing "bureaucratic red tape" the legislature granted the ADC broad powers to buy, own, and develop public lands. In other words, a partly privatized entity has been granted significant control over "public" lands. Without a clear mandate as to how to serve its purpose, in practice the ADC has functioned to redistribute public lands and resources for narrow private gain through an entirely non-democratic process.

The ADC controls some of the most fertile agricultural lands on Kaua'i, equipped with irrigation and road infrastructure from sugar days. Rather than being made available to meet State goals of local food production, they have mostly been handed over to the largest agrochemical companies in the world for research facilities. This is a huge subsidy to already extremely wealthy corporations. In 2019, on the west side of Kaua'i the State's Public Land Trust Information lists a lease with Syngenta for 2,369 acres, with BASF for 977 acres, another with BASF for 10 acres, and one with Pioneer for 1,462 acres. These have transferred to Hartung Brothers, Becks, and Corteva, respectively.<sup>[4]</sup>

The lands leased to agrochemical tenants have been associated with heavy pesticide usage and toxic drift into adjacent communities<sup>[5]</sup>. The 2016 Joint Fact Finding Group report *Pesticide Use by Large Agribusinesses on Kaua'i* showed that agrochemical tenants in Kekaha directly adjacent to Hawaiian Homes purchased three times the national average of chlorpyrifos, a dangerous neurotoxin insecticide now banned by the State of Hawai'i and several other states.<sup>[6]</sup> The Hawaiian Homes development in Kekaha is approximately 100 feet from the ADC fields. Chlorpyrifos (which is now banned in Hawai'i) and other organophosphates (a certain class of insecticide) are known to drift up to a mile.

Additionally, small farmers and ranchers seeking ADC leases have been denied with little to no justification. It appears that the ADC has largely handed over management of its lands to a private association, the Kekaha Agricultural Association, whose leadership and membership is largely agrochemical / seed companies. According to the state audit: "ADC also owns two water systems and associated lands on Kaua'i, a total of 18,628 acres, which are operated and maintained by the Kekaha Agricultural Association, pursuant to an agreement." <sup>[1]</sup>

ADC's non-democratic process was also reflected in its handling of its Central O'ahu landholdings. Rather than work closely with the local community which had been caring for the long neglected former Dole lands in Whitmore Village the ADC issued 30 day eviction notices once it acquired the lands. The area had a history of criminal activity, so local residents had taken initiative to plant gardens and fruit trees and care for the area. The ADC ultimately bulldozed their backyard gardens.<sup>[7]</sup> Coverage of the incident in 2018 noted that the ADC acts with an "unusual lack of accountability," including failing to submit annual reports to the Legislature as required by law.

#### Mismanagement of ADC Lands and Water

ADC's lack of oversight and mismanagement has led to water hoarding and wasting in Kekaha, ultimately leading to a contested case at the Water Commission.

Beginning in the early 1900s, the Kekaha Sugar Plantation built the Kekaha and Kōke'e ditch systems, which diverted much of the water flowing down the Waimea River and its tributaries to grow sugar. When the plantation went out of business in 2001, the State of Hawai'i took over the ditch network. The ADC leased the ditch network and lands to the Kekaha Agriculture Association (KAA). But, although the association was cultivating only a fraction of the previous plantation land, and growing much less water-intensive

crops, the diversions remained at plantation-era levels, leaving vast stretches of dry stream bed in the Waimea River and headwater streams.

Proceedings before the Water Commission revealed that the association (KAA) was diverting far more water than was needed for agriculture and, instead, was using this public trust resource to feed an antiquated hydropower system that helped subsidize its operations. And much of the water was simply wasted."<sup>[8]</sup>

The ADC has facilitated agrochemical companies' exemption from compliance with Clean Water Act standards by extending a decades old sugar plantation permit to discharge toxic chemicals into the water. The exemption was recommended by the ADC because the Clean Water Act criteria would "likely be extremely difficult to meet" with more stringent federal limits for pesticide discharge now in force.<sup>[6, pg 46-47]</sup> If we want to put things in the language of costs, this is another subsidy granted by the ADC to some of the largest corporations in the world at the expense of public health.

In 2019 the ADC was ruled to have polluted waters of West Kaua'i without a permit since 2015 by a federal judge, violating a federal Clean Water Act<sup>[9]</sup>. The ruling stems from the ADC lacking a permit to drain polluted waters since it's permit expired in 2015. The water was found to contain the herbicide Glyphosate, which has been linked to cancer and 2 billion dollars in lawsuit winnings over the use of popular Glyphosate-based herbicide Roundup.<sup>[10,11]</sup>

#### Discrepancies in Reporting on Kaua'i ADC Landholdings

It is worth noting that there are discrepancies in the ADC's reportings on its landholdings on Kaua'i. In addition to concerns raised by the auditor regarding poor record keeping, this discrepancy in reporting (not included in the auditor's report) should also be cause for concern.

According to the ADC's 2018 report to the legislature, the agency reported to manage a total of 35,000 acres on Kaua'i - <u>28,000</u> acres of land in Kekaha, and 7,000 acres of former Lihue Plantation land (now referred to as Kalepa).<sup>[12]</sup>

Yet in the ADC's 2019 report to the legislature, the agency reported to manage a total of 19,000 acres on Kaua'i - <u>12,000</u> acres of land in Kekaha, and 7,000 acres of Kalepa lands. <sup>[12]</sup>

The state auditor's report states: "when Kekaha Sugar Company on Kaua'i shuttered, ADC became involved in the management of <u>12,500 acres of state agricultural land and</u> <u>related infrastructure, including the former Kekaha and Koke'e plantation irrigation</u> <u>systems</u>. After making a number of improvements and formally assuming management of the state land in 2003, ADC entered into an agreement with the Kekaha Agriculture Association, an agricultural cooperative, to operate and maintain common infrastructure. ADC also issued long-term land leases to several tenants." <sup>[1,page 9, footnote 5]</sup>

This lack of clarity raises concerns about what degree of oversight the agency actually has over its West Kaua'i landholdings.

#### Incentivize Regenerative Farming Practices on Public Lands

Public lands can and should serve as a resource for small scale regenerative agriculture solutions that can feed our communities and manage Hawai'i's agricultural lands for future abundance. However, the failures of the ADC have hindered Hawai'i's potential for a diversified and sustainable food economy.

Lawmakers should prioritize regenerative agroecology farming operations that utilize soil and water conservation practices and climate friendly approaches. Regenerative farming practices provide an array of environmental benefits: preventing run-off into nearshore fisheries and coral reefs, sequestering carbon in the soil while rebuilding soil health and capturing carbon through agroforestry approaches.<sup>[13, 14]</sup>

Additionally, lawmakers should further support the revitalization of native Hawaiian food systems. There are a plethora of successful grassroots efforts to restore Hawai'i's food security rooted in ancestral wisdom of how to feed our communities sustainably while managing natural resources for future abundance. Many of these projects are succeeding despite the lack of access to affordable leases and water and resources of the ADC.

COVID-19 has revealed the socio-ecological fragility of our current industrial-globalized food systems on a world wide scale and here in Hawai'i. The effects of the pandemic on farming and food supply chains raises concerns about widespread food shortages and price spikes. A transition to more socially just, ecologically resilient, localized food systems is therefore urgently needed and drastically increasing small scale food production agriculture is the solution.<sup>[14]</sup>

#### Work with Farmers and Food Systems Experts to Create a Plan

Several farmers and food systems experts we spoke to believe that an inclusive, stakeholder driven process is desperately needed to create a plan for the future of Hawai'i's agricultural lands and water systems. The ADC was tasked with creating a strategic plan 27 years ago. Today a well developed plan is still vitally needed to advance a comprehensive and sustainable approach for managing Hawaii's agricultural lands for future abundance.

Should the committee consider mandating such a process or task force please consider including regenerative/organic farmers, representatives from some of the many local organizations engaged in 'āina-based projects that incorporate restoration of native Hawaiian food systems, food production, community education and environmental stewardship.

One of the failings of the ADC is its narrow focus on supporting corporate agribusiness for export. Any future planning process, study or task force should incorporate a comprehensive food system wide analysis to identify opportunities along the food chain for local institutional procurement, regional aggregation and other efforts to make small scale regenerative farming solutions more viable. The committee should also consider adding a representative of an environmental organization and a regenerative/organic farmer to the board of the ADC. This will ensure that the agency has the internal knowledge and capacity to implement its mission.

HAPA strongly supports SB 335 and believes mandating at least 50% local food production on our agricultural lands is an important first step towards a more regenerative agricultural system for Hawai'i.

My name is Jeri Di Pietro, President of Hawai`i SEED. I live in Koloa on Kaua`i. I have been doing agriculturally related work for a longtime. We support SB335.

The ADC has failed to accomplish much of its mission within its 27-year existence. Our elected officials should seriously consider whether dissolving the agency is a better option for accomplishing this food security mission, providing jobs and agriculture to benefit the Islands in place of colonial, monocrop, synthetic chemical farming. The state audit recently revealed that throughout the entirety of its 27-year existence, the ADC has failed to accomplish much of its mission aside from acquiring large acres of land.

<u>The recent State audit</u> shows the ADC's management has failed miserably over the past nearly 30 years. Our finite ag land and water needs to be tightly controlled and the mandate to lease these state agricultural lands to farmers and ranchers who actually grow food for local consumption must be enforced and adhered to with impeccable integrity, without conflict of interest, favoritism, nepotism, personal financial gain or greed. While the ADC manages over 22,000 acres of state-owned agricultural land, the large fields of corn you see are mostly "seed corn" grown by agro/chemical companies, intended for export, and used to produce ethanol, cattle feed, and high fructose corn syrup. No one locally actually eats this seed corn. We believe that the Legislature should also put great consideration into deciding on if dissolving the agency altogether is a better option.

It is time that we seriously address our over dependence on imported food with tangible solutions such as this requirement to increase the state agricultural lands leased for local food production. This measure will help create opportunities for jobs in agriculture. SB 335 will allow more small-scale farmers to gain access to these agricultural lands, bringing us a step closer to a diversified food production economy.

Lawmakers should prioritize regenerative farming operations that utilize soil and water conservation practices. These farming practices provide additional environmental benefits such as improved soil health and preventing run-off. Requiring that 50% of Hawai'i's agricultural lands are utilized for local food production will help reduce our dependence on imported food. Senate Bill 335 SD2 Testifying in Support

Aloha Chair Hashem; Vice Chair Perruso; and Members of the House Committees Agriculture:

The Agriculture Committee of the State of Hawaii Democratic Party Environmental Caucus thanks the Agriculture Committee of the State House of Representatives for the opportunity to submit testimony on SB335 SD2. There will be no lack of consensus that the intent of this bill is desirable. All available energies should be devoted to the goal of food security and self-reliance for these islands. This bill is designed in support of that goal.

However, the following observations suggest caution in pursuit of that goal as pertains to this proposal. The heart of the bill is in amendment to HRS Section 163D-15.6 (c). This amendment requires the Department of Agriculture to annually lease or license at least 50% of lands eligible for lease or license to persons or entities engaged in food production, of which at least 50% will be for local consumption in these islands.

The intent would be that farmers and ranchers would find access to available land opportunities. The concern reflected in this testimony is that due to the challenges facing the Agribusiness Development Corporation in affording and distributing these leases over a designated time frame (50% of the eligible lands must be leased within the first year) the outcome of this process will be heavily weighted toward assignment of these leasehold lands almost exclusively to ranching and grazing operators with little service to the intent of promoting diversified agriculture and support of the small or family or commercial farmer. Fifty percent of the available lands, which are currently 15,000 acres of suitable lands controlled by the ADC, would amount to the necessity of leasing at least 7,000 acres in the initial year following enactment. The ADC, the leasing entity, currently with 5 employees, would be confronted with the challenge of lands subdivision, assessment of credibility and lease assignment to applicants, management responsibilities, and creation of infrastructure appropriate to the new leaseholders. The scenario which would likely emerge is that several, (let's imagine seven) applications for lands for ranching would be submitted, and hundreds (lets imagine seven hundred) applications for lands for small or family farms would be submitted. The cattlemen's request is for a thousand acres and the farmer's request is for ten acres (perhaps the commercial farmers would request 50 acres). In spite of the ADC's desire to support diversified agriculture, it is highly likely that the outcome of this will assign almost all of these lands to ranching operations, diverging from the intent of this bill. One positive outcome might be that whereas currently most of Hawaii's cattle are sent to the mainland for 'finishing', the stipulations in this bill of 50% local consumption of production would demand local finishing of a greater proportion of

Hawaii's cattle. However, if all of Hawaii's current cattle production were finished here there would be more than enough beef produced such that imports would not be necessary. Hence, my concern is that this likely distribution of these lands to the ranchers is taking away the opportunity from the farmers and plant-based agriculture which is what Hawaii's food sovereignty demands.

Even if the operations of the ADC are subsumed by the Department of Agriculture in carrying out the subdivision and lease assignments and creation of infrastructure it is highly likely that the initial year's requirements and time constraints will obligate most of these lands to ranching. Hawaii has plenty of ranch lands now. What Hawaii lacks is farmers doing commercial plant-based farming.

A second concern regarding distributing these lands for ranching was voiced in a presentation to the Hawaii County Council by Climate Scientist Charles Fletcher PhD from UH SOEST describing the immense challenges we will soon be facing due to climate change. He presented the following facts: 1) Agriculture is responsible for 31% of all Greenhouse Gas emissions. 2) Producing beef generates 100x more GHG emissions than plant-based agriculture. 3) Over 80% of farmland is used for livestock but it produces just 18% of food calories and 37% of protein. 4) Cattle + grain they eat use one-third of available land surface on this planet. 5) 16% of all available fresh water. 6) 1/3 of worldwide grain production. 7) We are deforesting the planet at a rate of 30 football fields per minute, largely to raise cattle and the grain to feed them.

Consequently, a mechanism needs to be designed and inserted into this bill which will withhold the large proportion of these lands which may be coming available for lease from the ADC and Department of Agriculture, for the development of small & family farming and plant-based commercial agriculture as food production for these islands. This may necessitate removing the requirement of leasing 50% of these eligible lands in the first year in addition to prioritizing the dedication to plant-based agriculture. The demand for infrastructure to accomplish this may require major investment and organization among the farming stakeholders. But the realization of those requirements must be designed before this bill would be adopted.

This bill reflects the consensus intent of government and legislature and the people of Hawaii to develop agricultural self-sufficiency. However, we are in danger of throwing away the opportunity provided by these lands designated in this bill if our design is not considered very carefully from the outset.

#### Position: Strong Support

Me ke Aloha, Chair Mark Hashem, Vice-Chair Amy Perruso, and Members of the Agriculture Committee:

The Energy and Climate Action Committee of the Environmental Caucus supports this bill as a means to prepare our house for climate change.

The most recent (6th) UN/IPCC Synthesis Report (February 26, 2021) leading into November's international talks in Glasgow indicate that despite fine words and pledges, the Paris Agreement has accomplished virtually nothing to date. It raises a double warning: 1) climate change is happening sooner than we anticipated and is accelerating due to feedback loops kicking in; and 2) the pledges that nations have made in the Paris Agreements are not being followed.

The Committee recognizes the multiple problems that need to be overcome in raising the capacity for feeding ourselves as catastrophic change descends upon much of the world and its business-as-usual. We also share some of the criticism of the Agribusiness Development Corporation. But we also cannot help but applaud ADC for securing formerly private lands and irrigation systems for the State priority of maintaining the capacity to use excellent farming lands and valuable water conveyance systems in place of Hawaiian lands now used for residential and commercial use and even for military activities. Having these productive lands at our disposal allows us to work on the other barriers to successful food production for local tables.

Senate Bill 335 sets a relatively high bar for use of these lands for local food production, but its challenge provides a proper focus for a number of solutions that must be tried. We suspect that the challenge will illuminate other problems that our current system of governance has not yet learned to face.

A critical element of our support lies in the understanding that proper land stewardship involves regenerative soil practices that significantly reverse greenhouse gas emissions with sequestration. Old-fashioned "green revolution" cultivation practices using chemical fertilizers and pesticides actually deplete the soil, kill its restorative microfauna and flora, and cause greenhouse gas emissions from open fields, increasing siltation and contamination downsteam. Food agriculture using regenerative practices builds soil quality, and reinforces the proliferation of positive microfauna and flora, absorbing greenhouse gases. While there are regenerative pasturage practices, they are not as productive as complex food agriculture.

One of the issues facing us in recovering from the pandemic is rethinking how we can produce food locally for local tables, and therefore this legislation provides an important laboratory for finding our way home.

Aloha,

We support SB335 because it includes the requirement that the ADC lease 50% of its land eligible for lease to agricultural operations whose primary business is growing food or crops for local consumption.

However, I have deep reservations about how this bill preserves the ADC and its current leadership. The recent audit and the report by UHERO have both shown the ADC to be mismanaged and ineffective at achieving its mission. In addition to the reporting requirements given to the ADC by this bill, I wish that there was also a requirement that the ADC undergo a financial audit.

This bill *does* make a huge stride in requiring that more land be used to grow food for local consumption. In his testimony on HB1271 James Nakatani, Executive Director of the ADC, states that the ADC under his leadership has leased 2,000 acres of former plantation lands to growers producing food for local consumption. And, in his previous testimony on this bill (SB335) Nakatani cites the ~1,700 acre license of the Galbraith Estate lands as evidence of the ADC's commitment to leasing lands to local growers for local consumption. It's unclear, but I'm assuming that this 2,000 acre figure is inclusive of the ~1,700 acre Galbraith lands.

The ADC controls 22,887 acres of land statewide. The ADC's lease of the Galbraith lands undoubtedly supports the local agriculture efforts of the Whitmore Project. While this is a step taken by the ADC in supporting a plan in one community for development around local agriculture--it is only ~7% of its lands and represents one action in a 25+ year history of managing public lands and shaping Hawai'i agriculture. The ADC has leased far more land to GMO seed companies.



SB335's mandate that 50% of ADC acreage be put to producing food for local consumption would open up access to people who want to farm; it could benefit other communities in the state that may also want to pursue economic development around sustainable agriculture while achieving greater access to fresh, healthy food under normal conditions as well as during emergencies.

This vast improvement in making more land available for local production for local consumption needs to be accompanied by a fundamental shift in the vision for post-plantation agriculture in Hawai'i. It is worrying to me that in the ADC's previous testimony on SB335, all hopes are put on the local, small/family farmers that can "achieve the economy of scale." Nakatani also worries that the 50% mandate will make the ADC inflexible to shifting markets and demand over time.

This industrial approach to local agriculture, which emphasizes farming as primarily a business endeavor, is out of step with the needs of our historic moment, as we face immense challenges like climate change, ecosystem deterioration, economic inequality, health disparities, and increasing severe weather and natural disaster. While undoubtedly business and market considerations are important to the success of local farmers today (and small/local farmers do undoubtedly deserve our support and incentives) agriculture can no longer be looked at as purely a business proposition because how and what we grow has profound implications on the health of ecosystems, waterways & aquifers, and human communities.

We are also witnessing exciting opportunities that should not be ignored, namely the growth and increasing currency of Hawaiian cultural values, practices, and political ethics of aloha 'āina and mālama 'āina. People want to live in accordance with their culture, and they want to grow food. We see this at the grassroots and in the success of innovative social impact organizations in the agriculture and food space—MA'O Farms being the most celebrated but not the only example—that are not only producing food but becoming more sophisticated operations and scaling their efforts. What MA'O and others are doing is putting to work Hawai'i's intellectual capital, backed by science, about how organic, regenerative, natural, and Hawaiian traditional farming practices (as well as Hawaiian land/ocean management practices) can improve soil and ecosystem health, thereby sequestering carbon out of the atmosphere and into the soil, and also



ensuring watershed health--all while providing culturally coherent and dignified livelihoods and lifestyles.

We need an open and inclusive planning process for Hawai'i agriculture that takes into account the perspectives and needs of those leading this new vision of a biocultural agrifood system as well as all stakeholders--including Native Hawaiian farmers; communities near agricultural lands; organic, regenerative, and natural farmers; small farmers; farm workers; food insecure communities; as well as local food systems and policy experts.

First of all, I would like to thank you for the opportunity to testify in support of SB335, generally. The failures of the ADC have become a pervasive matter in the state and now more than ever, we need systemic change to address these issues. The recent COVID pandemic have exacerbated a fragile food system in Hawaii, and this started off with the hoarding of toilet paper, rice, and canned foods. While grocery store workers have been considered "essential" in their duties, I know of farmers in the state that were not. SB335 is a good way to begin to address the shortcomings of agricultural land mismanagement, with an emphasis on utilizing 50% to those farms/businesses whose primary goal is local food production. Although some argument exists in the fertility of some land parcels, there were many ways that the ancestors of Hawaii were able to grow kalo in lava fields (*kipuka*). This is the type of innovation that occurs as a result of necessity, without externalities. Furthermore, there are ways to improve soil fertility in ecologically sound ways that do not require lots of capital, just mana'o and opportunity. I do agree, however, that the ADC must be monitored more closely as a result of its failures. A biannual board review should be implemented with relative information on land/parcel activity and any/all accompanying economic figures. I would like to call for the resignation of the current executive board member as a punitive response to the accompanying negligence of the ADC audit findings. After all, in a real emergency, we cannot sustain life by eating money or electricity.

My name is Brian "loane" Jahn, I live in Wahiawā with my pops and my three keiki, and I am writing to express my support for SB335. This is a difficult testimony to write because I do not have much faith in the ADC, due to records of mismanagement and falling short of simple goals. However, since it does not appear that the ADC will be dismantled at this time, I would like to see at least 50% of 'āina leased to local farmers with the hope of increasing overall production within our islands.

The increase and stabilization of local food production will create a cascade of positive effects to benefit Hawai'i, along with the rest of the planet. Reduction of dependence upon outside sources for food will increase food security overall, lower carbon emissions related to shipping on a large scale, reduce ocean pollution related to shipping, eliminate unnecessary packaging that results in excess waste, create safer access to food that does not require chemical treatment for importation, facilitate more local jobs which contribute to local economy enhancement and keep local families in Hawai'i, and provide greater possibilities for communities to interact and build relationships with their local food system.

Priority should be given to smallholders who utilize conservation-based production methods, such as cover-crop rotations, low-till or no-till soil enhancement/soil conservation practices, responsible water management techniques, and the incorporation of traditional weed and pest mitigation strategies that create symbiotic relationships within 'āina.

There is a very real issue occurring here that highlights the lack of professional authority on matters that require systematic, long-term management strategies. There should be a panel of subject matter experts appointed to oversee these transactions within the ADC to ensure the biological, cultural, social, and economic needs of Hawai'i are being considered throughout all land management operations; 'āina is sacred and should be treated as such. These experts should collectively possess a comprehensive knowledge-set that ranges from understanding Hawai'i's specific socio-political needs, conventional farming's role as a key contributor to anthropogenic climate change, and an awareness of ongoing agricultural interventions and solutions to global climate change being introduced and implemented throughout the world; we are one piece of a larger picture that undoubtedly have significant connections, both seen and unseen.

My 'ohana and I strongly support SB 335 SD1, however we are concerned that the measure does not go nearly far enough. I am in strong support of the dissolution of the ADC all together to start a clean slate and an agency that is designed from the start with the right goals and accountability.

Requiring at least 50% local food production on Hawaii's agricultural (ADC) lands and annual reporting on ADC leases is an important and vital first step but doesnt go nearly far enough.

This partly privatized entity has been granted way too much control over public agricultural lands. ADC's non-democratic process has seen small farmers and ranchers seeking ADC leases denied with little to no justification.

The lands leased to agrochemical tenants have been associated with heavy pesticide usage and toxic drift into adjacent communities. The ADC has been assocaited with poor land management, and toxic industrialized agriculture rather than food produing regenerative farming and its costs our communities and environment far too much.

ADC's lack of oversight and mismanagement has led to water hoarding and wasting in Kekaha, leading to a contested case. Proceedings before the Water Commission revealed that the association (KAA) was diverting far more water than was needed for agriculture and, instead, was using this public trust resource to feed an antiquated hydropower system that helped subsidize its operations. And much of the water was simply wasted.

The ADC has facilitated agrochemical companies' exemption from compliance with Clean Water Act standards by extending a decades old sugar plantation permit to discharge toxic chemicals into the water. In 2019 the ADC was ruled to have polluted waters of West Kaua'i without a permit since 2015 by a federal judge, violating a federal Clean Water Act. Enough is enough. Please dissolve, radically reform and create a functional agency that serves the people, the land and the mission of transforming agriculture to regenerative food production.

I would like to offer the following amendment:

"Until at least 75% of the cattle raised in Hawaii are 'finished' in Hawaii, rather than being shipped to the mainland for 'finishing', and sold for food production in Hawaii, the lease of all of the lands eligible for lease by the ADC and Department of Agriculture shall be to persons and entities engaged in plant based agriculture for use as food in Hawaii."

Currently about 35,000 out of the annual cattle production of 45,000 head in the State of Hawaii are shipped to the mainland for 'finishing'. It is contrary to the intent of this bill to make further leases of State land for the purpose of cattle grazing until this exit of our food source out of the State is reversed. The overwhelming portion of beef sold in Hawaii is imported from the mainland. If all cattle raised in Hawaii were 'finished' here most of our State's beef requirements would be met. We should not lease more land for cattle grazing until the State's requirements cannot be met by the cattle raised here. This should be the case even if the cost of beef is somewhat higher.

There is currently not enough land devoted to plant based agriculture for production of Hawaii's food. This is what needs to be rectified, not more land devoted to raising cattle.

If the above amendment is not stipulated in this bill, it will certainly be the case that the Agribusiness Development Corporation will lease most all of these lands for cattle ranching. Leasing these lands to a few ranching operations would be far easier and require far less capital for infrastructure creation than leasing to a few hundred family or commercial farming operations.
