Testimony in OPPOSITION to SB0350 RELATING TO THE ENVIRONMENT

SENATOR MIKE GABBARD, CHAIR SENATE COMMITTEE ON AGRICULTURE AND ENVIRONMENT

Fiscal Implications: Adding monitoring activities during Brown Water Advisories would 1 require additional resources (i.e., more staff time, additional sampling materials, increase 2 laboratory costs, etc.). Collecting samples during brown water conditions may also pose a 3 4 hardship and safety concern to staff traveling during inclement weather to monitor and/or post signs on the affected beaches. The additional resources necessary to monitor and to post signs 5 6 are of significant concern, since the Department of Health (Department) relies heavily on federal funds (approximately \$310,000 per year) to conduct the beach monitoring and notification 7 8 program. The allotted federal funds cannot accommodate additional statewide laboratory analytical testing. The allotted federal funds would also not accommodate the signs and the costs 9 10 for the needed sign posts. This measure will impact the priorities identified in the Governor's Executive Budget Request for the Department's appropriations and personnel priorities. 11 **Department Testimony:** The Department acknowledges the intent of this measure, but 12 respectfully opposes it and submits the following comments. 13

<u>Environmental Management Division Chief.</u> Section 1(a)(1) of the bill requires the
 Department to fill the vacant environmental management division chief position by October 1,
 2021. The Department already anticipates that this position will be filled well before October 1,
 2021.

The Department received Governor's approval to fill this position on December 24, 2020, and recruitment has resumed from the point where it was halted due to the hiring freeze. An applicant had been recommended from the interviews conducted and the program is currently completing the required paperwork to make a conditional offer to the selected applicant. The Governor's biennium budget includes a tradeoff/transfer request to fund the positon salary, since that was reduced to \$0 by Act 9, SLH 2020.

<u>Testing During Brown Water Advisories.</u> Section 1(a)(2) of the bill requires the Clean
 Water Branch (CWB) to perform water quality testing during brown water advisories as part of
 its Hawaii beach monitoring program. This includes testing water samples from affected Tier 1
 beaches during advisories, but does not require the CWB personnel to collect water samples until
 hazardous conditions have subsided. The Department believes that water quality testing during
 brown water advisories, which would be in addition to testing already performed on a regular
 basis, is unnecessary.

As part of the Beaches Environmental Assessment and Coastal Health Act of 2000
(BEACH Act) monitoring program, the CWB routinely monitors Hawaii's beaches for
enterococci, which encompasses sample collection, field measurements, and field observations.
Tier 1 beaches, which are the most heavily utilized beaches, are monitored on a weekly basis.
The BEACH Act also requires states to monitor coastal recreational waters and provide prompt
notification to the public whenever there is an exceedance or likelihood of exceedance of
recreational water quality standards.

If the CWB detects levels of enterococci that may pose a risk to human health, it notifies the public and provides specific actions to take to protect health. These notifications include issuing brown water advisories. In the case of brown water, data collected by CWB and several scientific studies already show that waters impacted by surface runoff (the cause of brown water) almost always show increased levels of enterococci. Testing during a brown water advisory is unlikely to provide more actionable data on enterococci.

As part of the BEACH Act, the EPA made funding available to states in the form of 1 grants to help implement coastal recreational water monitoring and public notification programs. 2 The Department is a recipient and relies heavily on this grant (approximately \$310,000 per year) 3 to conduct the beach monitoring and notification program. Adding monitoring activities during 4 brown water advisories would require additional resources (i.e., more staff time, additional 5 6 sampling materials, increased lab costs, etc.). The allotted federal funds cannot accommodate the additional statewide laboratory analytical testing that would be required under this bill. 7 Neither would the allotted federal funds to be able to accommodate the signs and sign posts that 8 9 would be needed.

10 <u>Health Advisories During Brown Water Advisories.</u> Section 1(a)(3) of the bill requires 11 the Department to issue health advisories during brown water advisories that explain the health 12 risks associated with water runoff, including, but not limited to, informational signs posted 13 during these advisories at affected Tier 1 beaches. As discussed above, the CWB already 14 provides public notification and risk communication on beach water quality when human health 15 may be at risk and posts signs as warranted.

The CWB's public notification and risk communication was developed after extensive 16 17 stakeholder outreach and includes postings of beach advisory signs at beach parking lots, entrances, or points of access when there is indication of potential exposure to sewage or toxic 18 pollutants from water contact. Other forms of risk communication include posting advisories on 19 the CWB Water Quality Notification and Advisories website at: https://eha-20 cloud.doh.hawaii.gov/cwb#!/landing and through informational placards disseminated to 21 22 lifeguards, hotel personnel, volunteers, and CWB staff to help explain the beach advisory signs to beach users. Other means of notifying the public of beach water quality (including brown 23 24 water advisories) include email advisories sent to the general public (subscribers), officials from 25 each county, various state and federal offices, local news media outlets, county lifeguards, visitor 26 industry representatives, community partners, and other organizations and interested parties.

Brown water can affect all beaches in the State. It will not be feasible to post informational signs at all beaches impacted by brown water, especially on the neighbor islands where there is only one CWB staff member to cover the entire island. Also, as brown water advisories are often issued during heavy or severe storm conditions, it is unsafe to have CWB staff traveling and posting signs in coastal areas at such times. Even if posting signs is limited to Tier 1 beaches, that may send the wrong message to beach users recreating at non-Tier 1 beaches.

Determing and Ranking Beaches. Section 1(a)(4) of the bill requires the Department, 8 9 when considering usage and public health risk for its determination and ranking of beaches for 10 inclusion in Hawaii's beach monitoring program, to take into consideration environmental justice issues in the assessment of use. In developing its tier system, the CWB evaluated the usage level 11 12 of the various beaches, as well as the availability of facilities such as restrooms and showers, the presence of staffed lifeguard stations, and accessibility. Currently, Tier 1 beaches represent the 13 most heavily used beaches on each island. The rationale for this decision was to protect as many 14 beach users as possible. CWB resource limitations necessitated a limit to the number of Tier 1 15 beaches established on each island. 16

EMD Oversight Advisory Board. Section 1(a)(5) of the bill establishes of an oversight advisory board to provide oversight and guidance to the EMD. It is not clear what the purpose and scope of an EMD oversight advisory board will be. The EMD covers all the Clean Water Act, Safe Drinking Water Act, Clean Air Act, and the Resource Conservation and Recovery Act programs in the state. It seems infeasible to assemble an advisory board that can adequately and knowledgeably oversee and provide guidance on all the programs under the EMD.

<u>LRB Comprehensive Review.</u> Section 2(a) of the proposed bill requires the Legislative
 Reference Bureau (LRB) to conduct a comprehensive review of the EMD with a focus on the
 EMD's CWB and Wastewater Branch (WWB). An independent review and report by LRB is
 repetitive and unnecessary.

In 2018, the CWB completed an extensive internal operational review conducted by the
EPA's contractor, Blue Earth Consultants, a Division of ERG. Their report, the "Hawaii
Department of Health Clean Water Branch Program Evaluation, Final Report" was completed on
June 29, 2018. Preparing the report cost the Department over \$200,000, which represents a
significant amount of EPA grant funds. The Department realizes that improvements can and
should be made to managing the Clean Water Act programs. That was one of the reasons for
having the Blue Earth report completed.

Also, it is not clear what the purpose and scope of LRB's comprehensive review of the 8 9 EMD will be, since the EMD's CWB and WWB have very large and broad program 10 responsibilities (which include the National Pollutant Discharge Elimination System (NPDES) permitting, water quality standards, surface water monitoring and assessment, Total Maximum 11 12 Daily Loads, BEACH Act monitoring and notification, NPDES enforcement and compliance, non-point source management, state revolving funds management for water pollution control 13 projects, management and regulatory oversight of individual wastewater systems, onsite 14 wastewater and reuse treatment facilities, water reuse, and wastewater sludge reuse programs). 15

I am Charlotte Carter-Yamauchi, Director of the Legislative Reference Bureau (LRB). Thank you for this opportunity to provide written **comments** on S.B. No. 350, Relating to the Environment.

The purpose of this measure is to:

- (1) Require the Department of Health to fill the vacant division chief staff position within the Environmental Management Division by 10/1/2021 and consider environmental justice issues when making certain assessments and determinations;
- (2) Require the Department of Health's the Clean Water Branch to perform water quality testing during brown water advisories, inform the public of health risks associated with water runoff during brown water advisories, and establish an Environmental Management Division Oversight Advisory Board; and
- (3) Require the Legislative Reference Bureau to conduct a comprehensive review of the Environmental Management Division.

The Bureau takes no position on this measure but submits the following comments for your consideration.

Page 2

With regard to requiring the Legislative Reference Bureau to conduct a comprehensive review of the Environmental Management Division, we note that the Bureau has no specific expertise or particular experience in matters relating to environmental management or how to conduct what seems to be a performance evaluation of an executive department program. Historically, executive agency performance evaluations have fallen under the purview of the Auditor. Furthermore, as currently drafted, it is unclear what is to be achieved under a "comprehensive review of the Environmental Management Division" since no parameters are provided under which to frame the scope of the review.

Not sampling after these heavy rains and storms is not only misleading but irresponsible. It is irresponsible to our citizens, visitors, and ourselves to disguise the true quality of Hawai'i's water. This bill also aims to "inform the public of health risks associated with water runoff during brown water advisories". Aloha Chair Gabbard, Vice Chair Nishihara, and members of the AEN Committee,

The Surfrider Foundation would like to offer this testimony in support of SB 350. In addition, and attached to our testimony, is a sign-on letter from **21 local organizations** urging your support of this bill.

The Surfrider Foundation is a national nonprofit organization dedicated to the protection and enjoyment of our ocean, waves, and beaches. Surfrider maintains a network of over 150 chapters and academic clubs nationwide, including 5 chapters in the Hawaiian Islands. One of Surfrider's five primary initiatives is the protection of clean water, and we work at the local, state and federal level to ensure adequate monitoring programs are in place to protect public health in recreational waters across the country.

We support a robust citizen science program called the Blue Water Task Force (BWTF) that is providing valuable water quality information to coastal communities so people know where it is safe to get into the water. We currently have over 50 BWTF labs established in coastal states across the country, including three water testing programs in Hawaii: Oahu, Maui, and Kauai. Through the Blue Water Task Force program, Surfrider volunteers are testing marine beaches and estuarine and freshwater outflows onto beaches for enterococcus fecal indicator bacteria, and sharing their results with local agencies, decisionmakers and the general public.

In Hawaii, we have worked extensively with the Hawaii Dept. of Health (DOH) and their Clean Water Branch (CWB) to support robust water testing and public notification programs so the beach-going public has the information they need to make decisions on where it is safe to surf, swim and play at the beach in Hawaii.

SB 350 directs the Department of Health to make changes to the Clean Water Branch's (CWB) beach water quality and public notification program to better assess the threats to public health in Hawaii's recreational waters and to take further steps to communicate these risks to the public, so people can make informed decisions on where and when it is safe for them or their families to get into the water. The bill also recommends more oversight and guidance be provided to the Environmental Management Division for better implementation of their clean water permitting, monitoring and research programs.

Continued Monitoring During Brown Water Advisories

Currently the CWB suspends all testing activity when Brown Water Advisories are issued. No samples are collected from any of the affected beaches, not even Tier 1 beaches, until the BWAs are lifted as a result of visual inspections. The problems with this approach are multi-faceted:

- There is virtually no data to really describe the pollution levels and health risks during Brown Water Advisory (i.e. "wet") conditions. Because the overall dataset is biased, the public is less informed of risks during pollution associated with Brown Water Advisories. In some cases, the bacteria levels could be extremely high and dangerous, and the public should be aware of that risk.
- 2. Data from Surfrider Foundation's Blue Water Task Force monitoring clearly demonstrates that many locations have elevated levels of fecal indicator bacteria after rain events and in brown water events. Without testing during brown water events, it is unknown which locations monitored by the Department of Health experience pollution spikes during heavy rains. As noted above, this gap in knowledge puts ocean users at risk and delays the identification and enactment of needed pollution mitigation efforts.
- 3. By never testing during BWAs, cumulative water quality statistics communicated by the CWB beach monitoring program do not give an accurate picture of water quality conditions at many of Hawaii's beaches, and certainly not during wet weather conditions when public health is most likely to be threatened. EPA Region 9 has likewise recommended to the CWB, *"Establishing a protocol to test in Brown Water Advisories would provide much better and accurate data in regards to the water quality."*
- 4. In addition to providing better information to describe the health risk, testing during Brown Water Advisories could also allow the CWB to lift those advisories more quickly when testing results show bacteria levels dropping to safe conditions. This would minimize the disruption to people's enjoyment of Hawaii's beautiful beaches and coastal environment. Tourism and water sports activity companies are severely impacted when BWAs are issued as they cannot operate due to liability issues. The CWB must do more to monitor pollution levels during wet weather conditions and to lift BWAs sooner when water quality conditions return to normal.

Public Advisory Signs Posted at Beaches During Brown Water Advisories

Likewise, physical signs posted at the beach during BWAs would provide better notification to beach goers as they are stepping onto the beach that water quality conditions are likely affected by Brown Water conditions, allowing families with young children and people with compromised immune systems to take precautions from becoming sick.

While local residents and those who use Hawaii's beaches frequently may be aware of the BWAs that HDOH issues online and shares via email and radio/TV in some cases, there are many tourists and visitors who have no idea that Advisories have been issued and Brown Water could be affecting water quality conditions. Signs posted at popular Tier 1 beaches, would help provide better warning to visitors and those unfamiliar with HDOH's online advisories, and should not require any more staff time or logistical problems than it does to post temporary advisory signs for high bacteria readings. Surfrider feels confident that the Clean Water Branch

could work out a system with beach managers or property owners of Tier 1 beaches to develop a reasonable plan to make this work.

Continued Monitoring During Brown Water Advisories

Surfrider Foundation also supports the inclusion of environmental justice considerations in the prioritization of beaches for testing. The current ranking system identifies beaches that are heavily used, but this results in overlooking many areas that are important to local communities for fishing, gathering food, recreation, and cultural practices. Many coastal waters that are used primarily by native Hawaiian communities and local people are in areas with high cesspool density and/or low coastal circulation, such as Kahalu'u on O'ahu. The Department of Health has a responsibility to the public health of our island communities, and therefore the Surfrider Foundation supports updating the beach prioritization scheme to shift prioritization from beaches that consistently test as clean (and well below the health standard) to higher risk areas where local communities fish, work, and recreate.

Oversight of Environmental Management Division

The Surfrider Foundation also supports the provision of SB 350 that requires HDOH to fill the vacant Environmental Management Division (EMD) Chief Staff position. This position has remained unfilled since Stuart Yamada left HDOH employment over 2 years ago, and should be filled as soon as possible for optimal oversight and implementation of the various Division programs.

We also agree that an oversight advisory board should be created to provide oversight and guidance to the Environmental Management Division (EMD). A similar board was active in the past, but it has been over 10 years since this board has been convened. This board could provide much needed guidance to the EMD and Clean Water Branch to ensure that a responsible balance of scientific integrity, public health protection and due diligence are applied to all the clean water permitting and monitoring programs that they run, as well as any special research or pollution investigations that they undertake.

Thank you for your consideration of this testimony in support of SB 350, submitted on the behalf of the Surfrider Foundation's 4 Chapters in Hawaii and all of our members who live in the state and visit to enjoy the many coastal recreational opportunities offered by all of the islands' coastlines.

We, the **21 undersigned organizations**, write to express our support for SB 350 directed towards improving the Department of Health Clean Water Branch's statewide beach water quality monitoring and public notification program.

The ocean is a vital part of our communities in Hawai⁴i. From recreation and putting food on our tables to cultural and traditional practices, our way of life depends on clean coastal waters. Unfortunately, statewide water quality monitoring at beaches in Hawai⁴i currently lags other states, favors beaches predominately visited by tourists, and lacks data collection during wet weather.

SB 350 is a critical step towards improving water quality monitoring in coastal recreational waters in Hawai'i and will achieve the following:

- Account for environmental justice when DOH is evaluating its beach tiering system.
- Ensure that water quality sampling adequately covers popular local beaches and is not biased towards tourist-dominated beaches.
- Improve public notification of health hazards during Brown Water Advisories by requiring the DOH to post signs at affected Tier 1 beaches and to continue their testing program during Brown Water Advisories. Currently, the Clean Water Branch suspends all testing when Brown Water Advisories are issued, leaving us with an incomplete assessment of coastal water quality conditions across the state.
- Provide for more oversight and guidance to the Environmental Management Division for better implementation of their clean water permitting, monitoring and research programs, including the hiring of a Chief of Staff position that has been vacant for over two years.

We believe that it is a public right to ensure that our beaches and coastal waters are clean and free from pollution. Our local keiki, kupuna, 'ohana, and visitors should furthermore be able to enjoy surfing, swimming and recreating in the ocean safely. We appreciate your support of SB 350 and the improvements to beach water quality monitoring that will protect the public health of all our communities.

Enacting these measures would reduce the current biases in the water quality data collected by the department of health, provide the public with better information about ocean pollution risks, improve the Department of Health's water quality program in meeting the needs of local communities and native Hawaiians, and will allow for better management and decision with leadership and accurate data.

The current water quality data collected by the Department of Health are skewed towards dry conditions by avoiding sampling during brown water events. This means that the overall dataset is biased and that the public is less informed of risks during pollution associated with brown water events. Surfrider Foundation's Blue Water Task Force (BWTF) program tests coastal water across Hawaii, with active programs on Oahu, Kauai, Maui, and Big Island. BWTF uses the same methods as the Department of Health to test water samples for evidence of sewage contamination, but does not suspend testing during brown water events. From our data it is clear that many locations have elevated levels of fecal indicator bacteria after rain events and in brown water events (Figure 1). Without testing during brown water events, it is unknown which locations monitored by the Department of Health experience pollution spikes during heavy rains. This gap in knowledge puts ocean users at risk and delays the identification and enactment of needed pollution mitigation efforts.



Figure 1. Mean concentrations (colony forming units / 100 ml seawater) of the fecal indicator bacteria *Enterococcus spp.* at 8 sites in Maunalua Bay, Oahu. Orange bars show counts during dry weather, and blue bars show counts when there was rain within the past 3 days. The beach closure limit is 130 CFU/100ml.

Surfrider Foundation Oahu Chapter also supports the inclusion of environmental justice considerations in the prioritization of beaches for testing. The current ranking system identifies beaches that are heavily used, but this results in passing over many areas that are important to local communities for fishing, gathering food, and cultural practices. Many coastal waters that are used primarily by native Hawaiian communities and local people are in areas with high cesspool density and/or low coastal circulation, such as Kahalu'u on O'ahu. The Department of Health has a responsibility to the public health of our island communities, and therefore Surfrider supports updating the beach prioritization scheme to include these higher risk areas where local communities fish and work.

SB350 would increase the validity of ocean water quality data collected by the Department of Health by reducing systematic biases in the current sampling methodology. It promotes the health of the local community by requiring that more information is provided to the public about the health risks of swimming in brown water, and by providing an opportunity for the Department of Health to select beaches for testing with environmental justice concerns in mind. Overall, passing this bill will improve the State's handling of water quality issues and allow for better management and mitigation of sewage pollution throughout the state.

Aloha, Chair Gabbard, Vice-Chair Nishihara and Members of the Committee:

I am writing in strong support of SB350. Along with other provisions, this bill would protect water quality by making sure that the Dept. Of Health's Clean Water Branch tests during Brown Water Advisories. Currently, Hawaii is one of the only states that suspends water quality monitoring during rain events, and this creates an inconsistent record and insufficient data about the safety of our waters.

Though citizen-science groups like the Surfrider Foundation's water quality testing program, we have worked extensively with the Hawaii Dept. of Health (DOH) and their Clean Water Branch (CWB) to improve water testing and public notification programs so the beach-going public has the information they need to make decisions on where it is safe to surf, swim and play at the beach throughout the state.

This bill directs the Department of Health to make changes to the Clean Water Branch's (CWB) beach water quality and public notification program to better assess the threats to public health in Hawaii's recreational waters and to take further steps to communicate these risks to the public, so people can make informed decisions on where and when it is safe for them or their families to get into the water. The bill also recommends more oversight and guidance be provided to the Environmental Management Division for better implementation of their clean water permitting, monitoring and research programs. We strongly agree with both objectives.

The CWB should follow its normal beach monitoring schedule under Brown Water Advisories to better assess water quality conditions and communicate public health risk.

- Currently all testing activity is suspended under BWA's, leaving virtually no data to really describe the pollution levels and health risks during these conditions.
- As a result, water quality statistics from the beach monitoring program do not give an accurate picture of water quality conditions at many of Hawaii's beaches, and certainly not during wet weather conditions when public health is most likely to be threatened.
- EPA Region 9 has made this recommendation to the CWB: *"Establishing a protocol to test in Brown Water Advisories would provide much better and accurate data in regards to the water quality."*
- Testing during BWA's could help lift those advisories sooner, minimizing the disruption to people's enjoyment of Hawaii's beautiful beaches and coastal environment, especially for tourism and water sports activity companies that cannot operate due to liability issues.

Oversight of Environmental Management Division

The vacant Environmental Management Division (EMD) Chief Staff position should be filled as soon as possible for optimal oversight and implementation of the various Division programs.



An oversight advisory board should also be created to provide oversight and guidance to the Environmental Management Division (EMD). A similar board was active in the past, but it has not convened in over 10 years. This board could provide much needed guidance to the EMD and Clean Water Branch to ensure a responsible balance of scientific integrity, public health protection and due diligence are applied to all the clean water permitting and monitoring programs that they run, as well as any special research or pollution investigations that they undertake.

Aloha committee members,

I strongly support SB350, which is designed to help community members and residents make informed decisions on where and when it is safe for them and their families to get into the water, while also ensuring that statewide quality monitoring is more routine, transparents, and equitable across Hawai'i beaches. The bill also recommends providing more oversight and guidance to the Environmental Management Division for better implementation of their clean water permitting, monitoring and research programs.

The Department of Health's current sampling schedule and beach "tiering" system is biased towards testing popular, touristy beaches instead of beaches where public health is more likely to be threatened by pollution. For example, Tier 1 beaches that are tested most frequently (usually weekly or every two weeks) are overwhelmingly based in tourist areas, whereas community beaches are tested far less frequently, often only once every two to three months.

To ensure that water quality is regularly and equitably monitored at beaches that are utilized by local residents for swimming, surfing, fishing, and canoe paddling, SB350 requires the DOH to take into consideration environmental justice issues in the assessment of public health risks and the ranking of DOH's tiering system.

No water quality testing occurs when Brown Water Advisories (BWAs) are issued, resulting in a lack of robust data during wet weather and creating an inaccurate picture of water quality conditions in Hawai'i. SB350 requires the DOH to continue its regularly scheduled water quality monitoring during BWAs, provided that hazardous conditions have passed.

Signs are needed on the beach to warn beachgoers of BWAs. BWAs are currently posted online and shared via email and radio spots, but health advisories are not required to be posted at beaches themselves. SB350 requires DOH to post BWA signs to warn the public of conditions at affected Tier 1 beaches.

The DOH's Environmental Management Division (EMD) Chief of Staff position has remained vacant for over 2 years. This unfilled position results in a lack of oversight and

hinders the implementation of various Division programs. SB350 requires the EMD Chief Staff position to be filled by October 2021. It also establishes an Oversight Advisory Board to provide oversight and guidance to the Environmental Management Division. A similar board was active in the past and provided critical guidance that ensured a responsible balance of scientific integrity, public health protection, and due diligence were applied to all clean water permitting and monitoring programs run by EMD and CWB.

For these reasons, I urge the committee to support passage of SB350 on to second reading.

1. Making DOH hire an EMD Director this year would involve a substantial salary plus benetits that, without additional funding, would take away from programs given the fixed budget.

2. DOH only has a few people monitoring water quality in the whole state, with no additional funding prospects. So, requiring monitoring during brown water advisories (when the water is already known to exceed limits), similarly, would wastefully take away from other monitoring. A solution would be to fund additional monitoring positions.

3. DOH's Clean Water Branch was audited recently by an EPA consultant; an LRB review of EMD would not be productive.
