TESTIMONY OF THE

CHIEF ELECTION OFFICER, OFFICE OF ELECTIONS

TO THE SENATE COMMITTEE ON JUDICIARY

ON SENATE BILL NO. 421

RELATING TO VACANCIES

February 19, 2021

Chair Rhoads and members of the Senate Committee on Judiciary, thank you for the opportunity to testify in support of Senate Bill No. 421. This bill amends the manner in which a vacancy in the membership of the State Senate is filled and certain time frames relevant thereto.

The purpose of this bill is to amend HRS § 17-3 to ensure consistency with federal and state ballot transmission requirements and candidate filing deadlines. In 2010, our election laws were amended to comply with the federal requirement of the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) to transmit ballots to military and overseas voters at least forty-five days prior to an election. 52 USC § 20302.

However, the existing language of HRS § 17-3(b)(3) provides that vacancies occurring after the sixtieth day to the Primary Election but not later than the fiftieth day prior to the General Election will result in a process for the nomination of a candidate by the applicable county committee of each political party, along with a nonpartisan candidate being chosen by lot, by the fortieth day prior to the General Election.

As such, the proposed bill consolidates HRS § 17-3(b)(2) and HRS § 17-3(b)(3) to provide that a vacancy occurring later than on the tenth day prior to the close of candidate filing until the ninety-fifth day prior to General Election will be filled through an election held in conjunction with the General Election. Each political party will be able to nominate a candidate, and nonpartisan candidates will likewise be able to file – subject to one of the candidates chosen by lot, to be

elected on the General Election ballot. The filing deadline for this vacancy would be the seventy-fifth day prior to the General Election which is consistent with the deadline in HRS § 11-119 for state and county ballot questions to be presented to the Office of Elections to appear on the General Election ballot. This ensures ballots are transmitted in compliance with federal and state requirements.
