Dear Chair Lee, Vice Chair Inouye, and Members of the Committee on Transportation:

I am in support of SB434 because it enables the Counties to enforce payment of fees related to abandoned and derelict vehicles.

As the Derelict/Abandoned Vehicle Coordinator for the County of Kauai I regularly receive complaints from residents stating we need to make the owner who abandoned their vehicle pay for the charges that were incurred. At this time we can only enforce payment of towing charges, and only for vehicles which the owners reclaim. In 2020 the County of Kauai towed 348 abandoned vehicles and only 26 were reclaimed. We towed and destroyed an additional 222 derelict vehicles, and paid for 166 tows where the vehicle was no longer on location at the time of tow; and under current law we cannot enforce payment of charges for any of these tows.

SB434 would enable us to get back a much larger percentage of funds we expend on abandoned vehicles.

Testimony of the Hawaii State Association of Counties on S.B. 434 Relating to Registration of Vehicles. Committee on Transportation Thursday, February 11, 2021, 3:00 p.m. Room 224

The Hawaii State Association of Counties (HSAC) strongly supports S.B. 434, which authorizes a county director of finance to withhold the issuance or renewal of a certificate of registration of a motor vehicle until the county is paid for any outstanding charges owed for the towing, removal, or disposal of an abandoned or derelict vehicle.

S.B. 434 will help in addressing the problem of abandoned and derelict vehicles. The more immediate problem, however, are the costs for the removal and disposal of abandoned or derelict vehicles, which in many cases, are absorbed by the county. In the County of Kauai, for example, in the last quarter of 2019, 247 abandoned or derelict vehicles were towed. Towing charges for that quarter totaled \$66,462.

Rather than imposing the burden of additional fees on the entire community, S.B. 434 will impose the responsibility for the outstanding charges on those vehicle owners who contribute to the problem

For these reasons, HSAC supports S.B. 434. Thank you for the opportunity to submit testimony on S.B. No. 434.

Dear Chair Lee, Vice Chair Inouye, and members of the Senate Committee on Transportation:

We submit this testimony on behalf of Enterprise Holdings, which includes Enterprise Rent-A-Car, Alamo Rent-A-Car, National Car Rental, and Enterprise Commute (Van Pool).

Enterprise **submits comments** on S.B. 434, which allows the director of finance of a county to require payment of outstanding charges owed to the county for the towing, removal, or disposal of an abandoned or derelict vehicle within the county before issuing a motor vehicle certificate of registration.

While Enterprise believes it is good public policy to deter individuals from abandoning vehicles on public streets and highways, Enterprise is concerned about the application of S.B. 434 within the context of the rental car industry.

There are instances when customers fail to return rentals, or when rental cars are stolen and then ticketed as abandoned. Under S.B. 434, these situations would leave registered car owners footing the bill.

Enterprise requests that language be included in the S.B. 434 to exempt registered vehicle owners who've had their vehicle stolen or taken without permission or authorization. The proposed amendments are included below in red for your consideration.

SECTION 2. Section 286-51, Hawaii Revised Statutes, is amended by amending subsection (a) to read as follows:

"(a) The certificate of registration for each motor vehicle in the counties of the State shall be renewed on a staggered basis as established by each county. The director of finance of each county may adopt rules to carry out the purposes stated in this section and shall expend the necessary funds from the director's operating funds as may be necessary for these purposes; provided that the director of finance, if the director has ascertained as of the date of the application that the registered owner has not deposited or paid bail with respect to any summons or citation issued to the registered owner for stopping, standing, or parking in violation of traffic ordinances within the county, or has outstanding charges owed to the county for the towing, removal, or disposal of an abandoned or derelict vehicle within the county, may require, as a condition precedent to the renewal, that the registered owner deposit or pay bail with respect to all such summonses [or], citations[-], or outstanding charges, provided that the registered owner shall not be fined if the abandoned or derelict vehicle has been stolen or taken from the registered owner without permission or authorization. The certificates of registration issued hereunder shall show, in addition to all information

required under section 286-47, the serial number of the

tag or emblem and shall be valid during the registration year only for which they are issued. The certificates of ownership need not be renewed annually but shall remain valid as to any interest shown therein until canceled by the director of finance as provided by law or replaced by new certificates of ownership as hereinafter provided." SECTION 3. Section 286-52, Hawaii Revised Statutes, is amended by amending subsection (c) to read as follows:

"(C) Subsection (b), requiring a transferee to forward the certificate of ownership after endorsement to the director of finance, shall not apply to the transferee of a vehicle who was not intending to and does not drive the vehicle or permit the vehicle to be driven upon the public highways, but every such transferee, upon transferring the transferee's interest or title to another, shall give notice of the transfer to the director of finance and endorse the certificate of ownership to the new legal owner and the certificate of registration to the new owner; provided that if the director of finance has ascertained as of the date of the application that the registered owner has not deposited or paid bail with respect to any summons or citation issued to the registered owner for stopping, standing, or parking in violation of traffic ordinances within the county, or has outstanding charges owed to the county for the towing, removal, or disposal of an abandoned or derelict vehicle within the county, the director may

require, as a condition precedent to the transfer, that the registered owner deposit or pay bail with respect to all such summons $[\Theta r]_{,}$ citations $[-,]_{,}$ or outstanding charges, provided that the registered owner shall not be fined if the abandoned or derelict vehicle has been stolen or taken from the registered owner without permission or authorization."
