Re: S.B. 493, Relating to Agriculture

The Department of Taxation (Department) offers the following <u>comments</u> regarding S.B. 493 for your consideration.

S.B. 493 adds several new sections to chapter 196, Hawaii Revised Statutes (HRS), to establish a Hawaii Agriculture and Forest Carbon Positive Incentive Program. It also amends section 243-3.5, HRS, which governs the barrel tax, directing the Department to deposit an unspecified portion of the \$1.05 tax imposed on each barrel or fractional part of a barrel of petroleum product, except for aviation fuel, into a newly-created special fund for the Incentive Program. The measure is effective upon approval, with certain appropriations provision sections taking effect on July 1, 2021.

The Department notes that this measure would create a new barrel tax allocation to a newly-established fund, which would require the Department to test the new allocation's functioning in conjunction with the Department of Budget & Finance and the Department of Accounting & General Services. As a result, the Department respectfully requests that the effective date of Section 5 be postponed until January 1, 2022. This will allow sufficient time to ensure proper functioning of the new allocation.

Chairperson Gabbard and Members of the Committee:

Thank you for the opportunity to testify on Senate Bill No. 493 that seeks to establish a Hawaii Agriculture and Forest Carbon Positive Incentive Program that will keep forest and working lands intact and sequester additional carbon on those lands and to fund the Program with a portion of the revenues generated by the Environmental Response, Energy, and Food Security Tax. The Department of Agriculture ("Department") has concerns regarding this measure and offers the following comments.

The Department acknowledges and appreciates the broad intent and concepts expressed in this measure that are based upon voluntary participation by landowners and farmers. The Department is concerned that the measure assigns extensive and unfamiliar responsibilities to the Department of Agriculture and the Department of Land and Natural Resources that are enumerated from page 5, line 20 to page 7, line 14. The Department will need substantial assistance to acquire the appropriate expertise to develop compensation rates and carbon incentives contract terms, estimate sequestration rates for priority sequestration activities, develop the technical underpinning of compensation rates for sequestration activities, and conduct landowner outreach.



The Department notes that the proposed Program is voluntary for now and the Department is responsible for promoting the Program to qualified landowners/lessees. We recommend that landowners and farmers/ranchers be consulted to gauge demand as participation may require changes in cultivation practices, crop selection, or ranching practices. Of particular interest would be their expectations of "fair compensation" for committing to a carbon incentives contract over a to-be-determined period.

Senate Bill 493 proposes to establish a Hawaii agriculture and forest carbon-positive incentive program that will keep forests and working agricultural lands intact and sequester additional carbon on those lands, and will fund the program with a portion of the revenues generated by the Environmental Response, Energy, and Food Security Tax. The bill also proposes to require the Department of Agriculture and the Department of Land and Natural Resources (Department) to coordinate with the Hawaii Green Infrastructure Authority in developing the program. The Department supports this bill.

The State of Hawaii's commitment to uphold the Paris Climate Accord and progressive move towards zero emissions clean economy by 2045 requires that we actively invest in reducing our emissions and mitigate greenhouse gases (primarily carbon dioxide - CO2). Agriculture, Forests and other Land Uses (AFLOU) are currently the State's only carbon sink. Investing in carbon positive actions such as creating or restoring forests through tree planting, forest protection, and improved management of existing forests, soil carbon sequestration, and local organic plant food production are the most effective and efficient ways to mitigate our carbon footprint.

The Department recognizes that smaller land managers play a significant role in managing our natural and agricultural resources, but they often survive on small profit margins. The bill will provide an incentive to land managers to make climate-smart changes on their lands to reduce carbon emissions and increase carbon sequestration to help the State meet food security and carbon emission goals. We believe the bill will not only complement other assistance programs, it will also streamline and fill in limitation gaps of other programs, allowing lands across Hawaii's ecological and economic systems to participate.

Chair Gabbard, Vice Chair Nishihara, and Members of the Senate Committee on Agriculture and Environment:

The Office of Planning supports the intent of SB 493 and offers comments on this measure. The purpose of SB 493 establishes the Hawai'i agriculture and forest carbon positive incentive program within the Hawai'i Green Infrastructure Authority, appropriates funds from the Environmental Response, Energy, and Food Security Tax ("barrel tax") to administer and staff the program, and requires the State's Greenhouse Gas Sequestration Task Force to identify and prioritize carbon positive activities eligible for the Hawai'i agriculture and forest carbon positive program.

Since 2017, the Office of Planning has provided administrative support to the Carbon Farming Task Force via <u>Act 33, SLH 2017</u>; which evolved one-year later to the State's Greenhouse Gas Sequestration Task Force through the enactment of <u>Act 15, SLH 2018</u>, with initial funding of \$150,000 to fund the Greenhouse Gas Sequestration Task Force's research and project development efforts, now codified as <u>HRS §225P-4</u> of the Hawai'i Climate Change Mitigation and Adaptation Initiative Chapter.

Act 15, SLH 2018 did not provide the Office of Planning funding to provide staff support, and the OP has struggled providing administrative support to the Greenhouse Gas Sequestration Task Force. Since 2018, the OP has noted this need for additional staffing and funding to support the task force's work. Due to this historical lack of funding to the Greenhouse Gas Sequestration Task Force, the Office of Planning will now provide temporary administrative staff support to the task force with an AmeriCorps VISTA Member. The Office of Planning will host a Greenhouse Gas Sequestration Task Force Meeting on February 16, 2020, after a year-long hiatus because of these significant funding and staffing challenges.

The Office of Planning notes that the Greenhouse Gas Sequestration Task Force has a reporting requirement to the State Legislature and the State's advisory Climate Change Mitigation and Adaptation Commission in December 2022 to include the following analysis:

"(A) Types of agricultural and aquacultural practices, public land and marine use policies, and on-farm managing practices that would provide greenhouse gas benefits and result in tangible economic benefits to agricultural and aquacultural operations;

- (B) Short-term and long-term benchmarks that would indicate how effectively agricultural and aquacultural activities have been helping the State to reach greenhouse gas neutrality;
- (C) Appropriate criteria that may be used in a certification program to measure baseline levels and increases in carbon sequestration, improvements in soil health, and other key indicators of greenhouse gas benefits from beneficial agricultural and aquacultural practices;
- (D) Types of incentives, grants, research, and assistance that would promote:
 - (i) Agricultural and aquacultural practices to produce greenhouse gas benefits; and
 - (ii) Land and marine use policies and agricultural policies that would encourage agricultural, aquacultural, and land use practices to provide greenhouse gas benefits and result in tangible economic benefits to agricultural and aquacultural operations; and
- (E) Practices and policies that add trees or vegetation to expand the urban tree canopy in urban areas to reduce ambient temperatures and increase climate resiliency and improve greenhouse gas sequestration in Hawai'i." (Hawai'i Revised Statutes §225P-4)

The Office of Planning is actively working on sustainable development and climate resilience planning and coordination for the state to meet the needs of the present without compromising the ability of future generations to meet their own needs.

The Office of Planning is committed to supporting the Greenhouse Gas Sequestration Task Force in their important role, and the OP would appreciate similar Environmental Response, Energy, and Food Security Tax ("barrel tax") funding as described in this bill to help financially support and employ staff support for the Greenhouse Gas Sequestration Task Force and the Office of Planning's work on sustainability and climate adaptive planning and coordination.

BILL NUMBER: SB 493

INTRODUCED BY: GABBARD, CHANG, KEOHOKALOLE, Nishihara

EXECUTIVE SUMMARY: Establishes the Hawaii agriculture and forest carbon positive incentive program, and funds it with an earmark on the barrel tax.

SYNOPSIS: Adds a new part to chapter 196, HRS, to establish the Hawaii agriculture and forest carbon positive incentive program. The idea of the program is for the administering authority, here the Hawaii Green Infrastructure Authority, to "incentivize carbon sequestration activities through carbon incentives contracts that provide for compensation for eligible activities by program participants." In other words, it would pay people to undertake activities that are good for the environment.

Amends section 243-3.5, HRS, to add an earmark to the environmental response, energy, and food security tax (also known as the "barrel tax") to fund the program.

Makes other conforming amendments.

EFFECTIVE DATE: Upon approval.

STAFF COMMENTS: The proposed measure would perpetuate the earmarking of barrel tax revenues. Carbon sequestration activities may provide some benefit to the State. But does that justify grabbing a pot of barrel tax money without going through the normal budgeting process that also considers sweltering primary schools, underfunded state pensions, or disaster relief for rain-flooded or lava-burnt counties as well as the economic decimation wrought by COVID-19?

Rather than the continual earmarking of revenues, a direct appropriation of general funds would be preferable. Earmarking revenues from any tax type for a particular purpose decreases transparency and accountability.

We also question whether the Hawaii Green Infrastructure Authority (HGIA) is the appropriate agency to administer this program. It may be a better fit for the state Energy Office or the Department of Agriculture.

Next, it should be remembered that revenues diverted for a special purpose, in this case to fund an environmental incentive program, will not be counted against the state's spending ceiling or debt limit and will obscure the state's true financial condition..

Aloha Chair Gabbard, Vice Chair Nishihara, and Members of the Committee,

Life of the Land is Hawai`i's own energy, environmental and community action group advocating for the people and `aina for 51 years. Our mission is to preserve and protect the life of the land through sound energy and land use policies and to promote open government through research, education, advocacy and, when necessary, litigation.

Life of the Land has been engaged in fighting the climate crisis for more than two decades.

HECO filed its third Integrated Resource Planning (IRP-3) application in 2003. Life of the Land was the sole intervenor. As part of the Settlement, Life of the Land requested and HECO agreed to a Public Meeting on Climate Change & Global Warming that was held at the State Capitol Auditorium on June 8, 2007. The 394-page transcript is available on the PUC document management system website.

Life of the Land won the two Hawai`i Supreme Court cases addressing the climate crisis: In re HELCO (May 10, 2019) and In re Gas Company (June 9, 2020). These decisions have led to the filing of more than two dozen lifecycle greenhouse gas analyses in Hawai`i Public Utilities Commission proceedings.

Life of the Land has been in more than a dozen Hawai'i Public Utilities Commission bioenergy proceedings.

We regularly attend meetings of the Hawai`i Climate Change Adaptation Commission, the City and County of Honolulu Climate Change Commission, and before it was defunded by the Legislature, meetings of the Greenhouse Gas Sequestration Task Force.

We attended and participated in the Hawai'i Aviation and Climate Action Summit.

Greenhouse gas leakage (decreasing emissions in one silo while increasing it in another silo but only measuring the first silo) is a serious issue recognized by the Hawai`i State Legislature.

Act 234 SLH 2007 (HB 226 SD2 HD2 CD1). "There is established the greenhouse gas emissions reduction task force [] shall prepare a work plan [] The work plan shall include but is not limited to the following objectives [] Recommendations to <u>minimize "leakage"</u> or a reduction in emissions of greenhouse gases within the State that is offset by an increase in emissions of greenhouse gases outside the State."

The Hawai`i Supreme Court recognized the problem of leakages and that is why the Hawai`i Public Utilities Commission now requires lifecycle analyses.

The PUC dockets examining modifications to PAR Hawai`i Refineries with the HECO Companies and with Hawai`i Gas delve into production and refining emissions. Life of the Land and the State Energy Office are the two entities that intervened in the proceedings.

Greenhouse gas analysis requires measurement, verification, transparency, and additionality analysis (incentivizing real reductions, not reductions that would have been done anyway in the absence of incentives). The bill appears to have a noble cause of incentivizing climate crisis solutions.

Reviving the greenhouse gas sequestration task force is of vital importance. Funding it so the entity can do its job makes sense.

Incentivizing sustainable forest programs that reduce greenhouse gas emissions and/or sequester emissions makes sense.

However, SB 493 has serious flaws.

SB 493 establishes the Hawaii agriculture and forest carbon positive incentive program. Appropriates funds. The funds would be provided to the Hawaii Green Infrastructure Authority (HGIA) an entity that oversees financially supporting renewable energy and energy efficiency programs and projects but that appears to have NO expertise in agriculture or greenhouse gas emissions.

There are many ways to game forestry and agricultural operations, where one can be rewarded for switching which land sections will be altered when, resulting in no meaningful progress, with taxpayer subsidies going for the status quo, or for increasing greenhouse gas emissions.

Take the AES coal plant. They took a piece of Central American land, kicked out the native people, fenced it off, and claimed a carbon offset in 1989. There was no decrease in forest-based greenhouse gas emissions, just a manipulation of the law.

Solutions to the climate crisis encompasses a vast realm of policies and implementation strategies that must be analyzed with expertise.

On behalf of our 27,000 members and supporters, the Sierra Club of Hawai'i **strongly supports** SB 493, to establish the Hawaii agriculture and forest carbon positive incentive program.

As the Vice Chair of the Oahu Group Sierra Club, as a conservation planner serving the island of Oahu's agricultural producers, and as an advanced degree graduate of the UH Manoa with an expertise in soil health and soil carbon, I believe a program to incentivize carbon-smart practices would greatly support the agricultural community and those that depend on the preservation of our land.

After years of research with soil health and natural resource management, and years of local professional experience, I have found one of the biggest challenges for making positive changes in land management is creating enough financial incentive. This is particularly true for small-acreage parcels, since typical incentive programs depend on higher acreage to return benefits to the farmer. Farmers, ranchers, and land managers have complex jobs to fulfill their independent operation responsibilities. Beyond their own operation, they are now also faced with the expectation of regenerative land stewardship to benefit their surrounding communities and environment. While we need these natural and working lands of all sizes to become more climate resilient, we cannot expect their operators to navigate the hard work and fund the bill so that we may all benefit.

As a whole, the Sierra club feels this bill will address our initial hurdles to launch Hawaii into a functional carbon neutral system. We suggest to the committee as an amendment to this draft, the removal of biofuel production from Phase 2 agricultural activities, so as to not incentivize land use practices that may release soil carbon into the atmosphere if managed unsustainably.

The Environmental Caucus of the Democratic Party, through its Committee on Energy and Climate Action, are in strong support of SB493, establishing a Hawaii Agriculture and Forest Carbon Positive Incentive Program as part of the larger state initiative toward a regenerative economy. The purpose of this bill is to provide definitions of activities qualifying for the incentive program, to establish a special fund from the barrel tax, to identify the administrative priorities of the authority, to enlist the assistance of the departments of agriculture and land and natural resources, and to report on these functions.
