Chair Keohokalole and Members of the Committee:

My name is Ahlani Quiogue, and I am the Licensing Administrator of the Department of Commerce and Consumer Affairs' (Department) Professional and Vocational Licensing Division. The Department appreciates the intent of and offers comments on this bill.

The purposes of this bill are to: (1) make permanent the regulation of behavior analysts; and (2) exempt the Behavior Analysts Licensing Program from the auditor evaluation requirement.

The Department supports the bill's intent to make permanent the regulation of behavior analysts to continue to protect the public from the unqualified practice of behavior analysis and from unprofessional conduct by behavior analysts. The Testimony of DCCA S.B. 611 Page 2 of 2

Department takes no position on exempting the Behavior Analysts Licensing Program from the auditor evaluation¹ requirement.

Dear Chair Keohokalole, Vice-Chair Baker, and Members of the Committee:

I would like to offer testimony in strong support of Senate Bill 611 relating to Behavior Analysts.

I am a Board Certified Behavior Analyst-Doctoral Designation, Hawai'i LBA, Instructor of a Verified Course Sequence to prepare BCaBAs and BCBAs. Additionally, I am a Qualified Special Education Teacher and School Administrator. I have been practicing across both fields for 25 years. I have taught in private and public schools and at the graduate level in University in both Special Education Teacher Licensing programs and ABA Certification Courses in the USA and internationally.

This licensure law is important to me as a parent of a child with ADHD and as a professional. The current rate of growth and demand for services exceedingly outweighs the number of qualified professionals who can provide services.

Although this is a difficult situation, exemptions and temporary measures cannot continually be made as this leads to the inappropriate use of and implementation of procedures by unqualified or underqualified individuals. Further, this leads to the shifting of responsibilities to already overburdened professionals of other related or adjacent fields as experts when their expertise may be limited in scope and practice which may lead to further to misuse, abuse, and harm of the consumers of services. More especially when they encounter complex cases requiring a professional who has completed the minimal hours of fieldwork training and professional competencies.

The BACB, Behavior Analyst Certification Board has recently made additional changes to its credentialling to include Psychologists with a specified amount of fieldwork, education, and training in the area of Applied Behavior Analysis which will additionally allow them to submit their credentials and experience to gain certification eventually removing the need for additional exemptions to ABA licensure in the future. This will further ensure that professionals with similar credentials who work in similar settings, with similar clients have a minimal standard for review of their credentials and experience to gain ABA licensure in the state as well.

For these reasons, I am in strong support of this bill.

Chair Keohokalole and Members of the Committee:

The Hawaii State Teachers Association <u>supports SB 611</u>, relating to behavior analysis. This bill makes permanent the regulation of behavior analysts.

Behavior analysis means the design, implementation, and evaluation of instructional and environmental modifications to produce socially significant improvements in human behavior. The practice of behavior analysis includes the empirical identification of functional relations between behavior and environmental factors, known as functional assessment and analysis, as well as the use of contextual factors, motivating operations, antecedent stimuli, positive reinforcement, and other consequences to help people develop positive behaviors.

Act 199, Session Laws of Hawaii 2015, established the behavior analyst program within the Department of Commerce and Consumer Affairs and created licensing requirements for behavior analysts. Licensing of behavior analysis services was made concurrent with mandated insurance coverage for diagnosis and treatment related to autism disorders, with which nearly 1,500 public school students are currently diagnosed. Act 205 further clarified the licensing qualifications for those who conduct Functional Behavior Assessments (FBAs), and design and monitor Applied Behavior Analysis ABA) Plans in our state.

Our teachers sometimes need the support of other professionals who support our students with other areas of expertise; this area is one of them. Health plans should cover these services and these services should remain regulated and licensed accordingly. Although teachers are able to implement these plans, they need Licensed Behavioral Analysts or School Psychologists to conduct FBAs and write ABA plans.

To support access to learning experiences of our most vulnerable keiki, the Hawaii State Teachers Association asks your committee to **support** this bill.

Dear Chair Keohokalole, Vice Chair Baker, and members of the Committee:

The Hawai'i Association for Behavior Analysis (HABA) supports SB 611 with amendments. This bill makes permanent the regulation of behavior analysts under Hawai'i Revised Statutes Chapter 465D.

Since the enactment of the behavior analyst licensure law (Act 199) and autism insurance law (Act 235) in 2015, over 480 behavior analysts have been licensed and over 1500 registered behavior technicians have been credentialed under their supervision in the State. As a result, several thousand keiki and other individuals have received access to applied behavior analysis services. These numbers are continuing to grow to meet the ongoing demand for applied behavior analysis services in the State.

The practice of behavior analysis should continue to be regulated in order to protect consumers from unqualified practitioners, unprofessional conduct, and to ensure high quality services for those who need them. In December 2020, the Auditor released Report No. 20-20: "Sunset Evaluation: Regulation of Behavior Analysts," which supported the continued regulation of the applied behavior analysis profession. The Report specifically found that:

- Licensing requirements governing the practice of applied behavior analysis are reasonably
 necessary to protect the health, safety, or welfare of those receiving services, and therefore
 should be maintained. For example, behavior analysts develop and supervise treatment in cases
 involving aggressive and impulsive behaviors, including physical aggression, property
 destruction, and self-injury. Licensing the practice of applied behavior analysis protects
 consumers by establishing certain minimum qualifications, as treatment by unqualified
 individuals could worsen behavior and result in other negative social outcomes;
- 2. Regulation assures that behavior analysts are licensed professionals providing services that are eligible for insurance reimbursement; and
- 3. Licensing of behavior analysts does not unreasonably restrict entry into the practice of applied behavior analysis in Hawaii and licensing fees cover the cost to administer the program.

HABA would like to suggest that SB 611 be amended to delete Section 3 of the bill, which exempts the auditor's evaluation requirement since an audit has already been completed.

We sincerely appreciate the opportunity to testify on this measure and thank you for your continued support of our keiki and families.

COMMENTS ON SB 611

Honorable Chair Keohokalole, Vice Chair Baker, and members of the Committee:

We are parents of a child with autism and concerned community stakeholders. Since 1990 we have lived on Oahu and in 2008 we found our home in Kaneohe (District 24). Our son was diagnosed at the age of three and we began seeking and advocating for applied behavior analysis (ABA) services by highly qualified professionals. For over a decade our son has been receiving ABA services from board certified behavior analysts (BCBAs), and board certified and licensed behavior analysts (LBAs) since the enactment of the behavior analyst licensure law chapter 465D. Over the years we have been fortunate to see first hand how high quality ABA services by licensed and appropriately trained professionals has truly changed the quality of our son's life. He continues to thrive today!

We are forever grateful for the high quality of care provided by this dedicated group of professionals. Sadly there are still far too many children and families fighting for access to applied behavior analysis services by licensed behavior analysts who have the level of expertise necessary for this medically necessary treatment to be effective. With that being said, SB 611 is of utmost importance to our family because it removes the sunset date and makes permanent the behavior analysis licensure law chapter 465D, which ensures the protection of some of Hawai'i's most vulnerable children. Hopefully with the expotential growth of qualified LBAs in the field since 2015, more children and families can access these essential ABA services.

We appreciate the opportunity to testify on this measure and would like to offer the following comments for your consideration.

- The removal of the sunset date to continue to assure consumer protection for recipients of applied behavior analysis services by qualified licensed professionals.
- The auditors report supporting the removal of the sunset date (Please see below)

The following language shows the amended sections of the bill SB 611:

RELATING TO BEHAVIOR ANALYSTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAI

SECTION 1. The legislature finds that Act 199, Session Laws of Hawaii 2015, codified as chapter 465D, Hawaii Revised Statutes (Act 199), establishes the licensing standards for behavior analysts, which is set to repeal on June 30, 2021. Act 199 was established to ensure that persons requiring diagnosis and treatment for autism receive the care they need. Since the establishment of Act 199, over three hundred licenses for behavior analysts and over one thousand licenses for registered behavioral technicians have been issued in the State. As a result, thousands of individuals have received access to applied behavior analysis care and services since the implementation of Act 199.

The legislature therefore finds that the practice of behavior analysis and licensure of behavior analysts should continue to be regulated to protect the public's health, safety, and welfare. Additionally, while the licensure of behavior analysts has been a significant step in meeting the needs for treatment of those with autism, the total number of licensees is still insufficient to meet present demands.

Accordingly, the purpose of this Act is to:

(1) Make permanent the regulation of behavior analysts under chapter 465D, Hawaii Revised Statutes, which will ensure the continued treatment of individuals with autism; and

(2) Exempt the requirements of an auditor's evaluation and report pursuant to 26H-5, Hawaii Revised Statutes, for behavior analysts.

SECTION 2. Section 26H-4, Hawaii Revised Statutes, is amended to read as follows:

"§26H-4 Repeal dates for newly enacted professional and vocational regulatory programs. (a) Any professional or vocational regulatory program enacted after January 1, 1994, and listed in this section shall be repealed as specified in this section. The auditor shall perform an evaluation of the program, pursuant to section 26H-5, prior to its repeal date.

(b) Chapter 465D (behavior analysts) shall be repealed on June 30, 2021.

(c) (b) Chapter 466L (appraisal management companies) shall be repealed on June 30, 2023.

[(d)] (c) Chapter 457J (midwives) shall be repealed on June 30, 2025."

SECTION 3. The requirements of section 26H-5, Hawaii Revised Statutes, shall not apply to this Act.

SECTION 4. Statutory material to be repealed is bracketed and stricken. New statutory material is underscored.

SECTION 5. This Act shall take effect on June 29, 2021.

Please help more children and families the opportunity to improve the quality of their lives and be as happy and successful as any parent would want them to be despite their disability. We appreciate your service to our state and the opportunity to testify on this measure. Thank you very much.

Licensing the practice of applied behavior analysis protects consumers by establishing certain minimum qualifications, as treatment by unqualified individuals could worsen behavior and result in other negative social outcomes;
- 2. Regulation assures that behavior analysts are licensed professionals providing services that are eligible for insurance reimbursement; and
- 3. Licensing of behavior analysts does not unreasonably restrict entry into the practice of applied behavior analysis in Hawaii and licensing fees cover the cost to administer the program.

I would like to suggest that SB 611 be amended to delete Section 3 of the bill, which exempts the auditor's evaluation requirement since an audit has already been completed.

I would like to offer testimony in strong support of Senate Bill 611 relating to Behavior Analysts.

I am a Board Certified Behavior Analyst-Doctoral Designation, Hawai'i LBA, Instructor of a Verified Course Sequence to prepare BCaBAs and BCBAs. Additionally, I am a Qualified Special Education Teacher and School Administrator. I have been practicing across both fields for 25 years. I have taught in private and public schools and at the graduate level in University in both Special Education Teacher Licensing programs and ABA Certification Courses in the USA and internationally.

This licensure law is important to me as a parent of a child with ADHD and as a professional. The current rate of growth and demand for services exceedingly outweighs the number of qualified professionals who can provide services.

Although this is a difficult situation, exemptions and temporary measures cannot continually be made as this leads to the inappropriate use of and implementation of procedures by unqualified or underqualified individuals. Further, this leads to the shifting of responsibilities to already overburdened professionals of other related or adjacent fields as experts when their expertise may be limited in scope and practice which may lead to further to misuse, abuse, and harm of the consumers of services. More especially when they encounter complex cases requiring a professional who has completed the minimal hours of fieldwork training and professional competencies.

The BACB, Behavior Analyst Certification Board has recently made additional changes to its credentialling to include Psychologists with a specified amount of fieldwork, education, and training in the area of Applied Behavior Analysis which will additionally allow them to submit their credentials and experience to gain certification eventually removing the need for additional exemptions to ABA licensure in the future. This will further ensure that professionals with similar credentials who work in similar settings, with similar clients have a minimal standard for review of their credentials and experience to gain ABA licensure in the state as well.

For these reasons, I am in strong support of this bill.

Dear Chair Keohokalole, Vice Chair Baker, and members of the Committee:

My name is Kyle Machos and I am a Licensed Behavior Analyst in the state of Hawaii. I strongly support SB 611 with amendments. This bill makes permanent the regulation of behavior analysts under Hawai'i Revised Statutes Chapter 465D.

It is imperative to the medical needs of our keiki and all individuals receiving services in our state to make permanent the regulation of Behavior Analysts in Hawaii. The population with needs specific to Applied Behavior Analysis continues to grow along with the number of Behavior Analysts in our state. Licensures ensure consumer protection for our citizens in need.

Since the enactment of the behavior analyst licensure law (Act 199) and autism insurance law (Act 235) in 2015, over 480 behavior analysts have been licensed and over 1500 registered behavior technicians have been credentialed under their supervision in the State. As a result, several thousand keiki and other individuals have received access to applied behavior analysis services. These numbers are continuing to grow to meet the ongoing demand for applied behavior analysis services in the State.

The practice of behavior analysis should continue to be regulated in order to protect consumers from unqualified practitioners, unprofessional conduct, and to ensure high quality services for those who need them. In December 2020, the Auditor released Report No. 20-20: "Sunset Evaluation: Regulation of Behavior Analysts," which supported the continued regulation of the applied behavior analysis profession. The Report specifically found that:

- 1. Licensing requirements governing the practice of applied behavior analysis are reasonably necessary to protect the health, safety, or welfare of those receiving services, and therefore should be maintained. For example, behavior analysts develop and supervise treatment in cases involving aggressive and impulsive behaviors, including physical aggression, property destruction, and self-injury. Licensing the practice of applied behavior analysis protects consumers by establishing certain minimum qualifications, as treatment by unqualified individuals could worsen behavior and result in other negative social outcomes;
- 2. Regulation assures that behavior analysts are licensed professionals providing services that are eligible for insurance reimbursement; and
- 3. Licensing of behavior analysts does not unreasonably restrict entry into the practice of applied behavior analysis in Hawaii and licensing fees cover the cost to administer the program.

I would like to suggest that SB 611 be amended to delete Section 3 of the bill, which exempts the auditor's evaluation requirement since an audit has already been completed.
