Dear Chair Lee, Vice Chair Inouye, and Committee Members:

I am writing in strong support of renaming the Kahului Airport Access Road to the Mayor Elmer F. Cravalho Way. The basis for this support stems primarily from my association with Mr. Cravalho in his professional capacity as the CEO of the Kula Community Federal Credit Union (KCFCU) and spanned nearly three decades.

Mr. Cravalho was one of seven charter members who founded KCFCU, a member owned not-forprofit cooperative in 1954, believing this institution could assist the upcountry community, its farmers, ranchers and residents with their financial needs. Through his dedication, hard work and leadership, he and his Board successfully accomplished what the organizers set out to do. He was a living embodiment of the "People Helping People" credit union philosophy.

In his capacity as CEO, for nearly two decades up to the time of his retirement in 2014 and the merger of KCFCU, he took no compensation even though he was at the helm of a \$40 million institution and oversaw every facet of its operation. He had expressed that he did so because it was just another way he could give back to the community as he continually sought to do.

In 1996 when the federal regulators sought a merger partner for Hana Community FCU (HCFCU), they reached out to Mr. Cravalho. Mr. Cravalho recommended to his Board that their credit union should continue serving the Hana community by acquiring HCFCU because from a financial institution perspective it was an underserved area and despite what might be some fiscal reasons not to do so. The merger was approved by both the HCFCU membership and the regulators.

When it came to lending, he often took a different approach and looked beyond the traditional underwriting of FICO scores and debt-to-income ratios. Mr. Cravalho subscribed to a saying he coined "If we not going then who going". What this meant was he considered his credit union a

lender of last resort for some of the applicants. He would leave "no stone unturned" to approving a request to borrowers who had less than ideal credit if he felt they were deserving based on the need.

These are just some of the examples of how his unconventional thinking and actions benefitted those he served in his credit union. He was always about helping others. It is with this in mind that I support honoring his many accomplishments for the love of Maui by renaming the road as proposed.

Renames Kahului Airport Access Road on Maui as the "Mayor Elmer F. Cravalho Way"

I <u>strongly support</u> recognizing and honoring one of our Maui's "Native Sons", the late Mayor Elmer F. Cravalho.

Mayor Cravalho had a long and distinguished career serving Maui County and the State of Hawaii. At the State level Mr. Cravalho was elected to the State House of Representatives in 1954, and soon thereafter became Speaker of the House. In 1959 he famously was on the telephone with Washington receiving the news that Hawaii was going to be making the transition from being a United States territory to becoming the 50th state.

As a powerful State Representative Mr. Cravalho was instrumental in getting funds allocated that provided so many benefits to Maui County. For example, the excellent highway from Pukalani toward Keokea was significantly improved. Kula Elementary School was funded and constructed, opening in 1964. The new school served a broad area and was able to consolidate the needs of students who had previously been attending five smaller elementary schools into one beautiful school that has now served my Kula community for over 50 years.

In 1967 after Maui's Mayor Eddie Tam passed away, Mr. Cravalho was elected mayor of Maui County. He served as Maui County Mayor for 12 years. During that time Maui made a very significant transformation from a purely agricultural community into a world-class tourist destination area. Many infrastructure projects were completed all over the county during that time.

Within our Upcountry Maui community Mr. Cravalho was well known as the manager of the very successful Kula Community Credit Union which provided banking services and loan funds for many families and farmers. In the mid-1990s Mr. Cravalho demonstrated his leadership skills by chairing the citizen advisory committee for the UpCountry Makawao-Pukalani-Kula community plan. He also Chaired Maui County's Board of Water Supply, and the Upcountry Maui Community Plan Citizen Advisory Committee.

The above listing is a mere outline of the many contributions which Mayor Elmer F. Cravalho made to our local and broader community. I wish to recognize and honor these contributions by recommending that Kahului Airport Access Road on Maui as the "Mayor Elmer F. Cravalho Way".

Let us recognize this truly outstanding Maui County and State leader.

Aloha Senators. Thank you for the opportunity to testify in favor of SB 651, renaming Airport Access Way to Mayor Elmer Cravalho Way, honoring Maui's first Mayor and the first speaker of the House post-statehood.

Mayor Cravalho did a lot for Maui and the State of Hawaii, especially in making Maui a destination for visitors, making it appropriate to name the airport access road after him. Mayor Cravalho also was very passionate about providing opportunities for locals and immigrants. He was very instrumental in hiring many Filipino immigrants to work at the County and be the "first" Filipino in that capacity. As a youngster, I recall attending events where Mayor Cravalho was the guest speaker and he would be sure to recognize those in the audience of Filipino ancestry who were the first, e.g., Richard Caldito as the first Councilman of Filipino ancestry; Rafael Acoba as the first Maui Police Department Lieutenant of Filipino ancestry, Patrick Constantino as the first Executive Assistant to the Mayor (and later County Treasurer) of Filipino ancestry; Claro Capili as the first Managing Director of Filipino ancestry. As a teenager, it encouraged me that opportunities were available regardless of one's ethnicity.

After my first year of college, I was given a summer job in the County of Maui--splitting time between the Mayor's office and the Department of Motor Vehicles. I learned a lot during that summer and as a political science major, it helped to open my eyes as to the process of government and politics. I also was the fortunate recipient of an Elmer Cravalho scholarship given to a child of a Sakada majoring in political science. My late brother Rogelio Evangelista also worked closely with Mayor Cravalho on a number of community issues. Many of my elders--many who have passed away--also worked closely with him. Mayor Cravalho always remained committed to the people of Maui County. Even after leaving office, he served several community organizations such as the Board of Water Supply and the Kula Credit Union where he was the CEO. Like all politicians, he loved to talk story and share his mana`o. Without a doubt, Mayor Cravalho was a colorful guy and greatly contributed to the success of the County of Maui and the State of Hawaii.
