

# Testimony to the Senate Joint Committee on Health and Judiciary Wednesday, February 17, 2021; 9:30 a.m. Via Videoconference

#### RE: SENATE BILL NO. 0663, RELATING TO THE SOLEMN COVENANT OF THE STATES TO AWARD PRIZES FOR CURING DISEASES.

Chair Keohokalole, Chair Rhoads, and Members of the Committee:

The Hawaii Primary Care Association (HPCA) is a 501(c)(3) organization established to advocate for, expand access to, and sustain high quality care through the statewide network of Community Health Centers throughout the State of Hawaii. The HPCA **SUPPORTS** Senate Bill No. 0663, RELATING TO TTHE SOLEMN COVENANT OF THE STATES TO AWARD PRIZES FOR CURING DISEASES.

The bill, as received by your Committee, would formally certify and approve the State of Hawaii for adherence to a compact of states that would award prizes for the curing of diseases and establish the administrative framework for the participating states to raise funds for prizes. The bill would also allow the Governor to appoint a commissioner subject to Senate Advise and Consent,

By way of background, the HPCA represents Hawaii Federally-Qualified Health Centers (FQHCs). FQHCs provide desperately needed medical services at the frontlines in rural and underserved communities. Long considered champions for creating a more sustainable, integrated, and wellness-oriented system of health, FQHCs provide a more efficient, more effective and more comprehensive system of healthcare.

The goal of medical research is to develop safe and effective methods to prevent, detect, diagnose, treat, and ultimately cure the collections of diseases known as cancer. The better we understand these diseases, the more progress we will make toward diminishing the tremendous human and economic tolls disease inflicts upon our citizenry.

By formally entering the compact of states to award prizes for the curing of diseases, the State of Hawaii is joining the larger community across the Nation that sees the value in incentivizing medical breakthroughs for the benefit of all humanity.

Accordingly, the HPCA wholeheartedly supports this important measure.

Comments:

I OPPOSE SB663.

Hawaii's citizens, as citizens of the United States, currently authorize and fund the National Institutes of Health and the National Science Foundation to investigate and find cures for diseases. This is accomplished using the accountability of an elected Congress.

This compact would establish a "commission" with extensive powers, including imposing "dues" (i.e., a tax) on Hawaii and also to issue bonded indebtedness for which Hawaii would be liable. The compact further anticipates not only finding cures, but also engaging in the business of providing cures.

The "sunshine" requriements impossed on the commission are weak and there is no recourse except to litigate in a foreign jurisdiction.

The commission can impose "dues" and "fees" on Hawaii based on the commission's determination on heath care spending "saved" due to a cure it controls.

In sum, the proposed charter transfers important powers of taxation and public exspense from elected legistures to an unelected commission. The charter creates an entity that is duplicative with existing administrative agencies. The charter lacks meaningfiul oversight of the activities of the commission. For these reassons, Hawaii should not join in such a compact. We should keep our sovereignty.
