In consideration of SENATE BILL 772, SENATE DRAFT 2 RELATING TO TRANSPORTATION

Senate Bill 772, Senate Draft 2 proposes to authorize the issuance of special license plates to support forest and ocean conservation, with proceeds from the program to be used to fund conservation efforts at State beaches, nearshore waters, and forests; and increase the initial application and renewal fees for special number plates from \$25 to \$100. The Department of Land and Natural Resources (Department) supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Biennium Budget request.

The Department recognizes the importance of Hawaii's unique natural and cultural resources to sustaining life in the islands, and that management of these resources needs additional funding inputs, given threats to native ecosystems and the challenges posed by invasive species, population growth, and climate change. As demonstrated over this past year, Hawaii's forests, beaches, and waters are vital to maintaining the health and well-being of our residents.

The Department supports this measure as it would provide dedicated funding to support the management of Hawaii's beaches, nearshore waters, and forests. It would be a completely voluntary way for citizens to contribute to the resources they love. Putting the money directly into the management of natural resources would encourage participation. The forest stewardship and beach restoration special funds are the appropriate funds to support the purposes of this bill.

Aloha Chair Tarnas, Vice Chair Branco, and Members of the House Committee on Water and Land:

The HAWAI'I REEF AND OCEAN COALITION – HIROC – **supports SB1173 SD2.** HIROC was formed in 2017 by coral reef scientists, educators, local Hawaii environmental organizations, elected officials, and others to address the crisis facing Hawaii's coral reefs and other marine life.

Our reefs and oceans are under great stress and need funding for protection! Coral bleaching, polluted runoff, unsustainable fishing, invasive species, certain petrochemical sunscreens, and abandoned or grounded vessels are all degrading our coral reefs and oceans that are critical for protecting our aquatic life and shorelines and maintaining our tourism and recreational economy. Much more funding is needed to protect our forests, beaches, nearshore environments, ocean, and aquatic life.

The purpose of this Act is to establish special number motor vehicle license plates that commemorate the importance of forest and ocean conservation, and to use proceeds from the special number plate program to fund conservation efforts for the State's beaches, nearshore environments, and forests. The bill would increase the initial application and renewal fees for special number plates from \$25 to \$100.

This bill will provide the counties with some additional funding for conservation efforts, and so **the Hawaii Reef and Ocean Coalition asks that you pass this bill.** Mahalo!
