S.C.R. 121 Proposed S.D. 1 / S.R. 95 Proposed S.D. 1 URGING THE DEPARTMENT OF TRANSPORTATION AND THE CITY AND COUNTY OF HONOLULU TO MAKE SAFETY IMPROVEMENTS TO INTERSECTIONS AND ROADWAYS IN THE EWA BEACH AREA

Senate Committee on Transportation

The Department of Transportation (DOT) **supports intent with comments** S.C.R. 121, S.D. 1 Proposed and S.R. 95, S.D.1 Proposed.

Raised crosswalks at intersections with traffic signals will decrease the safety, efficiency and operations of vehicles travelling through the intersection. Vehicle backups will occur approaching the raised crosswalk and potential residual queuing after the left turn phase or cross street green phase will have drivers blocking the intersection for subsequent green phase movements. Longer left turn and cross street green phases necessary to clear these vehicle backups will result in longer delays and congestion at the intersection. Therefore, these improvements are not recommended on Fort Weaver Road at the intersection of Papipi Road and at the intersection of North Road.

The DOT is moving forward on three projects to enhance the safety of students and pedestrians on Fort Weaver Road. The first project will install raised crosswalks at the intersection of Pohakupuna Road and at the intersection of Parish Drive. The second project will install a raised intersection at Fort Weaver Road and Kilaha Street/Ewa Beach Road. And the third project will add streetlights to enhance night visibility at crosswalk on Fort Weaver Road and Kilaha Street/Ewa Beach Road.

TESTIMONY ON SENATE CONCURRENT RESOLUTION 121, PROPOSED SD1 & SENATE RESOLUTION 95, PROPOSED SD1

Chair Lee, Vice Chair Inouye, and Members of the Committee:

The Department of Transportation Services (DTS) provides the following <u>comments</u> on the various requests outlined in SCR 121, SD1 and SR 95, SD1:

Installation of raised crosswalks at the following locations:

Papipi Road, beginning from Kapolei Parkway to Fort Weaver Road.

This section of roadway is currently being studied as a result of a similar request from the Councilmember of District I.

Intersection of Keoneula Boulevard and Kamakana Street.

This intersection is privately held by the developer Haseko. It is DTS' understanding that Haseko is working with a consultant on this intersection.

North Road at the intersection of North Road and Fort Weaver Road and by Our Lady Perpetual Help Church.

This intersection of North Road and Fort Weaver Road is under the jurisdiction of the State Department of Transportation.

Kunia Street at the following intersections; Kuhina Street and Ahona Street; Kuhina Street and Pailani Street; Kuhina Street and Mailani Street

DTS has previously conducted a study regarding the installation of speed tables on Kuhina Street. We would further consider the installation of speed tables along Kuhina Street if a majority of the directly affected residents supports the proposal. Affected residents on Hanakahi Street provided a petition to the DTS indicating the support of installing a speed hump on Hanakahi Street.

Finally, regarding the removal of bus stop number 1091, located in front of Ilima Intermediate School. This bus stop is an integral part of TheBus system, and is in the most optimal location to serve the community safely and conveniently, including the Ilima Intermediate School students. . It has been at this location for over 20 years, is well established with shelter, bench, trash receptacle, and services Routes 41, 42, 44, 91, and W1. As such, DTS will not consider removal of this bus stop.
