### SCR 165/SR 130 REQUESTING THE UNITED STATES CONGRESS TO CONSENT TO THE ENACTMENT OF ACT 80, SESSION LAWS OF HAWAII 2017

March 23, 2021

Aloha Chair Shimabukuro, Chair Rhoads, and members of the Committees:

The Department of Hawaiian Home Lands (DHHL) supports these resolutions requesting the United States Congress to consent to the enactment of Act 80, Session Laws of Hawaii 2017 (Act 80). DHHL strongly supported Act 80, which reduces the minimum Hawaiian blood quantum requirement of certain successors to lessees of Hawaiian Home lands from one-quarter to one-thirty second. DHHL noted in its testimony on both the House and Senate versions of HB451 enacted into law as Act 80 that we continue to receive requests from beneficiaries, particularly lessees in our older homestead communities to reduce the blood quantum requirement for successors. As these communities age, the lessees with one-quarter Hawaiian blood are facing the possible loss of a homestead lease that has been within the family for several generations because their descendants lack the required blood quantum. Act 80 will provide DHHL lessees with greater flexibility to retain homestead leases within their families.

Aloha Chair Shimabukuro, Chair Rhoads, Vice Chair Keohokalole and members of both committees:

The Waimea Hawaiian Civic Club SUPPORTS SCR165/SR130.

In keeping with Prince Kuhio's intent, these resolutions seek to mālama the ohana that flows from native Hawaiian awardees who have built their lives on the land and established a safe and nurturing place for the generations of ohana that have followed. In the 101 years since the Hawaiian Homes Commission Act, 1920 was enacted, generations of families have lived on and rooted themselves in these homes, built ranches, farms, and local businesses which, in turn, support Hawai`i's economy. Additionally, significant number of marriages occurring between people of Hawaiian ancestry and people without Hawaiian ancestry directly have reduced the number of persons with sufficient Hawaiian blood quantum for purposes of successorship. Amendment of the Act to reflect Prince Kuhio's intent to help Hawaiian people should be given strong consideration and justification for the reduction of the blood quantum amount for certain successors.

Our community in Waimea and the surrounding area on Moku O Keawe has a strong settlement of homesteaders consisting of residents, ranchers, and farmers, and business owners. Kailapa and Kawaihae settlements are between 10 and 15 miles from Waimea. All contribute to the community, children attend schools, and residents work in businesses and produce food and services that feed our community.
