Good afternoon, Chair Rhoads, Vice Chair Keohokalole, and members of the Committee:

I'm Ron Han, Director of the State Office of Veterans Services (OVS). I appreciate this opportunity to provide comments **in support** of SCR 195, SD1/SR160, SD1.

Under the current federal laws, disabled Veterans who served in the armed forces for twenty years or more and possess a Veterans Affairs (VA) disability rating of 50% or higher receive dual compensation for their retirement and for their disability that they have earned and are not subjected to the offset. Consequently, the VA recognizes that the Veteran's retirement and disability compensation are two distinctive and separate entitlements. A retirement annuity was earned for successful years of service and the disability compensation was earned for a service-connected injury or ailment. Therefore, retired Military Members who have any service-connected disability compensation (i.e.10%-40%) should be afforded the same entitlements for dual compensation as those who reached retirement eligibility and are rated at the 50% disabled level. The current law creates a disparity of equitability that should be corrected to allow all VA rated disabled Veterans to receive just compensation without affecting their retirement pay through offset.

Thank you for this opportunity to provide testimony on behalf of Hawaii's Veterans and their families.
