- 1 EOA's Position: The Executive Office on Aging (EOA), an attached agency of the Department
- 2 of Health (DOH), provides comments to Senate Concurrent Resolution 219, Urging The
- 3 Executive Office On Aging To Form A Working Group And Develop A Plan For Outreach To
- 4 Kupuna To Remediate A Lack Of Digital Literacy, Broadband Access, And Computer
- 5 Equipment. The purpose of this bill is to urge the EOA to form a working group to develop a
- 6 plan for outreach to kupuna to remediate a lack of digital literacy and to develop a curriculum to
- 7 increase digital literacy among Hawai'i's kupuna community.
- 8 Fiscal Implications: These resolutions require significant resources to successfully implement
- 9 their intent. The EOA is limited in staffing and funding to convene a working group, develop a
- 10 digital outreach plan for kupuna, and develop a digital literacy curriculum for kupuna.

Purpose and Justification: The EOA appreciates the intent of this bill and understands the 1 value of kupuna having digital literacy skills and more importantly, access to broadband 2 connectivity particularly during COVID. However, these measures require significant resources 3 to successfully fulfill their intent, and the EOA is limited in staffing and funding. The EOA also 4 does not have the expertise and experience in digital technologies to develop a digital literacy 5 curriculum and/or in broadband connection to develop an outreach plan. EOA suggests that 6 another agency with expertise in broadband technologies and digital literacy take the lead in the 7 8 workgroup. We note for the Committee's consideration that in March 2020 the Department of Business Economic Development & Tourism (DBEDT) convened a Broadband Hui to "address 9 gaps in broadband access both near term and long term". Additionally, in November 2020, 10 DBEDT, in partnership with the Department of Commerce and Consumer Affairs (DCCA) and 11 the Office of Planning, published the Hawaii Broadband Strategic Plan 2020, which includes as 12 one of it's goals: "Goal 2: Expand Digital Inclusion and Adoption to Achieve Digital Equity" 13 with an objective to "identify and remove barriers to access and adoption to unserved and 14 underserved". Based on their current efforts these agencies may have a better understanding of 15 how to improve broadband connections and develop digital literacy for all populations. 16 Thank you for this opportunity to testify. 17

My name is Keali'i Lopez and I am the State Director for AARP Hawai'i. AARP is a membership organization of people age fifty and over, with nearly 145,000 members in Hawai'i.

AARP Hawai'i supports SCR 219 which creates a work group to develop a plan for outreach to kupuna to remediate a lack of digital literacy, broadband access and computer equipment. It urges the Executive Office on Aging to convene this work group.

The recent pandemic has significantly increase the demand and use of digital connectivity for communication across all sectors, and throughout our communities statewide. This is especially important for homebound kūpuna who have become more reliant on telehealth to connect with their physicians for medical consultation and monitoring. More recently, having online access has become even more critical for kupuna to schedule appointments for their COVID vaccination. Many kupuna are not digital literate, face limited or no access to computers and broadband connectivity. The heavy demand for broadband has amplified the weakness in our broadband infrastructure. AARP supports efforts that will expand digital equity and access to ensure that all individuals especially our kupuna, have access to information and modern communication technologies.
