I am writing in support of SCR 25 SD1. This measure requests that the Department of Public Safety be allowed to created a Faith Pod based on Kapu Aloha to be established witin each correctional center.

As a guiding principle, this Legislative body should strongly consider and embed evidence based criminal justice strategies into public policies. Best practices dictacte that

we concentrate our efforts on sentencing reform, diversion, cash bail elimination and decarceration. Yet, as long as people are incarcerated in Hawai'i and private prisons on the continent, we must simultaneously provide meaningful rehabilitation opportunities for persons to transform their lives.

Creating faith pods based on the guiding principle of "Kapu Aloha" would contribute to individual's personal growth within a historical and contemporary cultural context, and provide additonal "tools" to enhance successful reentry when returning home.

As the former Director of Maui Economic Opportunity's Reintegration Program on Maui, I have witnessed firsthand the efficacy and transformational power of providing cultural education, services and training opportunities. We offered cultural classes such as hula, and connected with cultural practitioners throughout Maui as part of our Family Reunification Program where we were able to malama cultural sites, engage in koa forest restoration, restore fish ponds and plant kalo. Through our Reading Circle, men and women at Maui Community Correctional Center read Hawaii's Story for Hawaii's Queeen. Inspired by the Queen's story, our participants wrote monologues that turned into a play performed at the historic 'lao Theatre, and at the Kaanapali Ritz Hotel. Participants were empowered and inspired to learn more about cultural practices (both Native Hawaiians and other participants who consider Hawai'i home), and gained a greater sense of self-worth and purpose. They saw these collective activities as opportunities to do good and give back to their 'ohana and communities. In effect, this is Restorative Justice in action!

It's encouraging to hear that Director Max Otani from the Department of Public Safety supports this measure. Please support SCR25 SD1.
