1 **Fiscal Implications:** The Department of Health does not have the resources to implement the

2 request outlined in the resolution and defers to the Governor's Executive Budget Request for

3 appropriation priorities.

Department Testimony: The Department respectfully offers comments on S.C.R. 33, which 4 requests the Office of Primary Care and Rural Health (OPCRH) to facilitate discussions with key 5 6 community health and social service organizations within West Hawaii and major healthcare 7 stakeholders in Senate District 3 to address the health and wellness needs of the most vulnerable by aligning the goals and objectives of key organizations into a One Shared 2030 Health Vision 8 Plan for West Hawaii. While the Department appreciates the intent of this measure, this 9 resolution duplicates efforts that are already underway. For example, OPCRH is engaged with 10 community-based organizations on Hawaii Island such as the Hawaii Physician Shortage 11 12 Taskforce and Community First to conduct a Community Health Needs Assessment for the entire Hawaii County. In addition, OPCRH is collaborating with the Hawaii State Rural Health 13 Association to conduct a statewide inventory of existing/secondary qualitative data sources that 14 15 identify communities with the greatest unmet health care needs, disparities, health workforce 16 shortages, and other critical barriers.
