My calling for the last 40 years has been giving access to healthcare and health professional careers to poor and underserved children. The connection I have with the people of the Compact of Free Association with the United States is strong. I was born and partially raised on the island of Kwajalein in the Republic of the Marshall Islands. During my training, I spent time in the Republic of Palau seeing patients. Presently, I practice pediatrics at a Kalihi-Palama Health Center clinic where most of my patients are Chuukese or Marshallese.

The young Pacific Islander youth that I see as patients and students were brought here or born here by parents seeking a better life for them. Unfortunately, most of these children know of, and have internalized, the prejudice, injustice and negligence inflicted by the citizens of our "Aloha State". One of my Marshallese Early College High School students once told me; "Dr. Ric, they think I'm stupid. I make straight A's."

How do we begin to right the wrongs perpetrated upon the peaceful Pacific Island people, many of whom we displaced, blew up their islands, and made their homes inhabitable? Recognizing their contributions to the security and economy of the United States is a start. It sends a message to Pacific Island children that their lives matter, that they are not inferior, and that there is hope.
