A BILL FOR AN ACT

RELATING TO VETERINARIANS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 471, Hawaii Revised Statutes, is
- 2 amended by adding two new sections to be appropriately
- 3 designated and to read as follows:
- 4 "S471- Exception to liability; emergency care;
- 5 veterinarian-client-patient relationship. (a) Any veterinarian
- 6 duly licensed under this chapter who, in good faith, without
- 7 remuneration or expectation of remuneration, renders emergency
- 8 care to a sick or injured animal at large shall not be liable to
- 9 the owner of that animal for any civil damages resulting from
- 10 the veterinarian's acts or omissions, except for damages as may
- 11 result from the veterinarian's gross negligence or wanton acts
- 12 or omissions.
- (b) A veterinarian duly licensed under this chapter may,
- 14 in good faith, render necessary and prompt care and treatment to
- 15 an animal patient without establishing a veterinarian-client-
- 16 patient relationship if conditions do not allow the
- 17 establishment of the relationship in a timely manner. A

- 1 veterinarian who renders emergency treatment shall not be liable

- 8 SECTION 2. This Act does not affect rights and duties that
- 9 matured, penalties that were incurred, and proceedings that were
- 10 begun before its effective date.
- 11 SECTION 3. New statutory material is underscored.
- 12 SECTION 4. This Act shall take effect upon its approval.
