A BILL FOR AN ACT

RELATING TO SPORTS MEDICINE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1	. Chapter 453, Hawaii Revised Statutes, is
2	amended by add	ing a new section to be appropriately designated
3	and to read as	follows:
4	" <u>§453-</u>	Sports teams; out-of-state physicians; exemption
5	from licensure	. (a) Notwithstanding any other provision of law
6	to the contrar	y, an out-of-state physician shall be exempt from
7	the licensure	requirements under section 453-2 if:
8	<u>(1)</u> (A)	The out-of-state physician has a written or oral
9		agreement with a sports team to provide care to
10		sports team members for a specific sporting event
11		to take place in the State; or
12	<u>(B)</u>	The physician has been invited by a national
13		sport governing body to provide services to
14		sports team members at a national sport training
15		center in the State or provide services at an
16		event or competition in the State that is
17		sanctioned by the national sport governing body;

1	(2)	The out-of-state physician's practice is limited to
2		that required by the national sport governing body;
3	(3)	The services provided by the out-of-state physician
4		are within the out-of-state physician's scope of
5		practice; and
6	(4)	At least thirty days prior to an event described in
7		paragraph (1)(A) or (B), the out-of-state physician
8		shall provide written notice to the Hawaii medical
9		board of the nature of the event, the dates of
10		attendance at the event, and the identity of the
11		sports team or teams for which the out-of-state
12		physician intends to provide services.
13	(b)	An exemption granted pursuant to subsection (a) shall
14	remain in	force while the out-of-state physician is traveling
15	with the sports team for two days prior to the sporting event,	
16	the duration of the sporting event, and two days after the	
17	sporting	event; provided that the exemption shall be valid for
18	no longer	than ten days per individual sporting event.
19	(c)	Upon prior request by an out-of-state physician, the
20	board may	grant the out-of-state physician additional time for
21	the exemp	tion permitted by subsection (a), up to twenty

Sports Teams; Out-of-State Physicians; Exemption from Licensure

Description:

Provides a limited exemption from state licensure requirements to out-of-state physicians who accompany a sports team to a specific sporting event in Hawaii or are invited to provide services at a national sport training center, event, or competition in Hawaii, if certain conditions are met. Requires out-of-state physicians to provide notice to the Hawaii medical board.
