A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that there are roads in Hawaii whose ownership or jurisdiction is disputed between the 2 3 State and counties. The legislature further finds that the 4 safety of persons traveling over these so called "roads in 5 limbo" is affected by the lack of maintenance to these roads. 6 The legislature also finds that neither state nor county 7 agencies are willing to maintain these roads because the maintenance activities may be construed as assuming ownership 8 9 and jurisdiction over the disputed roads.

10 The purpose of this Act is to enable government agencies to 11 maintain roads whose ownership or jurisdiction is in dispute 12 between the State and the counties by:

13 (1) Specifying that the maintenance or repair of disputed
14 roads by any agency shall not be deemed to be an
15 indication that the agency has assumed ownership or
16 jurisdiction of the disputed road; and

Allowing the State to transfer by quitclaim any 1 (2) 2 interest it has in a disputed road if the county requests title to the disputed road. 3 SECTION 2. Chapter 27, Hawaii Revised Statutes, is amended 4 by adding a new section to part V to be appropriately designated 5 6 and to read as follows: 7 "§27- Maintenance or repair of disputed public streets, roads, or highways; quitclaim. (a) Whenever ownership of a 8 9 public street, road, or highway remains in dispute between the 10 State and a county, any action by a government agency to maintain or repair a public street, road, or highway shall not 11 12 be used to establish the agency's ownership of, or jurisdiction 13 over, the public street, road, or highway and the agency shall 14 not be deemed to have assumed ownership of, or jurisdiction over, the public street, road, or highway solely because of 15 16 action to maintain or repair a public street, road, or highway. 17 (b) If a county requests or requires title to a disputed public street, road, or highway, the State may transfer by 18 quitclaim any interest it has in the public street, road, or 19 20 highway to the county.

3 No presumption that a county owns a particular street, (C) 4 road, or highway shall arise as a result of the county's 5 performance of the activities allowed by subsection (a) or (b). 6 (d) If a county requests or requires title to a disputed 7 public street, road, or highway, the State may transfer by 8 quitclaim any interest it has in the public street, road, or 9 highway to the county.

10 [-(d)-] (e) The general public shall have the unrestricted 11 right to use public streets, roads, or highways whose ownership 12 is in dispute between the State and the county to access the 13 shoreline and other public recreational areas; provided that 14 this subsection shall not apply to any private street, road, or 15 highway whose ownership is in dispute.

16 [(e)] (f) As used in this section [+

17 "Public recreational area"], "public recreational area" 18 means coastal and inland recreational areas, including beaches, 19 shores, public parks, public lands, public trails, and bodies of 20 water opened to the public for recreational use."
