SENATE CONCURRENT RESOLUTION

REQUESTING THE DEPARTMENT OF AGRICULTURE IN COLLABORATION WITH THE DEPARTMENT OF LAND AND NATURAL RESOURCES TO UPDATE LEASE AGREEMENTS FOR LANDS USED PURSUANT TO ACT 90, SESSION LAWS OF HAWAII 2003, HOLD A PUBLIC HEARING TO REVIEW AND UPDATE LEASES RELATED TO THE MANAGEMENT OF EXISTING NON-AGRICULTURAL PARK LANDS, AND SUBMIT REPORTS REGARDING ANY UPDATED LEASES AND LANDS TRANSFERRED, AND NOT YET TRANSFERRED, PURSUANT TO ACT 90.

1 WHEREAS, article XI, section 10, of the Hawaii State 2 Constitution states that "public lands shall be used for the 3 development of farm and home ownership on as widespread a basis 4 as possible, in accordance with procedures and limitations 5 prescribed by law"; and 6

7 WHEREAS, prior to 2003, the Department of Land and Natural
8 Resources was responsible for all public lands, including those
9 used for agricultural purposes; and

11 WHEREAS, the Department of Agriculture has the expertise 12 and necessary resources to manage lands used for agricultural 13 purposes and works with the agricultural community on a daily 14 basis on various issues relating to agriculture; and 15

WHEREAS, Act 90, Session Laws of Hawaii 2003 (Act 90),
established the procedures to transfer the management of certain
public lands that are available to be used for agricultural
purposes from the Department of Land and Natural Resources to
the Department of Agriculture; and

WHEREAS, the purpose of Act 90, is to ensure the long-term productive use of public lands leased or available to be leased by the Department of Land and Natural Resources for agricultural purposes by allowing these lands to be transferred to and managed by the Department of Agriculture; and

WHEREAS, section 166E-11, Hawaii Revised Statutes, 1 authorizes the Department of Agriculture to negotiate and enter 2 into leases with certain individuals to lease lands that are 3 used for agricultural purposes; and 4 5 6 WHEREAS, the Department of Agriculture has been derelict in 7 its duties prescribed by Act 90; now, therefore, 8 9 BE IT RESOLVED by the Senate of the Thirty-first 10 Legislature of the State of Hawaii, Regular Session of 2021, the House of Representatives concurring, that the Department of 11 12 Agriculture is requested to update lease agreements for lands 13 used pursuant to Act 90, to further the intended purpose of Act 14 90 of ensuring the long-term use of public lands for agricultural purposes; and 15 16 BE IT FURTHER RESOLVED that the Department of Agriculture, 17 Board of Agriculture, and Board of Land and Natural Resources 18 are requested to hold a public hearing to review and update the 19 20 leases related to the management of existing non-agricultural park lands pursuant to Act 90; and 21 22 23 BE IT FURTHER RESOLVED that the Department of Agriculture 24 is requested to submit a report on the status of entering into an updated lease agreement from the Department of Land and 25 Natural Resources to the Legislature no later than twenty days 26 prior to the convening of the Regular Session of 2022; and 27 28 29 BE IT FURTHER RESOLVED that the Department of Agriculture, 30 in collaboration with the Department of Land and Natural Resources, is requested to submit a report to the Legislature no 31 32 later than twenty days prior to the convening of the Regular Session of 2022 on their efforts to comply with this body; and 33 34 35 BE IT FURTHER RESOLVED that the report include: 36 37 (1) A list of all lands transferred pursuant to this body; 38 39 (2) A list of all lands that have not yet been transferred 40 pursuant to Act 90 and an explanation why each of 41 those lands have not been transferred; and 42
