
SENATE CONCURRENT RESOLUTION

REQUESTING THE HAWAII HEALTH SYSTEMS CORPORATION TO CONVENE A
TASK FORCE TO CONDUCT A FEASIBILITY STUDY FOR CONSTRUCTION
OF A HOSPITAL IN NORTH KONA AND A HEALTH CARE NEEDS
ASSESSMENT OF THE WEST HAWAII REGION.

1 WHEREAS, the population of North Kona on the island of
2 Hawai'i has significantly increased over the years, which has
3 corresponded with a steady increase in the need for convenient
4 access to medical services; and

5
6 WHEREAS, today the growing community of North Kona faces a
7 severe shortage of medical care and hospital services; and

8
9 WHEREAS, the residents of North Kona would greatly benefit
10 from the addition of a hospital in their community; and

11
12 WHEREAS, the accelerated and shifting economic and
13 population growth in North Kona has created a regional urban
14 core inconveniently far from Kona Community Hospital with a
15 population too large to be accommodated by the facility's
16 ninety-four bed capacity; and

17
18 WHEREAS, the island of Hawai'i is being impacted by the
19 coronavirus disease 2019 (COVID-19); and

20
21 WHEREAS, there are concerns about the shortage of staff in
22 hospitals on the island of Hawai'i due to demands created by
23 COVID-19; and

24
25 WHEREAS, there are also concerns that hospitals on the
26 island of Hawai'i will reach capacity and have insufficient
27 resources to adequately respond to COVID-19; and

1 WHEREAS, the island of Hawai'i has recently witnessed a
2 spike in COVID-19 cases, and a majority of those cases are on
3 the west side of the island of Hawai'i; and
4

5 WHEREAS, a hospital in the North Kona area would be
6 particularly beneficial should Kona Community Hospital become at
7 risk of surpassing its critical care and maximum bed capacity
8 due to COVID-19; and
9

10 WHEREAS, there has already been a long-time community
11 demand for a larger and more accessible hospital in North Kona;
12 now, therefore,
13

14 BE IT RESOLVED by the Senate of the Thirty-first
15 Legislature of the State of Hawaii, Regular Session of 2021, the
16 House of Representatives concurring, that the Hawaii Health
17 Systems Corporation is requested to convene a task force to
18 conduct:
19

20 (1) A feasibility study for the construction of a hospital
21 in North Kona; and
22

23 (2) A health care needs assessment of the West Hawaii
24 region; and
25

26 BE IT FURTHER RESOLVED that the task force is requested to
27 include the following members or their designees:
28

29 (1) A member of the Senate appointed by the President of
30 the Senate;
31

32 (2) A member of the House of Representatives appointed by
33 the Speaker of the House of Representatives;

35 (3) The Director of Health;

37 (4) The Regional Chief Executive Officer of the Hawaii
38 Health Systems Corporation, West Hawaii Region;

40 (5) A representative from Queen's North Hawaii Community
41 Hospital;

1 (6) A member of the West Hawaii Regional Health System
2 Board of Directors; and
3

4 (7) Any other representatives the Regional Chief Executive
5 Officer of the Hawaii Health Systems Corporation, West
6 Hawaii Region, or the Regional Chief Executive
7 Officer's designee, deems necessary; and
8

9 BE IT FURTHER RESOLVED that the Regional Chief Executive
10 Officer of the Hawaii Health Systems Corporation, West Hawaii
11 Region, or the Regional Chief Executive Officer's designee is
12 requested to serve as the chairperson of the task force; and
13

14 BE IT FURTHER RESOLVED that an initial meeting of the task
15 force is requested to be held no later than June 1, 2021; and
16

17 BE IT FURTHER RESOLVED that the task force, with the
18 assistance of the Hawaii Health Systems Corporation, is
19 requested to submit a report of its findings and
20 recommendations, including any proposed legislation, to the
21 Legislature no later than twenty days prior to the convening of
22 the Regular Session of 2022; and
23

24 BE IT FURTHER RESOLVED that the task force is requested to
25 be dissolved on June 30, 2022; and

27 BE IT FURTHER RESOLVED that certified copies of this
28 Concurrent Resolution be transmitted to the Director of Health;
29 Chief Executive Officer of the Hawaii Health Systems
30 Corporation, Corporate Office; Chief Executive Officer of The
31 Queen's Health Systems; and Regional Chief Executive Officer of
32 the Hawaii Health Systems Corporation, West Hawaii Region.
