

## II. Background and Summary

#### 1. <u>A brief description of the applicant's background.</u>

Aloha House, Inc. (AHI) was incorporated in 1977, when a group of concerned citizens recognized the need to have a residential facility on Maui to treat individuals with alcohol and substance use disorders. The organization's mission is to promote recovery and healthy lifestyles to individuals and families by providing compassionate, effective and comprehensive behavioral health services with the spirit of excellence and aloha.

AHI supports clients in its Residential Substance Abuse program by providing clinical supervision and evaluation, substance abuse treatment and treatment planning, counseling, crisis support, education, recreation and sober support activities. Clients may choose to participate in the Sober Living Program after they complete treatment. Here they have housing and sober support as they work toward reestablishing their lives, and accomplishing goals such as employment, education, and repairing relationships with family and friends. AHI is accredited by CARF, the Commission on Accreditation of Rehabilitation Facilities.

Aloha House is part of Maui Behavioral Health Resources, an umbrella organization of three nonprofit agencies: Aloha House, Malama Family Recovery Center, and Maui Youth & Family Services. All three agencies seek to provide mental health and substance abuse treatment to Maui residents. The three agencies merged in 2008 to share and maximize their expertise, reduce overhead costs and eliminate service duplication. While each maintaining their own non-profit status and independent missions, together they provide services to almost 8,000 individuals in the Maui community each year.

#### 2. The goals and objectives related to the request.

The overall goal of this funding request is to make improvement on two structures at the Aloha House Sober Living home at 720 Onehe'e Avenue in Kahului, so that they will be better suited to house clients in the Sober Living Program.

1. Increase client participation by 75%

Converting the current utility room in the main house to make it a full-sized, useable bathroom, will increase capacity to have six adults comfortably staying in this home, an increase from the five that live there currently.

Improvements to the downstairs space in the cottage to add two bedrooms, and add a bathroom and kitchen, will increase the capacity of the building to accommodate up to eight residents, where currently there are only three at this time.

These improvements will increase the potential number of clients from the current number of 8 to 14, or a 75% increase.

 Provide much-needed maintenance and upkeep to these homes, ensuring longevity for the use of the building, and thus lifetime of the Sober Living Program. The renovation of the kitchen in the upstairs unit of the cottage will help ensure its healthy, safe usage for many more years.

The renovation of the existing kitchen and bath in the main house, as well as replacement of the flooring, will ensure that the space is comfortable, safe, and fully usable for many more years.

#### 3. <u>The public purpose and need to be served.</u>

The Sober Living Program provides a much needed service for the Maui community by providing long-term "clean and sober" rental housing for single adults that are participating in or have completed intensive substance abuse treatment.

Substance use is a serious issue that can be devastating to individuals, and cause irreparable damage to those around them, including family members, coworkers, and the community. In 2018, nearly 1 in 5 people aged 12 or older (19.4 percent) used an illicit drug in the past year. It is estimated that 10% of Americans are considered addicts.

However, addiction is considered a highly treatable disease, and recovery is attainable. About 10% of American adults who are at least 18 years old say they are in recovery from an alcohol or drug abuse issue. From New York State Office of Alcoholism and Substance Abuse Services. (2012). *Survey: Ten Percent of American Adults Report Being in Recovery from Substance Abuse or Addiction*.

The Aloha House Sober Living Program (SLP) offers an important piece of the recovery process. The program provides a safe, substance-free living environment for individuals either recently discharged from Residential Treatment or in the early recovery phase. Services include psychiatric care related to substance recovery, sober support skills groups, help connecting with community resources, and case management. SLP allows clients to solidify the gains they made in treatment and generate different social circles to reduce the chance of relapse. In addition, it has been shown that providing living accommodations for those who need additional support greatly increases their chance for long-term recovery. This in turn reduces the likelihood of them committing crimes, becoming homeless, or becoming estranged from their family members, which are all typical consequences of substance use disorder.

To participate, clients must regularly test negative for drug use, be enrolled in outpatient treatment, and be working or actively seeking work and/or community volunteer activities. Providing affordable housing for individuals in long-term drug treatment recovery is particularly important to our community for several reasons.

1) Typically clients come into the program after many years of active drug use or incarceration, and have limited job skills or experience. Therefore, they have no assets, no money saved, and when they do get back to work, they often start in entry-level positions, many of which pay minimum wage (currently \$10.10 per hour in Hawaii).

- 2) With the high cost of housing on Maui, it is difficult for low-to-moderate-income workers to find safe, affordable housing. A studio can cost anywhere from \$800-\$1,500 per month, which is beyond the affordability for a person at a minimum wage job, who would only earn \$1,616 per month, before taxes.
- 3) When working on long-term recovery, it is important to have positive peer support. For many clients, returning to their family home is not ideal; this in fact may be where their drug use started. Living with other individuals, such as in a shared rental home, may expose them to persons who are using drugs or alcohol, increasing their chance of relapse. By living in a Sober Living Program home, clients can be ensured that they are in a safe, substance-free living environment.
- 4) Peer-to-peer support is an important aspect of long-term recovery. By living with others who are also striving to maintain sobriety, clients receive extra sober support on a daily basis.

Sober Living Programs are proven to aid long-term recovery from addiction. A study in California showed residents reduced or stopped their substance use between a baseline date and 6 month follow up, and then maintained those improvements at 12 and 18 months. Specifically, abstinence rates improved from 11% at baseline to 68% at both 6 months and 12 months after entering the program. (From *What Did We Learn from Our Study on Sober Living Houses and Where Do We Go from Here?* By Polcin, Douglas L., Ed.D., Korcha, Rachael, M.A., Bond, Jason, Ph.D., Galloway, Gantt, Pharm.D; California, Dec. 2010). This compares favorably to the rate of sobriety for clients who do not participate in Sober Living Programs. Typically, only 30% remain sober 12 months after completing a treatment program.

#### 4. Describe the target population to be served.

The Aloha House Sober Living Program currently serves 35 adults concurrently at 6 residential facilities. The planned renovations, as set forth in this proposal, would increase that number to 41, with the potential to serve 82 clients per year. Based on self-reporting, 93% of all Residential Treatment clients had incomes below 30% of the median income for Maui.

Clients are Maui residents who have completed substance use disorder treatment, either through the Aloha House residential treatment program or through outpatient treatment.

Based on the eligibility requirements of the State of Hawaii's Alcohol and Drug Administration Division (ADAD) and QUEST (Medicaid managed care) insurance programs, almost 70% can be verified as low- to moderate-income.

#### 5. Describe the geographic coverage.

This program primarily supports residents of Maui County, although occasionally clients from other outer islands may participate.

## III. Service Summary and Outcomes

#### 1. Describe the scope of work, tasks and responsibilities;

Specific to this request regarding the SLP home at 720 Onehe'e Avenue in Kahului, the scope of work includes:

- Main House Kitchen Update. This includes replacing all of the kitchen cabinets, countertop, sink and faucet, and range and refrigerator. A new microwave will be installed. The lighting and flooring will also be replaced, and the kitchen will be repainted.
- Main House Bathroom Update. This includes replacing the vanity, toilet, tub, tub surround, medicine cabinet, towel rods and flooring. The bathroom will also be repainted.
- Main House Utility Room. This project will convert a half-bath to a full bathroom. It includes removing the current utility sink from the room, relocating the washing machine within the room, and adding a shower, complete with proper waterproofing and drainage. The flooring will also be replaced, and the bathroom will be painted.
- Main House Flooring Replacement. This replaces the current flooring in the dining room, living room, hallway, and three bedrooms with click and lay plank flooring.
- Cottage Downstairs Area. This project converts a large storage area into a useable twobedroom unit. The space will include two bedrooms, a full bath and kitchen.
- Cottage Upstairs Area. Currently a two-bedroom unit, this project will provide a full renovation to the kitchen, including new cabinets, countertop, sink, faucet, range, refrigerator, light fixtures, and hot water tank. A new dishwasher and microwave will be installed. The kitchen will also be painted.

Aloha House and its affiliated agencies also have the following requisite resources and experience, including:

- Proven track record of providing quality behavioral health care in the Maui community for decades;
- High caliber of professional program staff and administrative staff;
- Sustainability and stability, as evidenced by repeatedly being awarded multi-year contracts and/or grants from many State and local government and private funding sources;
- State and national accreditation and licensing;
- Financial stability;
- Proven track record of successfully completing several capital improvement projects in recent years;
- High staff retention rates/low turnover;
- Strong leadership, including a diverse Board of Directors broadly representative of the Maui community.

With regard to program implementation and thus long-term viability of the project, Aloha House and its affiliated organizations have been providing behavioral health, substance abuse treatment, and related services for the target population since 1977. The three agencies employ a cadre of highly trained and skilled professional staff, including licensed psychiatrists, psychologists, social workers, marriage and family therapists, certified substance abuse counselors and prevention specialists who both oversee and deliver direct behavioral health care. In addition, Tri-Agency Partnership paraprofessional staff members are trained in evidence-based practices such as Motivational Interviewing and Trauma Informed Care. All three organizations are accredited by the Hawaii Alcohol and Drug Abuse Division and by the Commission on Accreditation of Rehabilitation Facilities (CARF). Tri-Agency Partnership residential facilities and foster homes are all State licensed, either by the Department of Health or the Department of Human Services.

Furthermore, the financial strength of the three agencies in the Tri-Agency Partnership combined with an ongoing need in the community for the services they provide further attest to the long-

term viability of this project and Tri-Agency Partnership programs. Aloha House, with its partner agencies Maui Youth and Family Services and Malama Family Recovery Center, is financially sound and has had many years of operation without running deficits. Facility operating costs will be managed and included in the Aloha House annual operating budget.

#### 2. Facilities

Current facilities at Aloha House allow for 40 beds for the Residential Substance Abuse treatment facility, and 35 beds in various Sober Living homes in the community. By making improvements to the current Sober Living home at 720 Onehe'e Avenue, an additional 6 beds will be available.

The current facilities are adequate for residential occupation by these clients. Sober Living Program homes are designed to be like a family home, with a warm, nurturing atmosphere. At this time, providing much needed maintenance and upgrades will ensure the viability of these homes and the Sober Living Program for years to come.



With his supervision and leadership, the organization has completed several important capital building and improvement projects. The CEO has ultimate responsibility for all agency services, programs, and projects. Mr. Cunningham will oversee the work related to this project.

The construction work will be conducted by a qualified independent General Contractor.
