Through community outreach, HHH identifies potential partner families who qualify for a Habitat home. Families participate in financial education and home ownership classes ensuring they are prepared for the financial obligations of home ownership. Once families are qualified, they are given a 30 year, no interest loan for their home, and HHH coordinates the volunteers and corporate donations needed to make their home a reality. Our partner families are required to give 'sweat equity' hours working right alongside our volunteers. Families work alongside Honolulu Habitat's staff and thousands of volunteers to construct their homes at 60% below market rate.

II. Background and Summary

1. A brief description of the applicant's background;

Honolulu Habitat for Humanity's (HHH) mission is to bring people together to build homes, communities and hope. HHH partners with low-income families to build decent homes, and renovate homes that have fallen into disrepair. HHH was founded in 1988 and has built more than 80 homes on the island of O'ahu, sheltering more than 400 people.

Our programs provide a permanent housing solution for low-income families that cannot be found through other housing programs. By working with a smaller number of people, HHH is able to dedicate hundreds of hours of staff and volunteer time to each family. As a result of this focused attention, HHH's programs see the following outcomes and positive changes in our community:

1) Our families keep their homes for the duration of their mortgage, and are able to take full advantage of low mortgage payments and grow financial equity.

2) Our families learn skills to maintain their homes in order to protect their investment and foster pride of homeownership that is passed down to their children.

3) Our volunteers get the direct hands-on experience of building a home for those in need. This fosters a sense of community and dedication that spreads awareness about housing issues and increases compassion and hope on our island.

These results are important because helping a low-income families attain homeownership affects not only the existing family, but improves the lives of the family for generations to come. HHH's builds not only homes, but a foundation for a family to change the direction of their lives and the lives of their children.

Our work hinges on collaborative partnerships across sectors. In partnership with organizations like Hawaiian Community Assets, Friends of Waimanalo and Council for Native Hawaiian Advancement, we conduct community outreach to identify families in need. We rely on our partners at the State of Hawaii - DHHL and Hawaii Housing Finance & Development Corporation (HHFDC)–to identify vacant parcels of land available for development. The work of Honolulu Habitat truly takes a village. It is vital that we be a trusted partner in the community. To this end, we spend significant time at local events, neighborhood meetings and community centers. This allows us to hear the concerns, challenges and

opportunities voiced by neighbors. Our impact is vast and multifaceted. At a national level, the impact of a Habitat home has been well-studied; conducted by surveying homeowners and their children over time on health, stability, education and community engagement.

2. The goals and objectives related to the request;

Honolulu Habitat for Humanity is applying for capital funding to build a fourbedroom, ADA accessible home to accommodate our partner families while their permanent homes are being constructed or renovated. It is estimated that our partner families will live in this transitional home for 3-5 months while their permanent home is being constructed. The maximum capacity would be 8 people. Having an opportunity to use this home during construction will save the families between \$3,400 and \$5,000 a month that they would have had to pay for a short-term rental.

3. The public purpose and need to be served;

The need for affordable housing in Hawaii is urgent. Hawaii's low-income residents face the highest cost of living in the nation, including the highest cost of housing. Prior to the pandemic, one in five households in Hawaii were extremely cost-burdened, paying 50% or more of their income on housing. In 2020, there was a shortage of 23,143 affordable housing units across the state. Hawaii residents face the highest cost of living and housing wage in the nation at \$38.76/hour.

Hawai'i has the highest rate of 'doubling up' in the country, where multiple generations live in one unit. Even Hawai'i residents at middle-income levels have trouble finding affordable housing or purchasing homes. A shortage of affordable housing, combined with relatively low wages, and rent increases means lowincome families are facing a severe housing affordability crisis. With a shortage of rental units in Hawaii, especially for low-income families, as well as a dramatic surge in housing prices since the pandemic started, the stability provided through homeownership is simply out of reach for most low-income families.

Housing affordability affects the overall well-being of our community. Housing instability has an overarching negative impact on our community - with such a large portion of people's income going towards housing, less resources are available for education, healthcare, and food. A decent place to live reduces barriers to opportunity, success and health, and benefits not only the current family, but future generations. Homeownership promotes wealth, income and asset building by acting as a forced savings mechanism and through home value appreciation. Homeownership is an indisputable social determinant of health. Research shows that stable housing promotes improved educational outcomes, higher earning potential, increased civic engagement and better health for children and adults. In comparison to renters, homeowners invest more time and

money in maintaining their homes, move less frequently, are more involved in their community and are more likely to volunteer.

4. Describe the target population to be served; and

Our target families are in the 30% (extremely low income) - 60% (very low income) range of Area Median Income (AMI) for the county of Honolulu. In general, our applicants are living in inadequate housing, living with other family members, or paying rent that overstretches their budget. Habitat homeowners begin to accrue equity immediately. A Habitat mortgage is typically 80% of the home's appraised value, meaning a family has 20% equity in their home on the day they move in. Every Habitat homeowner completes a required financial education class. This, combined with an affordable mortgage, empowers homeowners to achieve financial stability, budget household expenses and establish emergency savings.

Families who are receiving homes and renovation services have applied and been accepted as Honolulu Habitat for Humanity partner families, and will have an active role in the construction and completion of their homes. Supported by hundreds of other community volunteers, each family will contribute 'sweat equity' hours by assisting in the construction and renovation of their homes, and be required to attend financial literacy training to ensure they are able to pay their zero-interest loan payments. Housing costs for these families are greatly subsidized by in-kind donations, volunteer labor, and community support which makes homeownership a reality these low-income families could not otherwise attain.

5. Describe the geographic coverage.

Our service area is designated as the island of Oahu. The transitional home will be built in Waiahole or Waimanlo, where nearly 30 Habitat homes are slated to be built in the coming years.

Honolulu Habitat for Humanity is applying to the State of Hawaii GIA to build a four-bedroom ADA compliant transitional home for our partner families to live in while their permanent homes are being constructed. This will allow families in

need of shelter to live in the home 3-5 months while their home is being constructed. Once all scheduled homes are built in the area, the transitional home will be then transferred in ownership to a low-income family, providing permanent housing to one additional family.

Scope of work, tasks and responsibilities include:

- a. Work with HHFDC to lease a parcel of land in Waiahole or Waimanalo Village to build home. HHH is scheduled to build 9 homes in Waiahole and 20-plus homes in Waimanalo Village in the coming years.
- b. Secure permits, donations, volunteers and construction needs to build transitional home.
- c. Complete transitional home and begin housing partner families whole homes are being constructed.
- d. Once all partner families homes in area are complete, ownership of transitional home will be transferred from Habitat to a partner family, providing permanent housing for one additional family.
- 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;
 - July August 2022: Finalize lease for parcel of land with HHFDC
 - September 2022: Finalize and submit architectural drawings to DPP
 - October November 2022:Secure contracts for subcontractors needed

HHH's evidence-based model of self-help housing is drawn from the history and experience of its national affiliate, Habitat for Humanity International, which has over 40 years of experience as a global leader in addressing the issues of poverty housing. As part of a national network of 1,300 Habitat affiliates who have been serving a mission of bringing communities to build homes with low-income families, HHH has garnered invaluable experience and expertise in home building and repair. Habitat for Humanity is the largest residential home builder in the world, bringing the reputation, strength and backing of the Habitat International to the table. All of Honolulu Habitat for Humanity's programs, services, and activities were chosen because they fit into Habitat for Humanity International's evidence-based strategies, and can increase home ownership among low-income families in our community and give homeowners the skills to maintain and keep their homes.

HHH also bring strong public and private partnerships to the table, and continues to expand its knowledge of housing issues to best serve our community. HHH has built more than 80 homes on Oahu since our founding, sheltering more than 400 people. We have direct experience providing shelter, homeowner training, and financial literacy training. In the past 3 years, Honolulu Habitat for Humanity has built 11 homes,

renovated 4 houses in disrepair through the Home Preservation Program and worked with more than 6,000 volunteers.

Honolulu Habitat for Humanity's offices are located in the Kalihi area of Honolulu. This large facility space allows us to collect and store donations for our home builds.
