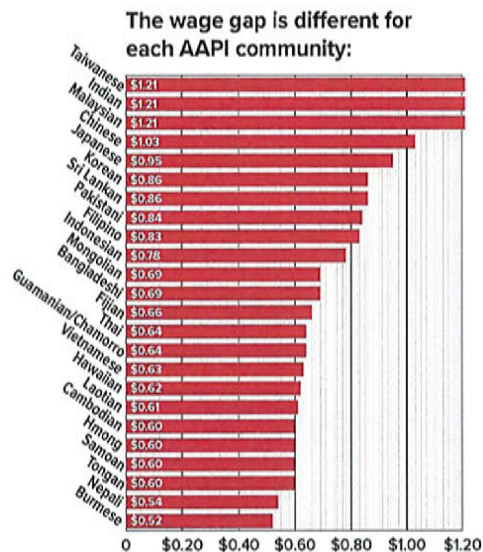
## Cultural Assistance

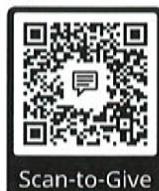
