#### II. Background and Summary

## 1. A brief description of the applicant's background;

**Malama O Puna** (MOP) is acting as a fiscal host for Hawaii Tracker. Malama O Puna, a 501c3 environmental education and community capacity building member supported organization since 2000 has managed dozens of grants in the last 22 years including two State GIA grants relating to reforestation of the Keau'ohana

Forest reserve. It has served as fiscal host to various community groups conducting lava recovery projects due to the 2018 volcanic eruption through funding from the County of Hawai'i. Under its Food Security program MOP has hosted multiple County and Hawaii Island Way grants to ensure sustainable food production and adequate food distribution in the Puna district.

**Malama O Puna** is supportive of the work done by Hawai'i Tracker to keep the public apprised of important information relating to potential natural disasters and is pleased to act as the fiscal host for this grant request. While there is a role for Civil Defense to play in notifying the public in real time regarding potential impacts from disasters, Hawaii Tracker has consistently provided more timely and accurate information to the public.

Hawai'i Tracker has provided reliable volcano and disaster information for Hawai'i Island in a complementary role to the US Geological Survey and Hawai'i County since the 2018 Kīlauea eruption, and has been publicly recognized for its work. Hawai'i Tracker's information was utilized by the Hawai'i Emergency Management Agency in their damage assessments during the 2018 eruption, and helped provide FEMA with the necessary documentation to grant Individual Assistance to the public during the 2018 eruption. Local community impacted by the 2018 eruption find Hawai'i Tracker to be more knowledgeable, accurate and prompt than all traditional news outlets, and scored Hawai'i Tracker higher in expertise, relevance, sincerity and pace than the USGS, according to USGS-backed research.

Information and education campaigns continue to be presented through an 88,000-member social media network, in written, short video, and live video broadcast formats, with additional in-person outreach events as possible and appropriate. In 5 months of the Puna Strong program in 2021, Hawai'i Tracker produced 106 articles, 46 short videos, and 33 live broadcasts, with a cumulative reach of 1,135,879 views and total of 169,016 interactions, spanning two Kīlauea summit eruptions. Hawai'i Tracker consists of two primary principals for this project, Philip Ong and Dane DuPont. Both Philip Ong and Dane DuPont have extensive experience in public information distribution, volcano and hazard messaging, digital communications, and community involvement.

## 2. The goals and objectives related to the request;

Hawai'i Tracker requests \$100,000 to fund a year-long volcano education and communication campaign, with the overarching goal of increased public understanding of current eruptions and better preparedness for future eruptions. This includes combating misinformation and damaging rumors surrounding our volcanoes, and guiding those in need of support to the appropriate resources.

The objectives related to this request are as follows:

- Produce monthly minimums of 16 written articles, 4 live broadcasts, and 4 short videos.
  - Short videos are typically less than 5 minutes, while live video broadcasts average 1 hour.
- Empower local non-profits and community organizations on Hawai'i Island to share their work and local events free of charge on Hawai'i Tracker's platform of 88,000 members.
  - Monthly minimum of 1 shared event related to eruption recovery, preparedness, or resilience when possible.
- Provide individual or group technical training and consulting in digital communications and social media practices for Hawai'i County grant recipients free of charge.
  - Yearly minimum of 6 groups based on Hawai'i Island for at least 1 hour each.
- Hawai'i Tracker aims to become more self-sustainable through partnerships and sponsorships with local businesses over the course of this project.

#### 3. The public purpose and need to be served;

Following the 2018 eruption, Hawai'i Island residents have heightened reactions to any changes on its volcanoes, and look primarily to social media for information and discussion from trusted sources.

While the USGS and Hawai'i County provide periodic updates in the interest of public safety, they are limited in their format, frequency and educational scope, especially during times of elevated volcanic activity. A full-time educational and communication campaign increases public awareness and leads to better preparedness.

In the absence of timely vetted information, rumors and concerns disrupt the local community and burden local government. Both the USGS and Hawai'i County have recognized the role of Hawai'i Tracker as a trusted source.

As the USGS information distribution and eruption response has become nationally centralized on the mainland following the 2018 eruption, Hawai'i Tracker offers a locally-based intermediary with established trust in the community and proven results. Many USGS scientists rotate through Hawai'i on time-limited work terms, providing invaluable experience for the national response teams, but at the expense of long-term relationships with the local community. Through multiple eruptions, Hawai'i Tracker has

demonstrated its value to the island community, adding resilience against volcanic and other geologic hazards through timely, vetted and scientifically sound information.

#### 4. Describe the target population to be served; and

The 2020 census showed the Island of Hawai'i's population increasing by 24% since 2010, with an even more dramatic increase of 66% in the District of Puna, most affected by Kīlauea's activity (Houghton, et al, 2021). There are now over 200,000 residents on Hawai'i Island, with many newly relocated residents that do not have knowledge of Hawaiian volcanoes or experience from past eruptions to rely upon. Note that developed areas around Hilo and Kailua-Kona have grown substantially since their last nearby eruptions, and are of special concern.

Hawai'i Island residents are thus the primary target population, especially those within the eruptive footprints of Kīlauea, Maunaloa, and Hualālai affected by lava flows within the past 250 years, but also their family and friends on- and off-island. More broadly, the project serves any resident seeking an understanding of volcanic hazards, impact zones and the scientific basis behind forthcoming evacuation plans tasked to HIEMA (2021 HI SR51), such as the USGS lava inundation maps revised in 2017 (USGS SIM 3387).

Affected and traumatized residents of Puna impacted by and still recovering from the 2018 eruption are also a focus in this work. Even now in 2022, residents are triggered by felt earthquakes, brush-fires, and vog, and continue to deal with the mental health effects of the eruption.

Potential visitors to Hawai'i Island and the local tourism economy as a whole will also benefit from the long-term educational campaign. Thousands of potential travelers use Hawai'i Tracker before and during their visit to Hawai'i Island, and with accurate information in-hand instead of media sensationalism, they are able to make an informed decision on whether or not they need to alter a planned visit. Further, Kīlauea's 2018 eruption had a significant economic impact beyond the area of lava flows in Lower Puna. According to the County of Hawai'i, tourism losses were estimated at \$415 million around the island in the year following the start of the eruption, and 2,950 people lost their jobs as a result. The Governor and tourism agencies made public pleas for visitors to maintain their travel plans, such was the effect of cancellations due to misinformation.

#### 5. **Describe the geographic coverage**.

Hawai'i Tracker is centered on Hawai'i Island, with a focus on communities most at risk to the island's volcanic hazards, like Hawaiian Oceanview Estates and Puna that are highly exposed to the rift zones of Mauna Loa and Kīlauea respectively. The residents of these rapidly developing areas in Lava Hazard Zones 1 & 2 are more prone to rely on information provided by Hawai'i Tracker, but our coverage of the volcanoes extends across most of the island, as do the volcanic hazards.

Our reach also extends to the other Hawaiian islands, the mainland and abroad. Based on Facebook and YouTube analytics, our present viewership of 88,000 is roughly 51% on-island, 19% on neighbor islands, 26% in the mainland US, and 4% international. Viewers are about 65% female, and 62% are 35 or older. On island, 65% reside in Puna and Hilo, reflecting the communities affected most recently by the 2018 eruption. This broad viewership is possible because the produced content is freely accessible online and archived digitally, allowing the coverage to grow with minimal overhead costs.

#### III. Service Summary and Outcomes

### 1. Describe the scope of work, tasks and responsibilities;

The project funds two principals to deliver volcano education content in the 3 chosen formats, establishing monthly minimum benchmarks based on the previously-trialed content production from May to August 2021 as part of the Puna Strong grant.

The educational content must be relevant to current volcanic events and public interest, yet timely when addressing significant volcanic changes of public concern. Official releases and information from the US Geological Survey and Hawai'i County agencies will be relayed to the public and clarified as needed, providing researched context as appropriate. Current scientific data, historical events and lessons may be incorporated into educational content during periods with no official releases. At all times, the presented information should strive to be easy for the public to understand.

Content will be delivered via the existing Hawai'i Tracker platform and vast social network, which must also be maintained through curation and moderation, but offers added benefit to the island community. As part of this project, Hawai'i Tracker will empower other community and non-profit groups with social media training and access to the distribution network, broadening the impact of their community work.

Depending on the content format, production includes research, writing and editing, video and sound recording and editing, and live video broadcast preparation and execution. After publication, public engagement follows through interactions on social

media. Non-production responsibilities will include documentation of content and administration of multiple grants; communication, meetings and networking with Hawai'i County and USGS representatives; and maintenance of the digital Hawai'i Tracker network.

# 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Many activities will occur repeatedly throughout the 12-month grant period, while others are more flexible. A summarized timeline chart is included below.

#### Quarter 1

- Outreach to various community partners and local non-profits to gather information for upcoming events and to inform them about using Hawai'i Tracker's online platform to promote their work.
- Create a calendar of events relating to volcano education, eruption preparation and recovery, or community building for the project period.
- Produce and publicly share 48 written articles, 12 live broadcasts, and 12 short videos, to be freely available online.
- Share one event related to volcano education, eruption preparation and recovery, or community building.

#### Quarter 2

- Maintain monthly minimums for written articles, live broadcasts, short videos, and related events.
- Plan and coordinate a Hawai'i Tracker training event for group technical training and consulting in digital communications and social media practices.
- Outreach to new areas on Hawai'i Island and recruit partners.
- Train new staff and volunteers ongoing.
- Review progress toward deliverables, adjust systems to ensure compliance.
- Attend and coordinate with other Hawai'i Island based groups, like the Puna Strong Cohort.

#### Quarter 3

- Maintain monthly minimums for written articles, live broadcasts, short videos, and related events.
- Promote and host the Hawai'i Tracker training session.
- Cultivate new partners and funders ongoing.

#### **Quarter 4**

- Maintain monthly minimums for written articles, live broadcasts, short videos, and related events.
- Finalize project and analyze cumulative data.
- Complete project and submit final report.

As content is presented online on social media platforms, there are several built-in metrics for viewer reach and interactions compiled by each platform, with additional direct feedback from participants available through personal messages and public comments. These direct interactions are the primary means of quality assurance, which will be monitored on a near-daily basis.

Full statistics will be compiled monthly for each of the 24 produced content pieces and analyzed for trends across every platform, with the goal of increased viewership, interactions, and total subscribers each month. These data will be used to guide content production choices to improve results, keeping in mind that viewership is also affected by the level of volcanic activity. Quarterly reviews will also be used to inform improvements to the production system.

**Malama O Puna's** grant record for the prior three years (2019-2021) and proposed grants applications for 2022-2023 are included on the attached sheet provided with th GIA packet entitled *Government contracts, grants, and grants in aid.* 

**Hawai'i Tracker** was awarded a Puna Strong grant for \$15,000 by the Hawai'i Community Foundation on behalf of Hawai'i County in April 2021, with Kuleana Pahoa as its fiscal sponsor. Hawai'i Tracker will apply for another Puna Strong grant if there is a second round of grant requests as being discussed by Hawai'i County for some time in 2022 which will extend into 2023.

6. The applicant shall provide the balance of its unrestricted current assets as of December 31, 2021.

**Malama O Puna** has no physical assets, although it maintains an old plantation cottage in Pahoa Town that is provided rent free and which includes office spaces, a large meeting room, an outdoor area for workshops, and expansive front and back yards that have been transformed into a demonstration urban and permaculture garden. As of Dec. 31, 2021, Malama O Puna retained \$19,406 in unrestricted funds in its Operations Account at First Hawaiian Bank and \$29,464 in its reserve funds with Edward Schwab.

Hawai'i Tracker has no assets to disclose.

# V. Experience and Capability

1. Necessary Skills and Experience

Malama O Puna is acting as the fiscal sponsor for Hawai'i Tracker. The funding will be allocated to two full-time Information Officers who have worked and volunteered with Hawai'i Tracker over the last three years. In the previous three years, Hawai'i Tracker has grown in membership from roughly 3,500 members to 88,000 members at the time of writing. Hawai'i Tracker's group on Facebook has one of the widest audiences available that focuses on Hawai'i Island, including contributors such as professional

photographers, scientists, and community members potentially impacted in future disasters. Hawai'i Tracker is also growing its audience on YouTube and Twitter, with plans to add additional platforms as possible. In the last 60 days (Nov 13 to Jan 11, 2022), Hawai'i Tracker's posts on Facebook have generated 1,480,571 page views.

Hawai'i Tracker has produced thousands of posts relating to Hawai'i's volcanoes and participated in dozens of community events over the last three years.

Acknowledgements of Hawai'i Tracker's effectiveness have come from the Big Island Press Club, which awarded Hawai'i Tracker with "Excellence in Media Innovation" in 2019, from Facebook which produced a video promoting our work connecting displaced residents with accurate information during the 2018 eruption, and letters of recognition and support from our local government representatives, including recognition from the County of Hawai'i on April 17, 2019 (Certificate No.5342).

What makes Hawai'i Tracker uniquely able to accomplish the goals outlined in this project is the trust that has been established with the local community. Haney and Havice (2019) polled residents during the eruption and reported, "Internet sources and their popularity, particularly social media, offered invaluable updates as the eruptions progressed. A Facebook group called 'Hawaii Tracker' emerged as the go-to resource for many residents." Furthermore, in research backed by the USGS and presented at the AGU Fall Meeting 2021 by Goldman and others, Hawai'i Tracker outperformed all other sources of volcano information in all identified metrics, including the USGS Hawaiian Volcano Observatory.

**Malama O Puna** will act as fiscal sponsor for Hawaii Tracker and provide administrative support for the project. The organization's Executive Director is responsible for supervising and providing administrative support for all grant programs and will provide oversight for this project with Hawai'i Tracker.

Eileen O'Hara, M.S., Ph.D. is the current part-time Executive Director of Malama O Puna. She has her masters and doctorate degrees from the University of Hawaii at Manoa in Natural Resource and Environmental Economics. She is currently the part-time Executive Director of Malama O Puna. She has thirty years of experience managing nonprofits, is adjunct faculty with the University of Hawaii at Hilo, College of Business and Economics (CoBE) teaching economics, and is also an adjunct with Purdue University Global, School of Legal Studies, teaching Public Administration/Policy and Environmental Management/Policy courses for that institution.

Hawai'i Tracker consists of two principals for this project, Philip Ong and Dane DuPont.

Philip Ong earned a masters in Geology from the University of Michigan and a bachelors in Computer Science from UNC-Chapel Hill, having worked for 13 months during 1999-2001 as a volunteer and contractor with the USGS Hawaiian Volcano Observatory. Philip founded and ran VolcanoDiscovery Hawai'i tours from 2010-15, earning the Hawai'i Ecotourism Association's state-wide Ecotour Operator of the Year in 2012-13, and training two Hawai'i Island winners of Ecotour Guide of the Year in 2013 and 2014. He then founded Eruption Software to develop the EruptionLens App for iOS. Since then, Philip has become one of primary sources of information trusted by the community on our geologic and volcanic hazards, in large part due to his role providing much needed information and education to the community in the 2018 eruption. In addition to daily update livestreams, Philip provided the community with inperson support at the Pu'uhonua O Puna community hub through the end of the eruption, sharing his ability to articulate complex topics to those familiar and unfamiliar with our volcanoes.

Dane DuPont graduated from the University of Hawai'i, Hilo with a bachelors in Computer Science and a background in information security and networking. He has served as the primary Hawai'i Tracker Administrator since 2018, while working as an information technology specialist. Dane was the lead developer and researcher behind the "Homes Lost Map" which documented in near real-time the loss of homes to lava during the 2018 eruption. These data became a primary reference for the Department of Defense and the Hawai'i Emergency Management Agency in the State's application to FEMA for Individual Assistance to help impacted residents with federal funding. Dane has written hundreds of short and long articles relating to Hawaii's volcanoes in the last three years, and has produced hundreds of videos in the same period, including the lead producer, editor and cinematographer for Malama O Puna's eruption recovery video, "We Pick Up And Move When She (Pele) Comes ~ A Kīlauea Eruption Recovery Story", released July 1, 2021.

Finally, in the 3+ years since the 2018 eruption, Philip Ong and Dane DuPont have produced 124 short videos and 145 live video broadcasts totaling over 170 hours on-air, along with an average of 20 written articles per month in 2021, all detailing the changes on both Kīlauea and Maunaloa, as well as other natural hazards, while steadily improving in quality, distribution and viewership.


### 2. Organization Chart

Below is the Organization Chart for Malama O Puna a membership organization. Per the organization's Bylaws, the board is served by four officers and additional board members. At this time, there are a total of seven board members. The Bylaws allow for an Executive Director who is responsible for applying for, implementing and reporting on all grant programs, is a signatory on all bank accounts, and is authorized to enter into contracts on behalf of the organization.

In addition, the organization employs a Certified Public Accountant as a contractor and has utilized contracted Project Coordinators as needed to implement specific grantfunded programs. Those contracted positions are overseen by the Executive Director who reports to the Board of Directors at monthly board meetings. The organization provides an opportunity for student interns from the local high schools and the University of Hawaii at Hilo. These positions are also overseen by the Executive Director. Currently one intern is working with the organization from the Hawaii Academy of Arts and Sciences (HAAS) in Pahoa which is a public charter school.

Aloha,

Mainstreet Pahoa Association (MPA) is the primary organization representing the businesses and community of Pahoa and surrounding populated areas of Lower Puna. In 2018 when the area experienced the most significant volcanic eruption in over 100 years, Hawai'i Tracker set itself apart from other entities by being able to report information that was accurate, efficient, and did so from points close to the eruption sites. This on-spot and timely reporting was followed more closely on social media by our resident population, as well as followers from around the world, than any government or media sites reporting on the event.

If provided with the proper funding, Hawai'i Tracker can both expand its reach and become more self-sufficient, making it a key player in education on our volcanoes and recovery efforts. Since the eruption, MPA has stood up the Pahoa Lava Zone Museum to inform residents and visitors about our volcanic island. The role played by Hawai'i Tracker assists our effort to fully inform people on how to safely view and access the vistas created by the 2018 lava flows.

We recognize that visitors are attracted to islands for its natural beauty and we want them to have the best information possible to enjoy their visits while being made aware of the need to respect our 'aina and to be safe in their explorations of this beautiful place. We find that Hawai'i Tracker delivers a well-rounded content when educating visitors and residents about our volcanic island and that people find their articles and broadcasts understandable. While we recognize that there are federal and state agencies dedicated to providing similar information, the approach taken by those government agencies often results in the public being confused by the messaging. Hawai'i Tracker does a great job with messaging in a manner that the average person can understand and feel confident that they've received good information.

We strongly urge you to consider the State Grant-in-Aid proposal being submitted by Malama O Puna on behalf or, and as the fiscal host for, Hawai'i Tracker.
