II. BACKGROUND AND SUMMARY

1. Applicant Background Information

Duane DeSoto and Mālia Kaʻaihue founded Nā Kama Kai in 2008. The mission of this non-profit organization is to create, conduct, and support Hawaiian cultural-oriented, marine-based programs, that empower youth to thrive in their community through ocean safety and stewardship learning opportunities that build self-confidence, leadership, and integrity.

Nā Kama Kai Programs are designed to guide youth to fully appreciate and understand the importance of the ocean as part of our natural world, by helping them become "ocean intelligent". Such learning occurs through guidance and experience in a nurturing environment where keiki learn how to be safe in the marine environment, grow physically and emotionally through interaction with the ocean, and develop overall respect for nature using the ocean as a connecting force to all living things.

2. Goals and Objectives

Reduce the drowning rate of youth in the State of Hawai'i focusing first on counties with the highest rates of incidence.

Inspire Hawai'i's keiki (children) and kumu (teachers) to become "ocean intelligent".

Guide Hawai'i's keiki to grow physically and emotionally connected to the ocean, empowering them both in and out of the water.

Provide the knowledge required for State of Hawai'i teachers to teach Ocean Safety in their classrooms.

Provide Ocean Safety curriculum and resources for State of Hawai'i teachers to use in their classrooms.

Provide access to safe, culturally-based environments for ocean education.

Combine culture, ocean safety, stewardship/conservation, and personal kuleana (responsibility) into a comprehensive and accessible program.

3. Public Purpose and Need Served

Despite living minutes from the ocean, many of our keiki in Hawai'i are raised without a connection to nature. This lack of connection to the natural world is becoming an issue in many other countries and threatens the health of natural resources around the world. Nā Kama Kai has great concern for this growing condition and the need for Hawai'i's keiki to become more aware of the need for ocean conservation. Nā Kama Kai strives to guide youth to fully appreciate and understand the importance of the ocean as part of their natural world.

Additionally, the lack of ocean safety awareness among Hawai'i's youth is of great concern to Nā Kama Kai. Hawai'i ranks among the nation's top ten states for youth-related drowning deaths. While some of the drownings are associated with the tourist industry, 55% of drownings are Hawai'i residents. Hawai'i's Department of Education has recently taken steps to require Ocean Safety education in at least one grade K-5 at all DOE elementary schools by May 26, 2022. This directive was given by Keith T. Hayashi, Interim Superintendent on November 24, 2021. The DOE has requested assistance from Nā Kama Kai to meet this educational responsibility by creating teacher and student Ocean Safety Curriculum.

4. Target Population to be Served

The target population will include all keiki and teachers in DOE schools at or near the 4th grade across the State of Hawai'i. Counties will be prioritized based on the most recent drowning data from the State of Hawai'i Department of Health.

III. SERVICE SUMMARY AND OUTCOMES

1 Scope of Work, Tasks and Responsibilities

PDE3 Credit Course for State of Hawai'i DOE Teachers – Ocean Safety Education

Nā Kama Kai will design PDE3 Courses to certify teachers in Ocean Safety and equip them with the materials needed to teach the content in their classrooms. The courses will include location-specific content by county/region to encourage buy-in and ownership of content and place. The courses will be administered by each county to focus on the highest drowning rates based on the most recent State of Hawai'i drowning data.

Implementation in FY 2023 will include the facilitation of one course per county. This course is designed as a 2-day synchronous, immersion experience for up to 30 educators in or near Grade 4, taught by Nā Kama Kai staff, regional ocean and swim safety experts, and education facilitators. We envision that the core team of Nā Kama Kai staff and a representative from the education support team will be present at all clinics in addition to regional/local ocean experts, and therefore require travel support.

Each 2-day experience will be followed by 2, half-day synchronous virtual meetings focused on curriculum development, as well as office hours for teachers to make appointments to review the content they are developing to support the building of ocean and swim literacy. Portfolio requirements will include a demonstration of professional learning related to increased ocean intelligence for teachers, as well as the design and implementation of lesson plans that reflect a goal of increasing ocean intelligence in students. Classroom sets of Nā Kama Kai resource materials will be provided for each participating teacher to utilize in their implementation.

Currently, we are developing this course and professional development trajectory with Education Incubator, a local Hawai'i non-profit known to be a leading expert in place-based, innovative teacher professional development and curriculum design.

"Lessons from the Sea" Animated Videos

- Nā Kama Kai started a project to produce 5 animation videos teaching the 5 learning stations offered at our Ocean Clinics. These include our Ocean Safety Station, Way-Finding Station, Ocean Experience Station, Outrigger Canoe Paddling Station, and our Stewardship and Conservation Station.
- Each video will be approximately 5 minutes and can be used as resources for teachers as they build their lesson plans for their PDE3 course and classroom implementation.
- Twiddle Productions, Inc. is creating the animated videos in partnership with Nā Kama Kai.

Here is a description of the Nā Kama Kai learning stations whose concepts are included in the resources and materials listed above.

LS 1. Kai Palekana (Ocean Safety) Station:

- K.A.I. Ocean Safety
 - o **Know** your limits Listen to your *na'au* (gut feeling).
 - ✓ Knowing to listen is important traditional knowledge.
 - ✓ What are your capabilities? On land and in the water.
 - o **Ask** a lifeguard or responsible adult.
 - ✓ Never swim alone.
 - ✓ Swim/surf at Lifeguarded beaches if possible.
 - o **Identify** the hazards.
 - ✓ Take 5-10 minutes to study the environment.
 - ✓ Identify wind direction and speed, wave direction and size, current direction and speed, vessels (surfboards, boats, etc.) in the immediate area, and other people who may be potential hazards to your safety.
 - ✓ *Keiki* learn and discuss different safety signs that are posted on beaches.

LS 2. *Hoʻokele* (Wayfinding) Station:

- Traditional wayfinding and navigation taught through the use of a star compass banner.
- Knowledge of wind patterns, currents, swells, birds, and stars required for successful travel.

LS 3. Holo Kai (Ocean Experience) Station:

- Hands-on, one-on-one (mentorship) ocean experience surfing or standup paddling.
 - Safe ways to use ocean recreational equipment.
 - Health benefits of being active in the ocean

LS 4. Wa'a (Outrigger Canoe Paddling) Station:

- Perspective of the island from the ocean. Identify the valleys where rivers bring water that includes waste and pollution to the ocean.
- Opportunity for *keiki* to swim in deep blue water with their life vest on and give them a chance to build self-confidence under careful supervision.

LS 5. Mālama Kai (Conservation/Stewardship) Station:

- Papahānaumokuākea Education
 - Kupuna Islands are a part of the State of Hawai'i.
 - Hawai'i is the endangered species capital of the world.
 - Marine debris from all over the world including Hawai'i.
- Where Hawai'i is located in the Pacific Ocean (Oceania).
- Buy In It is "MY" kuleana to mālama 'āina / mālama kai (care for the land and sea).

Compliance Training Module – Ocean Safety Education

Nā Kama Kai will design and produce a 15-minute training video to brief participants on the basics of Ocean Safety. This module will be available for DOE schools to utilize as education before field trips that include beach or ocean experiences at State or City Parks.

V. EXPERIENCE AND CAPABILITY

1. Necessary Skills and Experience

Nā Kama Kai has been in operation since May of 2008 and a total of approximately 30,000 keiki have attended Ocean Safety and Conservation Awareness Clinics over the last 14 years. Based on current enrolment rates approximately 1,200 children will attend ocean clinics in fiscal year 2023. This also assumes COVID-19 restrictions allow for safe outdoor gathering.

Nā Kama Kai ocean clinics are advertised largely by "word of mouth" and yet there is still a great demand that exceeds our current capacity. There are no other organizations that provide this service to the youth in the state of Hawai'i or in any other coastal community in the world.

Nā Kama Kai activities proposed here are ongoing and targets all youth in many different cultural settings. The Ocean Safety and Conservation Awareness Clinics are held primarily on the island of Oʻahu, and whenever possible the other neighbor islands in Hawaiʻi. Ocean clinics have also been successfully held in Brazil, Tahiti, Japan, and California incorporating place based cultural values and traditional knowledge into Nā Kama Kai's program model. To date Nā Kama Kai has conducted over 150 Ocean Safety and Conservation Awareness Clinics and 16 Alaka'i Instructional Camps.

In 2021 Nā Kama Kai conducted 1 Ocean Safety and Conservation Awareness Clinic due to the restrictions and risk that the year saw with COVID-19 surges. During that time the organization restructured for long term growth hiring its first Chief Operations Officer. Work begun to strengthen internal processes in increase capacity and capability. The Lessons from the Sea Animated Series project started with a rigorous request for proposal selection process and Nā Kama Kai partnered with Education Incubator initiating a H.O.P.E. (Hawaii Online Portal for Education) Content Institute to invite teachers to work with local watermen and waterwomen to build ocean safety curriculum for school classrooms. This partnership helped Nā Kama Kai to learn more

about what is required in the formal education environment for keiki and led to its partnership with Education Incubator on this request.

In 2020, Public health measures to control the COVID-19 pandemic led to the closure of our public beaches in March 2020. The stay-at-home order presented new challenges and opportunities for innovation. Nā Kama Kai met the challenge to positively influence the lives of Hawai'i's keiki. Nā Kama Kai partnered with Wai'anae Coast Comprehensive Health Center to feed keiki on the Wai'anae coast who lost an important source for nutritous meals when public schools were forced to close. Nā Kama Kai partnered with numerous organizations and by the end of May the efforts had helped distrubute 84,800 meals, 46,930 lbs of pantry bags, 40,873 lbs of local produce, and 14,200 take home meals. Nā Kama Kai contributed \$33,400.00 to this project and provided hundreds of volunteer hours. Under the guidance of master shaper Tom Pohaku Stone and while maintaining COVID-19 safe protocols, 20 Alaka'i Program participants learned how to make a traditional Hawaiian Alaia or 'Ōnini surfboard. Nā Kama Kai worked with the HAKU Collective to produce six original songs and one original oli that reinforce the learning objectives of our ocean clinic learning stations. Some of these songs were featured dring our virtual Pa'akai Gala (annual and first time televised fundraiser). Kimié Miner's song "Children of the Sea" hit #1 on music charts in Hawai'i.

In 2019, Nā Kama Kai conducted 12 Ocean Safety and Conservation Awareness Clinics. 735 keiki attended our Clinics on the island of Oʻahu at no cost. Each Clinic was staffed by 9 professional service workers and between 40 – 75 volunteers. Nā Kama Kai also completed the lease of Harvey Hale from the USAG-HI securing a 1.25 acre lot with a two bedroom house at Pililaʻau Army Recreation Center in Waiʻanae. This was the first opportunity since creation in 2008 that Nā Kama Kai will have a home base of operations. Nā Kama Kai provided a type of exchange program for Alakaʻi particpants to Brazil. The gorup shared in local cultural practices and offered an Ocean Clinic while in Brazil and keiki from Brazil came to Hawaii to do the same. A documentary film was produced showcasing this amazing partnership.

Supervision - Nā Kama Kai understands the importance of supervision during all stages of working with youth. Our programs follow a logical "chain of command" that starts at the top. The CEO supervises the COO and the COO supervises the Program Directors and serves as a backup to the Program Coordinator as appropriate when necessary. Similarly, the Program Director oversees activities conducted by the Coordinators and Special Project Instructors. The Program CEO is accountable to the Nā Kama Kai Board of Directors. The CEO oversees and supervises all activities conducted by Nā Kama Kai and the COO is responsible to ensure the Program Directors implement the Ocean Safety and Conservation Awareness Clinics and Alaka'i Program. Training - Nā Kama Kai has two levels of training designed to meet the need of the organization. The first and foremost priority is to ensure the safety of all involved in Nā Kama Kai activities. To that end NNK ensures that at least 4 certified CPR and First Aid staff or volunteers are present at all Nā Kama Kai ocean clinics. All staff and volunteers are notified when First Aid and CPR training is available.

This grant will support the statewide system of public schools and not any sectarian or nonsectarian private educational institution.

4. Future Sustainability Plan

Upon receiving the Grant in Aid grant for fiscal year 2023 Nā Kama Kai will continue to work diligently on strengthening our programs and fund development strategies. We have five components included in our strategies for fund Development. Our annual Pa'akai Gala fundraiser, Merchandise Sales, individual donors cultivation, major gifts, and Grants.

The Pa'akai Gala is our Annual fundraising concert/diner. To date we have successfully run 10 Gala's. The first annual Pa'akai Gala was held at the Pacific Club where we netted a profit of \$24,000.00. The second annual Pa'akai Gala was held at the Hale Koa Hotel where we netted a profit of \$30,000.00. In 2020, we had to transition from in person to broadcasting the Pa'akai Gala due to COVID. We netted \$78,000.00 which was our best fundraiser to date! We broke that record in 2021 with the 2nd televised Pa'akai Gala netting \$185,000!

Merchandise Sales will be a big part of Nā Kama Kai's advertising and fundraising. We expanded our merchandise on our website in 2021 and plan to continue to grow this offering. This will allow us to not only sell items at our existing events but to also sell to a national and international market.

Cultivating our donor list to engage individual donors will be important to our success in the future. In 2019, non profit organizations across the United States received 60% of their funding from this source. We receive less than 10%. We have had some success with major gifts and believe the purity of our mission has to potential to get much more.

Grants are an important source of Nā Kama Kai's ability to grow our services. Grant in Aids funding will help us demonstrate to other funders that we are being funded by various agencies outside of the private and federal sectors. This grant will be key in funding our full time positions allowing us to write more grants that are program focused, thus allowing Nā Kama Kai to bring a better product to more children in Hawai'i.

If Nā Kama Kai were not receiving funding from Grant in Aid after fiscal year 2023 we would be stronger from its previous support and use the gained knowledge and experience to seek out a replacement. Executing our fundraising programs as planned should provide us the financial ability to sustain at the same level of output. We would
