

The Special Education Center of Hawaii (SECOH) requests capital support for the public purpose of providing individuals with disabilities with education, job training, recreation, community integration activities, and skills to develop independence and improve their quality of life.

II. Background and Summary

The Special Education Center of Hawaii, dba SECOH, (SECOH) is a nonprofit organization founded in 1965 with the mission to provide personalized services to individuals with disabilities in the spirit of enriching their lives. Our vision is for all people to be valued and treated with dignity and respect.

SECOH began as a school for children with special needs, and expanded in the 1980s when Waimano Home was deinstitutionalized, and many of their residents were admitted to SECOH for care. Today we continue to serve approximately 80 of these individuals, now age 50 to 70, with Adult Day Health (ADH) services.

In 2015 SECOH expanded with the establishment of the Pathways Program to address the demand for services to the population of young adults with disabilities that are aging out of the Hawaii Department of Education (DOE) public schools. SECOH currently serves 65 adults in the Pathways Program with 36 adults currently on the admission waitlist.

Programs - The services provided by SECOH are a priority of the Hawaii Department of Health, Developmental Disabilities Division (DOH DDD), designed to help sustain people with disabilities in the community, support them to achieve their potential, and assist them to have "healthy, safe, meaningful and self-determined lives." Services provided by SECOH through DOH DDD contracts include:

- *ADH and Pathways* SECOH provides group recreational and educational activities for individuals with disabilities in two programs: ADH for older individuals with disabilities that require more intensive support; and Pathways for younger more capable individuals with disabilities that have the capability for greater community integration.
- Personal Assistance Services (PAB) SECOH provides individualized services designed to improve self-help and independence skills.
- *Community Learning Services (CLS)* SECOH provides individualized services to improve skills necessary for community integration.
- Respite SECOH provides respite to families that are caregivers of individuals with disabilities.
- Vocational Assessment and Skill Development SECOH provides services that build job skills, including housekeeping, managing the snack shop, yard work, and volunteering at various nonprofits in the community. This is a program service currently in development.

2. The goals and objectives related to the request;

This overall goal of this project is to expand and enhance the capacity of SECOH to serve individuals with disabilities by making capital improvements to the Diamond Head Campus.

Objective 1: Renovate the administration building to create a new job and life skills center (\$253,790) – Renovations will be made to the interior so that the building can be used for a new job and life skills center.

Objective 2: Renovate Building D to increase capacity to serve more clients (\$119,962) – A 5,500 sq. ft. building that was constructed in 1978 is currently unusable and unsafe. The lanai will be enclosed to expand the interior to 6,300 sq. ft, and be reconfigured to include three "great rooms" for group activities. This will enable the Pathways program to grow by 20 clients.

Objective 3: Renovate the swimming pool house (\$162,179) – SECOH has one of the few swimming pools on the island specifically constructed for individuals with disabilities: it has a ramp into the water so that individuals may walk into the pool; and those who use wheelchairs

may remain seated in a water chair and pushed down the ramp and into the pool. The pool is used by SECOH's clients from both locations on Oahu, students from Variety School (a nonprofit school for 20-25 children with learning disabilities), and clients of from the ARC in Hawaii (a nonprofit residential and day health program for 40-50 adults with disabilities). On the week day evenings and weekends, it is used by Leahi Swim School, a program that serves approximately 300 children on Oahu (pre-pandemic enrollment). The pool house was constructed in 1983, and there have been no improvements made to the plumbing and electrical systems since that time, and the structure is in dire need of improvements.

3. The public purpose and need to be served;

Need to improve the quality of life and independence of individuals with disabilities - Recreation, employment, and community integration for individuals for disabilities are services are the core services of SECOH. These activities are also evidence-based methods that improve the quality of life of our clients. By enhancing and improving our programs, we are able to better individualize our services to meet the needs and interests of each client. Development of job and volunteer skills will enable our clients to better integrate into community activities, and also fosters a sense of purpose and achievement.

State priorities – SECOH provides services that are a priority of the Department of Health, Developmental Disabilities Division (DDD) strategic plan goals, which states individuals with disabilities: have opportunities to receive quality services in the most integrated settings, engage in community life, and control personal resources; have opportunities to seek employment; and quality person-centered planning, services and supports are available for participants to live full lives in the community and have greater opportunities for self determination.

Growing demand for services - There is a shortage of services on Oahu for the target population of adults with disabilities. SECOH is only one of two service providers in East Honolulu, both working at capacity. However, there are some communities on Oahu where there are no choices or unacceptable choices for families. As a result, SECOH serves clients from Hawaii Kai to Kapolei, including Waimanalo, Kailua, and Kaneohe. They are willing to travel to the Diamond Head campus because of the quality of SECOH's programs. The current wait list for services is 29, most of them are young adults that recently aged out of the Hawaii public school system.

4. Describe the target population to be served; and

Current clients of SECOH - SECOH currently serves 173 adults with disabilities at 2 locations: Diamond Head and Kapolei. Our clients have physical and cognitive disabilities including Down's syndrome, Autistic Spectrum Disorders, Cerebral Palsy, developmental disabilities and other conditions that require specialized support.

We have two group programs at the Diamond Head Campus that serve clients with different needs: Adult Day Health (ADH) and Pathways ADH (Pathways).

ADH provides group activities for middle aged and senior adults with disabilities in need of intensive support for self-care, recreation, and community activities:

- Communication 37% are verbal, 22% are partially verbal, 35.6% are non-verbal and 5.5% use a communication device.
- Mobility -26.7% walk on their own, 50% are wheelchair bound, and 19.8% walk with assistance; 3.4% walk with crutches or a walker.
- Independence 7.8% require line of sight supervision, 9.5% require supervision for personal care, 22.4% require assistance with personal care, and 60.3% require assistance for everything.

PATHWAYS was developed in 2015 to meet the needs of young adults that are aging out of the Department of Education (DOE). This program quickly filled to capacity, and has 36 young adults currently on a wait list for services. Pathways clients are more capable ADH clients.

- Communication 39% are verbal, 40% are partially verbal, 17% are non-verbal and 5% use a communication device.
- Mobility 70% walk on their own, 20% are wheelchair bound, and 6% walk with assistance.
- Independence 48.3% require line of sight supervision, 23.3% require supervision for personal care, 12% require assistance with personal care, and 8.3% require assistance for everything.

Future clients of SECOH - There is a growing need to increase services to individuals with disabilities, as the number of young adults with special needs is outpacing the inventory of programs and slots currently available. To meet the growing demand for services, SECOH seeks to expand its capacity by increasing space for clients.

Families and community of the clients of SECOH - The services provided by SECOH not only improve the independence and quality of life of persons with disabilities, they also improve the quality of life of their family and friends and the community at large: assisting individuals with disabilities to lead more independent and fulfilled lives by reaching their greatest potential will reduce or prevent the need for more intensive levels of care, such as institutionalization. In addition, without the services of SECOH, families would be required to act as full time caregivers, and would be unable to retain gainful employment to support their household.

5. Describe the geographic coverage.

SECOH serves individuals with disabilities that reside on the island of Oahu.

III. Service Summary and Outcomes

Task 1: Renovate the administration building to create a new job and life skills center (\$253,790) – The CEO will oversee contractors to complete renovations to an administration

building so that it can be used for job and life skills training activities. Renovations to the interior will achieve these measurable outcomes:

- A conference room for meetings with clients, their families, and staff.
- The kitchen will be renovated and a small store, snack bar/café will be created for clients to learn and practice job and life skills. For example, clients will be able to practice making a shopping list and exchanging money, as well as staffing the store and snack bar/café. This will build upon the depth and diversity of job training, independence skill-building, life skills and educational activities.
- Three "great rooms" and ADA compliant bathrooms for ADH and Pathways group activities
 will be created, and enable SECOH to serve an additional 30 more adults with disabilities on
 the Diamond Head campus. This will address the dire need for more service slots on Oahu.
- New LED light fixtures, refrigerator, and energy efficient air conditioning units with filtration systems to 500 microns will be installed to reduce the cost of electricity and purify the air for occupants.

Task 2: Renovate Building D to increase capacity to serve more clients (\$119,962) - The CEO will oversee contractors to complete renovations to Building D, and this will increase the capacity of SECOH to serve 20 more individuals with disabilities:

- The building currently has 5,500 sq. ft. of interior space. The renovation will enclose exterior patios (without changing the building footprint) and increase the interior space to 6,300 sq. ft.
- Reconfigure the interior to create three bright, open activity rooms.
- ADA compliant bathrooms will be improved.
- A kitchen/dining room will be updated and improved.
- One comfort/quiet room will be created for clients that require privacy to change, rest, or take a break from group activities.

Task 3: Objective 3: Renovate the swimming pool house (\$162,179) – The CEO will oversee contractors to complete the following renovations to the pool house:

- The electrical system was built to applicable code at the time of construction, and will be brought up to current standards.
- A solar photovoltaic system will replace the electric heating and pump system.
- The lighting system is dated and will be improved with energy efficient fixtures.
- New toilets, showers and changing areas will be installed in compliance with ADA standards.
- Provide a projected annual timeline for accomplishing the results or outcomes of the service;

The CEO will be responsible for this project, including monitoring, evaluating, and reporting on project objectives. Quality assurance includes the following:

- Weekly status meetings between the CEO and the contractors to go over progress and address any unanticipated challenges in the renovation, and ensure that the renovation is proceeding as planned and in compliance with State of Hawaii and applicable code.
- Quarterly reports by the CEO to the Board of Directors.
- The CEO will work with the finance and accounting consultant on an ongoing basis to monitor the budget expenditures to ensure timely and appropriate distribution and reporting of funds.

- 4) **Expenditures:** The expenses are incurred on a timely basis, in the categories of costs as projected in the budget.

V. Experience and Capability

1. Necessary Skills and Experience

Experience providing services to individuals with disabilities - SECOH has over 53 years of experience serving individuals with disabilities in the State of Hawaii. It has secured multiple contracts to provide services from the DOH DDD and Honolulu County DTS, and a successful track record of meeting or exceeding contract objectives.

Today SECOH has 79 employees that serve over 170 clients out of two service locations: Diamond Head and Leeward. We currently have contracts with DOH DDD to provide ADH, PAB, CLS, respite, and employment training. The current Medicaid Waiver is valid through 2025, and SECOH is committed to continuing these services in the future.

SECOH has sufficient funds to cover project expenses in advance of reimbursements from the State of Hawaii for this project. Finance and accounting is managed by Custom Bookkeeping Solutions, a contractor with SECOH for the past four years. ProService Hawaii manages all payroll and human resource activities, and we work with a consultant grant writer to raise the funds necessary for renovations, program improvements, and other expenses not covered by DOH DDD and Honolulu County DTS contract reimbursements for services.

Experience completing capital improvements – In the past three years SECOH has completed several renovations at the Diamond Head campus. Each of these capital renovation projects were completed on time, and within budget.

SECOH has two service locations and an administrative office. All service locations are ADA compliant, and have sufficient parking for visitors and the SECOH vehicles.

The Diamond Head facility has four single level buildings and a pool for recreational activities. This site serves 98 individuals with disabilities through both ADH and Pathways programs.

The Sister Agnes' Leeward Center (SALC) is a single-story facility that was purchased and renovated in 2019. The ADH program at SALC currently serves 67 individuals with the most intensive needs.

The Kapolei Administrative Office houses all of SECOH's administrative staff.

VI. Personnel: Project Organization and Staffing

1. Proposed Staffing, Staff Qualifications, Supervision and Training

CEO experience and qualifications - President/CEO Bridget Panee will direct this project. She has been with SECOH for 26 years, starting as a Program Instructor. In 2010 she was appointed Vice President of Operations, and in 2015 she was appointed President/CEO. In 2017 Bridget was named a Weinberg Fellow by the Harry and Jeanette Weinberg Foundation.

At the time Bridget began working at SECOH, its sole program was to care for a population of individuals that required services due to the deinstitutionalization of Waimano Home. SECOH's ADH program continues to serve 80 of these persons with disabilities, all of them older adults.

In 2014 Bridget saw the growing need for services for young adults with disabilities aging out of the DOE, and created the ADH Pathways Program. To accommodate these new services, she planned and oversaw a \$125,000 renovation of 1,400 sq. ft. in three rooms on the Diamond Head

Campus. Pathways was opened in January 2015, and within a short period of time, was filled to capacity. Each week SECOH receives inquiries from parents looking for an ADH program for their young adult child. There is a clear need to expand the capacity of this program.

Responsibility for capital improvements - CEO Bridget Panee will be responsible for this project, and ensuring that the goals and objectives are met on a timely basis, and within budget. SECOH has a full-time accounting clerk, and contracts with Custom Bookkeeping to manage its finance and accounting. SECOH has worked with Custom Bookkeeping for five years.

Supervision of capital improvements – A contractor with experience in projects of similar size and scope will be retained. CEO Bridget Panee with work with the contractor, and meet weekly to ensure the renovations proceed on time, as planned and within budget.
