This grant will be used for a public purpose to provide comprehensive substance abuse treatment for 225 adults (18 or older) who do not have comprehensive health insurance.

#### II. Background and Summary

#### 1. A brief description of the applicant's background;

Hina Mauka established itself as The Alcoholic Rehabilitation Services of Hawaii Inc. in July 1977, and possesses over 50-years of experience serving the individuals, families, and communities of Hawaii. We are leaders in treating substance use disorders that also cooccur with other mental health and physical health problems. We employ 122 full-time and 13 part-time staff, and our healthcare professionals are fully credentialed, licensed, and certified to practice in the State of Hawaii. We operate a 64-bed residential facility in Kaneohe as well as separate outpatient facilities located in Kaneohe and Waipahu, and our programs and services are nationally accredited and state-licensed. Each year we serve approximately 2,000 people, with 89% of our service population considered as having low to moderate income and 76% reporting an annual income of less than \$19,000.

The vast majority of our clients have little or no health insurance at the time of admission to treatment services. We offer a full continuum of care that includes inpatient detox and

residential treatment as well as day treatment, intensive outpatient, and aftercare programs. We also offer an array of recovery support services that include psychiatry, nursing, case management, peer mentoring and family education. Our treatments follow evidence-based practice guidelines and includes both individual and group cognitive-behavioral therapy as well as addictions psychiatry and medication-assisted treatment. We also offer a full array of wrap-around recovery support services that include best practices in nursing, case management, peer mentoring, family education, vocational rehabilitation, and transitional housing. We specialize in providing integrated substance abuse treatment for people experiencing alcohol and drug addiction along with severe mental illness and chronic physical health conditions such as hypertension and diabetes. We also specialize in providing wrap-around recovery support for people who are homeless, jobless, and involved with the criminal justice system.

#### 2. The goals and objectives related to the request;

The goal of this grant-in-aid (GIA) request is to provide comprehensive substance abuse treatment for 225 adults (18 or older) who do not have comprehensive health insurance. This project will have several key objectives. One objective is to provide evidenced-based residential and outpatient services that include treatment for chronic substance abuse, co-occurring disorders as well as co-morbidity physical illness in one treatment episode. This includes having staff to address these multiple chronic conditions as well as having established networks to connect patients to appropriate care in the community. Our intention is to produce good outcomes while being cost-effective given the exorbitant costs for untreated chronic conditions. This involves helping clients recover from alcohol and drug addiction, while addressing other important issues they may have with co-occurring mental illness and physical health problems. Providing people with integrated healthcare improves outcomes by addressing complex mental and physical health issues that could trigger a relapse into alcohol and drug use. It is also cost-effective because our services help people to address all of their healthcare needs in an integrated care model, either in house or we help coordinate care with other medical providers while in treatment. Following treatment, patients are now connected with ongoing psychiatric or medical care to continue their recovery with several different providers.

A second objective is to provide best practices and promising practices in wrap-around recovery support. Helping uninsured people satisfy their basic social, financial, housing and employment needs is the best way to encourage treatment initiation and recovery maintenance. Wrap-around recovery support involves helping people obtain public health insurance as well as other social entitlements and assistance. It also includes helping people find stable housing and employment, as well as prosocial supports in the community. Providing people with linkages to community supports increases the likelihood that they will refrain from breaking the law and getting involved with the criminal justice system. It also increases the likelihood that they will develop productive relationships with people and make amends with family and community members that they may have alienated in the past.

#### 3. The public purpose and need to be served;

The purpose of this GIA request is to provide the public with access to integrated treatment substance abuse, mental and physical health free of charge. Poverty should not be a barrier to

good health and wellbeing. Likewise, having little or no health insurance should not prevent people from receiving access to comprehensive healthcare treatments and services. The Department of Health (DOH) Alcohol and Drug Abuse Division (ADAD) is the primary funder of substance abuse treatment for the uninsured and underinsured living in the State of Hawaii. Hina Mauka is one of few public-funded agencies that treat co-occurring substance use, mental health and physical health disorders in Hawaii. However, we will experience a \$3,110,000 reduction in ADAD funds for the 2022-2023 cycle. This means that we will only be able to serve roughly 75 uninsured clients this year, which is well short of the over 500 uninsured clients that we served last year. With the COVID-19 pandemic still hurting so many individuals and families, there are more underserved people in our communities than ever before. This GIA funding request will go a long way to helping Hina Mauka continue helping the uninsured and underinsured people of Hawaii while waiting for ADAD to restore its funding.

The need for this GIA request is great. Uninsured or underinsured people represent the most vulnerable members of our community. Typically, those with little or no health insurance are impoverished, unemployed, homeless, and not enrolled in the state's Medicaid program. Often times they suffer from severe physical and mental health conditions that have gotten worse overtime due to going untreated. Moreover, many self-medicate their mental and health problems through the abuse of alcohol and drugs, which not only exacerbates existing health problems, it also can cause new ones. Failing to treat chronic health conditions eventually results in irreparable tissue or organ damage, emergency hospitalization, or even premature death. Additionally, uninsured or underinsured people have difficulty finding a primary care provider because Medicaid reimbursement rates are far lower than private health insurance rates. As a result, many go to the emergency room for treatment, which is costly to the public and insufficient to address most chronic health conditions. This GIA request will allow Hina Mauka to help people stabilize their chronic health conditions and gain access to primary care providers capable of prescribing more long-term treatments and services.

#### 4. Describe the target population to be served; and

This GIA request targets 225 adults (18 or older) who are experiencing complex substance use disorders and either do not have health insurance (uninsured) or have coverage that does not pay for important wrap-around recovery support services (underinsured). The uninsured and underinsured people of our community can include those who are recently homeless, jobless or exiting jail or prison. Although the state's Medicaid program covers the healthcare costs for the uninsured or underinsured, many people still fall through the cracks. For example, homeless people typically do not have a mailing address to receive importance notices and forms that require a timely response to avoid loss of benefits. In addition, people who lost their job also lose their employee health insurance and may be unable to afford the cost of health insurance and are unfamiliar with or unwilling to apply for Medicaid. Likewise, those existing jail and prison are unable to apply for Medicaid until after their release and may have difficulties accessing information and assistance with the application process. This GIA request will ensure that uninsured and underinsured people will receive the treatment and services they need to overcome their health problems and live a productive life.

#### 5. Describe the geographic coverage.

With separate windward and leeward locations on Oahu, Hina Mauka serves the entire State of Hawaii with 10% to 15% of our annual census being clients who are residents of Kauai, Maui and Hawaii Island. Therefore, the services funded by this grant-in-aid request will benefit anyone living in Hawaii, even though treatment will occur on Oahu.

#### **III.** Service Summary and Outcomes

#### 1. Describe the scope of work, tasks and responsibilities;

The scope of work covered by this GIA request will reflect our entire care continuum and services array. For our residential program, this includes intake processing, assessment and evaluation, as well as logging, room and board, along with 24/7 access to psychiatric, nursing, and counseling services. For our outpatient program, this also includes intake processing, assessment and evaluation, as well as daily access to psychiatric, nursing, counseling, peer support and case management services. The tasks of delivering the proposed scope of work is the responsibility of the clinical team, which is multi-disciplinary and includes psychiatrists, nurses, counselors, case managers, peer specialists and treatment associates.

# 2. Provide a projected annual timeline for accomplishing the results or outcomes of the service;

Hina Mauka proposes a one-year timeline for this GIA request. Between the award and release of funding, we will work with our community partners to streamline client referral processes, service delivery practices, and outcome data-collection protocols. Upon release of funds, we will begin receiving referrals from hospitals, urgent care and homeless providers, while ensuring patients receive treatments tailored to their service needs through data-driven assessment and evaluation processes. Altogether, these activities will position our services in places where uninsured and underinsured people are most prevalent. It also will make sure that uninsured and underinsured people have timely, appropriate, and continuous access to the most effective treatments without any gaps or disruption in services.

Key outcomes of interest include increased enrollments in Medicaid and public entitlement and assistance programs, as well as reduced problems with substance abuse, mental illness, physical ailments. Additional outcomes include lower rates of emergency hospitalization and criminal arrests, as well as improved individual well-being and social functioning. By achieving these outcomes, we will accomplish the goals of this GIA request and fulfill our mission to improve the quality of life among the most vulnerable uninsured or underinsured people living in our community. We expect that this project will result in a significant number of people breaking the cycle of addiction, mental illness, physical ailment, hospitalization, incarceration, joblessness and homelessness.

# 3. Describe its quality assurance and evaluation plans for the request. Specify how the applicant plans to monitor, evaluate, and improve their results; and

Hina Mauka will utilize robust continuous quality improvement (CQI) methodologies to evaluate program performance and ensure the quality of services and outcomes associated with this GIA request. This includes collecting program-level data on the number of clients admitted to and discharged from services, financial data on program income and expenditures, as well as staff satisfaction and supervision surveys. It also includes collecting client-level data on services received, treatment plans, program satisfaction, as well as psychosocial functioning and clinical symptom variations from intake, follow-up, and discharge. We compile these CQI into summary reports and disseminate this information to funding agency sponsors regularly.

Hina Mauka will monitor and improve the efficacy and effectiveness of services and outcomes through internal CQI planning and review processes. This includes monthly reporting and oversight from our Board of Directors, as well as annual reviews of agency policies, procedures, financial controls and service delivery protocols. It also includes weekly meetings between our Chief Executive Officer and program directors overseeing human resources, administrative management, clinical programs, information technology, and program development departments. Our Board of Directors include experts and community leaders in the areas banking, real estate, medical services, fund raising, and governmental operations. Our Medical Director oversees all psychiatric and nursing services in consultation with the Chief Executive Officer and clinical program director. Our Chief Financial Officer oversees accounting and independent auditing results and provides these results to the Board of Directors and Chief Executive Officer quarterly or as needed. Altogether, these leadership activities translate into service and outcome improvements through adjustments in policies, procedures, and protocols that program directors implement and manage in collaboration with each department's management and line staff.

Hina Mauka will utilize its existing CQI methods to measure performance and collect outcome data. This includes tracking the number of uninsured and underinsured clients served, as well as determining how well they responded to treatment. Key measures of success include treatment completion rates and Medicaid enrollments. The target population needs this project to establish benchmarks from which to improve outcomes. A significant measure of outcome is to develop effectively working relationships for integrated practices with primary care providers, hospitals and emergency rooms.

#### V. Experience and Capability

#### 1. Necessary Skills and Experience

Hina Mauka employs a team approach that is motivational, and client centered in all of its services. The medical team comprises of Psychiatrists, who specialize in addiction medicine, medication assisted treatment (MAT) and psychiatry; Registered Nurses (RN) and Advance Practice Registered Nurse (APRN) and Medical Assistant who have at least 3-years of experience working with complex patients.

The clinical team consist of License Certified Social Workers (LCSW) License Mental Health Counselors (LMHC) and Certified Substance Abuse Counselors (CSAC), with the minimum requirement of a Bachelor's degree in social work or behavioral science. Intake staff also holds a CSAC or an advance degree in behavioral sciences that reinforce their competency to meet the work requirements. Intake staff are also skilled in interviewing techniques (attending, paraphrasing, reflecting, etc.) designed to quickly establish rapport or an alliance, gather assessment data and formulate summaries for treating staff to use as part of the treatment regimen. Treatment Associates (TA) provide behavioral observation and monitoring during structured and non-structured programming hours (24/7) alongside the medical assistant. They report their observations to the clinical team daily. Treatment Associate receive training annually on Crisis Prevention Intervention (CPI), CPR and First Aid and behavioral health management.

The Case Management team also employs staff with Master's degrees and documented experience working with the complex patients. On the average, the entire service team has worked with the substance abuse, mental health, homeless, legally encumbered and the complex patients for at least 5-years or longer.

Service staff are well versed in clinical theory and able to deliver a variety of service activities at all levels of care. Clinical staff is skilled in facilitating individual counseling sessions, crisis intervention, educational, skill building, process groups, gender and illness specific groups and offender groups that require time spent on actual practice or role-playing. Clinical staff receive assignment to each modality with consideration to individual skill set, abilities, and experience.

Clinical staff receives ongoing trainings such as the use of motivational interviewing techniques, cognitive behavioral interventions and client-related approaches, Confidentiality, Ethics, HIPAA Privacy Rule, Client's Rights and Infection Prevention and Cultural Competency. Clinical staff also attend internal and external trainings related to their profession, including Integrated Treatment for Persons with Dual Diagnosis; Treatment as an Alternative to Incarceration for Offenders with Mental Health and Substance Abuse Disorders; Denial and Resistance in Chemical Dependency and Cognitive Behavior Intervention for Substance Abuse. Staff also attend regular training offered by the DOH and ADAD.

Hina Mauka has an extensive history working with various government and community-based and recovery-oriented providers. Our current contract with the DOH and ADAD, which includes a continuum of care that consist of Pre-Treatment and Pre-Recovery Support Services, Treatment Services and Recovery Support Services. Historically, Hina Mauka has provided services under this contract for the last 20 years.

Hina Mauka also has a current contract with Adult Client Services Branch (ACSB) providing similar services as described above for those under probation supervision. Hina Mauka staff work closely with the contract manager and probation officers by sharing client clinical information to help offenders access needed services. Hina Mauka's working relationship with ACSB extends over the last 15 years or more. As a result of this productive working relationship, Hina Mauka was awarded and currently manages a reentry grant from the Substance Abuse Mental Health Administration (SAMHSA) Honolulu County Offender Reentry Program (HCORP 2) that funds care coordination (case management) and housing assistance for probationers reentering the community from incarceration.

Hina Mauka also has a current contract with the DOH's Adult Mental health Division (AMHD) providing a continuum of care that involves a comprehensive approach for the Severely Mentally Ill (SMI) consumer, which includes residential and day treatment services. Hina Mauka also contracts with AMHD to provide an essential range of intensive community-based case management and rehabilitative services for those consumers with high utilization of services (high utilizers) and homeless individuals. Case managers provide intensive and highly integrated services to those who are experiencing recurring crises, frequently hospitalization or incarceration, and require a higher level of service coordination to become or remain stable in their community-housing placement.

Hina Mauka provides programs and services for over 2,000 adults and per year. Adult programs are at multiple outpatient sites in Waipahu, WCCC and Kaneohe. A recently successful capital campaign helped us to increase our residential beds from 48 to 64 to accommodate a growing statewide waitlist. Our patients have come to us with increasingly complex issues. Hina Mauka now serves people with co-morbidity issues including mild to moderate physical medical conditions and moderate to severe mental health issues.

#### 2. Facilities

#### Kaneohe: 45-845 Po'okela Street, Kaneohe, Hawaii 96744

Hina Mauka's Kaneohe facility has the ability to provide residential services to 64 clients at any given time. This residential facility has adequate space for several outpatient groups and houses our administrative staff, kitchen, dining room, laundry room, and individual counseling rooms. The residential clients reside upstairs, which is accessible by stairs and elevator. On the ground floor there are 5-large, enclosed group rooms including an expansive dining room that also serves for client groups, recovery meetings and staff trainings. There also are 9-individual enclosed counseling rooms, a Treatment Associates' office that is open 24 hours a day, a physician's office, a nursing office, a physical examination room, a large, enclosed chart/documentation room, and a large enclosed clinical administrative office. Double closed doors provide privacy and separate the clinic area from the large open lobby where our

receptionist and intake specialist's welcome guests, our patients, families and those seeking program services.

#### Waipahu: 94-830 Hikimoe Street, Waipahu, Hawaii 96797

The Waipahu adult office is located on the ground floor of a leased building. It has a separate outside entry for the adult program and the offices and group room are restricted from the rest of the building. It provides space for a warm and welcoming reception area, (2) intake and admission, (5) counseling, UA collection and testing office and (2) group rooms and a kitchen break room. The facility has ample parking for staff and consumers with 24/7 video surveillance. This office is ADA compliant, wheelchair accessible and has handicap ramps. This location is next to a bus transit center.

#### VI. Personnel: Project Organization and Staffing

#### 1. Proposed Staffing, Staff Qualifications, Supervision and Training

This GIA request will cover staffing costs for the following personnel:

Medical Director/psychiatrists are licensed, experienced in this population, working at Hina Mauka in part time positions and have prior experience in hospital psychiatric departments, Hawaii State Hospital, Tripler and private practice. Dr. Shibata, Dr. Rudlowski and Dr. Yamamoto. This grant would expand their role. Policies and procedures are developed with supervision practices in place to manage medical teams. Training is ongoing and scheduled per year, often involving some traveling, or working with UH Medical School. These doctors have addiction credentials as well. Uncompensated costs include uninsured and underinsured.

APRN: Hina Mauka has had an APRN from time to time though has difficulty affording this position. In this grant, the APRN would help considerably to manage medical procedures and provide after hour consultations to help reduce the more expensive doctor time. The APRN would report the Medical Director.

RNs 24/7. Hina Mauka has part time RN, but this position is currently uncompensated. Procedures, training, and supervision are in place. Hina Mauka would recruit several more nurses, part time and full time to cover services 24/7, especially onsite during day hours. Some of the coverage would be by telephone consultation after hours.

Medical Assistants: Hina Mauka intends to greatly expand this role, recruiting staff who have completed course work in this area. This would be new hires. Hina Mauka would develop P&Ps, and training for these positions.

Management: Our Clinical Director and Manager of Adult Programs would provide management, ensure integration and address personnel issues.

License/Certified Staff: The clinical team comprise of License Certified Social Workers (LCSW) License Mental Health Counselors (LMHC) and Certified Substance Abuse Counselors (CSAC), with the minimum requirement of a Bachelor's degree in social work or behavioral science. Intake staff also holds a CSAC or an advance degree in behavioral sciences that reinforce their competency to meet the work requirements. Treatment Associates (TA): provide behavioral observation and monitoring during structured and non-structured programming hours (24/7) alongside the medical assistant.
