Intended Purpose: Pursuant to section 706-603, HRS, moneys in the DNA registry special fund shall be used for DNA collection, DNA testing, and related costs of recording, preserving, and disseminating DNA information pursuant to chapter 844D, HRS.

Source of Revenues: Pursuant to section 706-603, HRS, every defendant convicted of a felony offense shall be ordered to pay a monetary assessment of \$500 or the actual cost of the DNA analysis, whichever is less. The court may reduce the monetary assessment if the court finds, based on evidence presented by the defendant and not rebutted by the State, that the defendant is not and will not be able to pay the full monetary assessment.

Current Program Activities/Allowable Expenses: Activities and expenses related to DNA collection, DNA testing, and recording, preserving, and disseminating DNA information pursuant to chapter 844D, HRS.

Variances: Revenue variation due to fees collected. Expenditure variation due to payroll previously charged to fund and number of DNA kits purchased.
