A BILL FOR AN ACT

RELATING TO THE WORKERS' COMPENSATION LAW.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 386, Hawaii Revised Statutes, is
2 amended by amending the title of part V, subpart C, to read as
3 follows:

4 "C. PUBLIC BOARD MEMBERS, RESERVE POLICE OFFICERS, POLICE
5 CHAPLAINS, VOLUNTEER FIREFIGHTERS, VOLUNTEER BOATING ENFORCEMENT
6 OFFICERS, ~~AND~~ VOLUNTEER CONSERVATION AND RESOURCES ENFORCEMENT
7 OFFICERS, AND RESERVE PUBLIC SAFETY LAW ENFORCEMENT OFFICERS"

8 SECTION 2. Section 386-181, Hawaii Revised Statutes, is
9 amended to read as follows:

10 "**§386-181 Generally.** (a) As used in this section:

11 "Police chaplain" means a member of an authorized
12 chaplaincy program of a county police department who performs
13 services in a voluntary and unpaid capacity under the authorized
14 direction of an officer of the department.

15 "Public board" means a governmental body, regardless of its
16 designation, duly created under authority vested by law for the
17 purposes of performing quasi-judicial, administrative, or
18 advisory functions.



1 "Reserve police officer" means a member of an authorized
2 reserve force of a county police department who performs
3 services in a voluntary and unpaid capacity under the authorized
4 direction of an officer of the department.

5 "Reserve public safety law enforcement officer" means a
6 member of the authorized volunteer law enforcement force of the
7 department of public safety who performs services in a voluntary
8 and unpaid capacity under the authorized direction of an officer
9 of the department of public safety.

10 "Sheriffs' chaplain" means a member of an authorized
11 chaplaincy program of the department of public safety who
12 performs functions similar to a police chaplain in a voluntary
13 and unpaid capacity for the sheriff division.

14 "Volunteer boating enforcement officer" means a member of
15 the authorized volunteer enforcement force of the harbors
16 division, department of transportation, who performs services in
17 a voluntary and unpaid capacity under the authorized direction
18 of an officer of the department.

19 "Volunteer conservation and resources enforcement officer"
20 means a member of the authorized volunteer enforcement force of
21 the division of conservation and resources enforcement,



1 department of land and natural resources, who performs services
2 in a voluntary and unpaid capacity under the authorized
3 direction of an officer of the department.

4 "Volunteer firefighter" means a person who performs
5 services for a county fire department in a voluntary and unpaid
6 capacity under the authorized direction of an officer of the
7 department.

8 (b) If a member of a public board, a reserve police
9 officer, a police chaplain, a reserve public safety law
10 enforcement officer, sheriffs' chaplain, a volunteer
11 firefighter, a volunteer boating enforcement officer, or a
12 volunteer conservation and resources enforcement officer is
13 injured while performing services for the board, county police
14 department, county fire department, department of public safety,
15 harbors division of the department of transportation, or
16 division of conservation and resources enforcement of the
17 department of land and natural resources, under the conditions
18 specified in section 386-3, the person or the person's
19 dependents shall be entitled to all compensation in the manner
20 provided by this chapter and, for the purposes of this chapter,



1 the person shall, in every case, be deemed to have earned wages
2 for the services.

3 (c) In computing the average weekly wages of an injured
4 public board member, reserve police officer, police chaplain,
5 reserve public safety law enforcement officer, sheriffs'
6 chaplain, volunteer firefighter, volunteer boating enforcement
7 officer, or volunteer conservation and resources enforcement
8 officer:

- 9 (1) The person's income from self-employment shall be
10 considered wages;
- 11 (2) The person shall, in no event, be considered to have
12 earned less than the minimum hourly wage prescribed in
13 chapter 387;
- 14 (3) Wages of other employees in comparable employment
15 shall not be considered; and
- 16 (4) All provisions of section 386-51 not inconsistent with
17 this section shall apply; provided that section
18 386-51(5) shall not apply."

19 SECTION 3. Statutory material to be repealed is bracketed
20 and stricken. New statutory material is underscored.

21 SECTION 4. This Act shall take effect upon its approval.
